
## NOTES TO THE ACCOUNTS

2. The rent was for Sundays of the last three months of the year as other activities were cancelled due to Covid-19.


## TRUSTEES REPORT

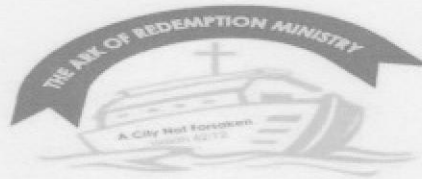


## NOTES TO THE ACCOUNTS


1. Income represent contributions by members even though there was no meeting from the 22<sup>nd</sup> of March 2020 due to Covid-19.

3. The amount was used to provide help and assistance to a few members affected by the sudden loss of income due to the lock down.
