Summary of the main achievements of the charity during the year

We continued our support of 13 vulnerable or orphaned children to return to school and to continue their education – this comes in the form of school fees and requirements, including a daily hot lunch at school. We also were able to raise money to send care parcels to families in need during the continuing restrictions in 2021. Many families live hand to mouth so being unable to work created widespread famine. We sent care parcels consisting of food and soap to over 60 families.
