This year saw the beginning of one of the biggest pandemics we have witnessed in living memory, non-essential retail units, religious organisations and businesses were closed nationally. The City Retreat Leicester was forced to close for long periods of time during the year, however we managed to refocus our efforts to provide for an increasingly difficult situation faced by huge numbers of the community throughout Leicester city and Leicestershire at large.

For 6 months from March to September we planned food distribution across the city to the neediest, we received donations from all sections of the community, and worked extensively with The Red Cross to keep distributions running via our network in the city and reached out to over one thousand of homes.

Meanwhile the centre remained closed throughout and the costs had to be met, staff had to be laid off and the struggle of the day-to-day pressure running a city centre community provision continued.

The centre became a store for food, clothing and household essentials during this period and door to door support continued with a team of volunteers.

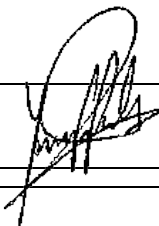
