| <p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p> | <p>Para 1.20</p> | <p>Through regular surveys & monitoring of the grey seals we can clearly identify individuals.</p> <p>We have achieved this by recording all seal sighting and registering each individual seal, giving it a name and number.</p> <p>In doing this we have added vast data not only to our own database, but to that of Cornwall Seal Group Research Trust, with whom we share our data.</p> <p>They previously only held a small number of recorded seals within the South Devon area, but with almost daily surveys, from both land and sea we have significantly increased this data.</p> <p>This in turn gives us an insight into the distances seals can travel enabling us to learn more about these globally rare species.</p> <p>As a result of this we can talk with clarity about easily recognised returning seals, giving them a voice.</p> <p>We are learning more about the behaviours of these creatures. In turn this gives us a different angle to other conservation groups when talking about the seals.</p> <p>Knowing even a small timeline on a seal creates part of a life story which gives the public an understanding they wouldn't otherwise have.</p> <p>This makes them more inclined to get involved with the project and volunteer with us, from sending in seal sighting photos or volunteering to help survey or manage data, taking leaflets and putting up signage.</p> |

| <p>Achievements against objectives set</p> | <p>Para 1.41</p> | <p>We have access to a Survey boat which has enabled us to cover over 40kms of the South Devon coastline. This has increased our surveying areas and therefore increased our knowledge of seals. We have also been able to monitor other wildlife and reported incidents against other marine mammals.</p> |
| <p>Performance of fundraising activities against objectives set</p> | <p>Para 1.41</p> | <p>Through a £5,000 donation to the project, we were able to consider running a survey boat. This has proved vital for monitoring seals, especially if entangled or under disturbance. We have not only been able to monitor wildlife but record human disturbance issues regarding jet skis in restricted areas.</p> <p>Other talks have raised funds, but as a new project we were just making inroads to future events when Covid 19 began. Many of these talks and assemblies were delayed but we took part in numerous on line webinars.</p> <p>The few talks we had done gave us a wider social media and local presence and as a result we raised funds through selling merchandise both purchased and donated, and funds were also raised over the Christmas period with online adoptions of seals.</p> |
