To raise awareness through education & information to protect these both endangered Grey seals and uncommon Common seals whilst recording each sighting adding their seal life stories.

Through our ongoing surveying around the South Devon coastline we are building up an ever increasing picture of these amazing creatures. We know many of these seals well and over period of years can identify them through their individual fur patterns, by their behaviour and routines.

Our knowledge of these seals has proved invaluable for concerns from locals, and visitors to harbour authorities and marinas. We can easily put minds at rest about concerns, often merely sleeping or resting seals in highly visible locations.

## Achievements

Once again we've had a busy year. The weather conditions stopped many surveys from taking place, either because of the rain, or wind. Sunny days and high seas don't make boat surveys with cameras easy. However we still achieved many surveys, recording seals we know well along with some new faces both young and older!

Our highlight of this year has to be being asked to take part in BBC's Countryfile. We, as both as The Seal Project, and as BDMLR (British Divers Marine Life Rescue) Marine Mammal Medics, were all on an episode entitled 'Brixham'. We were so proud of this! Between our Trustees and our volunteers we represented 3 Charities we volunteer for on one episode of this well known TV programme, alongside other locally represented groups.



Once again we've been busy with talks and presentations. Our biggest event being the Devon County Show. Its a 3 day event, which always brings us great contacts and this year we proudly unveiled our new logo created by a student from Stover School. Where better to unveil our winning entry!

Our consistent surveys, talks, visibility and knowledge are proving our reputation and we are proud of this.



Throughout 2022-23 we have taken part in almost 200 seal surveys, responded to 53 calls from members of the public, attended 22 BDMLR Marine Mammal Medic call outs, and attended 76 meetings and represented ourselves at 43 events, with the amazing support of 15 volunteers, including DofE Students. We have been so well supported by so many.

## Financial Review

The Coop Local Community fund again supported us for a second year, and we incredibly appreciate this. Its fantastic to know we have such community support.

We were also fortunate enough to be granted funding by Dartmouth Town Council to enable us to monitor the Dartmouth/ South Hams/ River Dart locations with more ease.

We had a number of items purchased in this financial year. A Gazebo which has proved its worth. We've attended a number of weather affected events but our sturdy purchase has been rock solid and given we had this printed black to help our seal skeletons stand out against the background, we had to ensure they were safe inside the gazebo no matter what the conditions were, and they are!

Surveying on the sea means lots of salt water spray. This is a massive nightmare for our camera equipment, and without this kit we cannot record all we do. so keeping the camera equipment safe is key. We waited for Ocean Covers to be able to fit us in at a great price for a bespoke canopy t our survey boat, to which they kindly sponsored us too, and designed this perfectly for protection with maximum visibility panels, to ensure monitoring was never compromised. This has proved invaluable. We can now survey out of the wind, protected from the sea and sun, spray, rain, wind and heat - and our camera equipment remains clean, cool and dry.

Our logo needed refreshing, so with the help of the pupils at Stover School we launched a logo competition. The perfect place to launch the winner of this competition this was at the Devon County Show 2023. This required new leaflets, signage and clothing, which was very successfully received, and we are very pleased with our bright new look.

This did all come at once, but we have worked hard to sell our merchandise, raise donations and most of all, raise awareness. We will keep doing all we do to ensure the seals are safe and to ensure this remains so. Our aim is always to ensure we protect the seals, which we do well, and we are always grateful that we are respected and appreciated amongst our community.
