Food Kits

Food Kits are distributed to the deprived and underprivileged, elderly, widows, poorly and the needy.

These Food Kit provisions are enough for a family of up to five to live on for five/six weeks.

As well as Food Kits, some token cash amount may also be given so that other items of need which are not included in our Food Kits can be purchased.
