INDEPENDENT EXAMINATION

The accounts for the year have been submitted and examined by the independent company Luke Silver Accountancy & Taxation Services. Since an audit is not required, they have examined the accounts in accordance with the Charities (Accounts and Reports) Regulations 1995 (Statutory Instruments No. 2724) and the Accounting by Charities Statement of Recommended Practice (SORP). The accounts have been examined in line with section 145 of the Charities Act 2011, following the procedures laid down in the General Directions given by the Charity Commission under section 145(5)(b) of the 2011 Act.

A copy of the Independent Examiners' Report is attached and dated 26th February 2025.

TRUSTEES

During 2024 there has been one change to the Board of Trustees as follows:

- Alina Keziah Graham was appointed to the Board of Trustees on 4th August 2024.

The accounts have been submitted to the Trustees for approval. They were accepted and approved by the Board of Trustees.

There had been no serious incidents that were required to be brought to the Charities Commission's attention.

CHARITY COMMISSION ANNUAL REPORT

The Charity Commission Annual Report for Renew Church has been submitted online once again this year.

ACCOUNTS

2024 has seen another positive year with regards to the activities and services that we provide and has been another year of progress in maintaining our facilities through the completion of maintenance and building improvements. We are the official Foodbank for the Uttoxeter area and our food bank commitments have continued in this period as did our attempts to support those continuing to struggle within our community spiritually, emotionally and physically.

- **Income**

Overall, the total incoming resource in the period was £224,045.00 which has decreased from 2023; however, this is mainly due to the Church being left an incredibly generous legacy donation in September 2023. Due to this donation, and the money we still have in our Kingdom Bank Savings Account, the trustees decided to open a second Higher Rate Savings account through Cambridge and Counties Bank until the Church requires the funds for any future projects or local Church plants.

The charity continues to remain actively in control of its financial situation. Our policy is to hold our RESERVES in the Higher Rate Savings Account.

- **Expenditure**

Overall, the expenditure in the period was £204,904.00; which is a decrease of our expenditure amount in 2023. As mentioned above the Church has a savings account with Kingdom Bank and opened a new one with Cambridge and Counties and moved a large amount into these accounts. We have continued with our charitable giving allowing us to be able to support and give to campaigns and organisations when needed as well as providing outreach activities in our local community.

- **Balance Sheet**

The value of fixed assets remains positive and funds are continuing to be held in savings accounts as a contingency.

THE ADVANCEMENT OF RELIGION FOR PUBLIC BENEFIT

AIMS

We aim to spread the Gospel of Jesus Christ in word and deed. We believe that a personal belief in God should be exemplified, globally and locally, by Christians putting God's love into practice with worthy actions and honourable deeds that benefit the community at large. Consequently, we aim to have a positive effect on our community in Uttoxeter and the surrounding villages. We aim to support the local schools, supplement the education of children by offering a moral and ethical framework through the teaching of Christian principles. We aim to assist the spiritual wellbeing of people of all ages in our community. We provide regular wellbeing support through our Warm Welcome Cafe as part of our Uttoxeter Foodbank. The elderly also have access to the church for warm meals that are provided each week.

IDENTIFIABLE BENEFITS FOR THE PUBLIC

Renew Church offers a venue for the public with positive activities for people of all ages. In line with increasing internet use, Renew maintains a website, www.renewchurch.co.uk, for access to further information about the Church by the general public. The Church continued to live stream services online via YouTube and Facebook. The Church endeavours to provide all our activities and groups free of charge so they are accessible to people from every social walk of life.

Our toddler group, Roar, ran sessions on a Wednesday morning and afternoon and is an asset to those in our local community providing a safe place for parents/carers and their children to come and chat, play and engage in a variety of other activities. We also continued our group for new parents with pre-walking children called Little Pups which gives a great opportunity for people to come and relax, chat and have a drink with new parents/carers who may not feel comfortable in a larger setting with older children running around.

Renew Church continued with our Friday lunch club for the over 60s in our community. They are welcomed into the building for a warm meal, fun games and the ability to sit and talk with those their age in a caring environment. This is a group we are especially passionate about as for several of the elderly in our community this is the only time in the week that they can participate in something like this.

We have a dedicated room for the children and young people that is used on a Sunday morning for Sunday School and Friday evenings for a time when the youth can meet weekly for a fun evening of music, discussions, prayer and faith-based talks. Our young people are also taken annually to a Christian summer youth festival where they can meet and socialise with like-minded peers as well as take part in the activities, services and seminars provided.

Our Warm Welcome Café as part of our food bank on a Monday morning continues to be a huge success. This is a place where local families who are suffering from ill health and associated with poverty are

temporarily assisted with food parcels and/or can sit and have a warm drink and slice of cake and talk with one of our volunteers. Referrals to other service providers are made when necessary to ensure that they are getting the all-round support that they need.

Renew Church holds regular Men's and Women's events throughout the year for members of the Church which also provide great opportunities to bring non-Church friends and family members to smaller gatherings and hear Biblical encouragement or stories from Church members. These range from breakfast's, afternoon sweet treats to games nights and meals at local restaurants. We aim to make most of these events and activities are free of charge if they happen in the Church building.

Renew Church has added to its number of very talented musicians. The group play various instruments and sing together providing the music during our services every Sunday throughout the year. They have regular practices together and are developing their talents and skills on an ongoing basis.

On Sunday's Christian religious services are held at Renew Church. These are open to all people of different ethnic backgrounds and all age groups. The services are generally times of joyful and exuberant praise and worship to God, but time is also allowed for reflection and prayer.

There is always a friendly welcome for people attending Sunday services. We have two sessions for our youngest members with 'Roar Sunday' group for ages 2-4 years as well as our Sunday School 'Tribe' for those ages 4-11 years old; in these sessions the children can play games, hear Bible based stories and do craft activities. The coffee-bar is open after the services where tea and coffee is provided and served free of charge.

Renew Church is also a base from which other activities take place to benefit the general public:

- Donations have been made to various charities throughout the year to support people in their times of need.
- We linked up with Places of Welcome and opened an evening Craft Group for the community which was very well attended.
- Local families who are having difficulties financially can come at various times within the year for our School Uniform Mornings where they can have a look through, and select free of charge, items of good quality, used uniform that have been donated to the Church for their children.
- The Church also held several free events including a Nativity performance in December as part of our Christmas Carol Service, a Light Party in October, a Lunch with Santa event on Christmas Eve and an Easter meal and hunt. All the events were well attended and great opportunities for members of the Church and local community to come engage with.
- A small group of people also attended Big Church Festival during the May bank holiday weekend, joining with thousands of other Christians and providing another opportunity to build community.

- Members of the Church went on two mission trips to Romania to volunteer with an organisation there working with local children, vulnerable women in the community and to help with some practical needs, for example gardening and house maintenance.

Renew Church is working with the local agencies on an ongoing basis to identify the local needs where we can provide support and have a positive impact for the good of the local community.

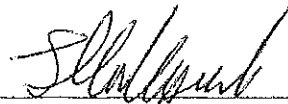

The Church continued to live stream services online via YouTube and Facebook. The Church endeavours to provide all of our activities and groups free of charge so they are accessible to people from every social walk of life.

Our toddler group, Roar, returned with sessions on a Wednesday morning and added an afternoon sessions and is an asset to those in our local community providing a safe place for parents/carers and their children to come and chat, play and engage in a variety of other activities. We also continued our group for new parents with pre-walking children called Little Pups which gives a great opportunity for people to come and relax, chat and have a drink with new parents/carers who may not feel comfortable in a larger setting with older children running around.

Renew Church continued with our Friday lunch club for the over 60s in our community. They are welcomed into the building for a warm meal, fun games and the ability to sit and talk with those their age in a caring environment. This is a group we are especially passionate about as for a number of the elderly in our community this is the only time in the week that they can participate in something like this.

We also have various children's groups and youth activities throughout the week. We also have a dedicated room for the children and young people that is used on a Sunday morning for Sunday School and Friday evenings for a time when the youth can meet weekly for a fun evening of music, discussions, prayer and faith-based talks. We also have a very active children's club that runs termly on Friday's with games, songs and a biblically based moral story. Our young people are also taken annually to a Christian summer youth festival where they can meet and socialise with like-minded peers as well as take part in the activities, services and seminars provided.

Our Warm Welcome Café as part of our food bank on a Monday morning has been a huge success. This is a place where local families who are suffering from ill health and associated with poverty are temporarily assisted with food parcels and/or can sit and have a warm drink and slice of cake and talk with one of our volunteers. Referrals to other service providers are made when necessary to ensure that they are getting the all-round support that they need.

Renew Church has its own very talented music group. The group play various instruments and sing together. They provide the music during our services every Sunday throughout the year. They have regular practices together and are developing their talents and skills on an ongoing basis.

On Sunday's Christian religious services are held at Renew Church. These are open to all people of different ethnic backgrounds and all age groups. The services are generally times of joyful and exuberant praise and worship to God, but time is also allowed for reflection and prayer.

Like most organisations and establishments, the Covid-19 pandemic meant that in 2021 our financial activities looked very different to in previous years as almost all of our services and activities ceased. That being said our food bank commitments increased substantially in this period as did our attempts to support those struggling with the realities of the pandemic spiritually, emotionally and physically.

- **Income**

Overall, the total incoming resource in the period was £166,787.00 which has decreased by £107,384.00 from the sum of £274,171 in 2020. We continued to take part in the Government's Furlough Scheme to help keep two members of staff in employment until our normal activities returned.

In addition to this, in late April 2020 a single-mother in our congregation passed away from Covid-19 and the Church collected donations to place in a fund for her daughter. This money was held in a separate Church account but is reflected in our overall income amount. Once the child was placed with a family in 2021 the money was moved into a legal Trust from our account in June 2021 and we no longer have any responsibility for this money.

- **Expenditure**

Overall, the expenditure in the period was £182,837.00; which is an increase of our expenditure amount last year. As mentioned we continued to take advantage of the furlough scheme for part of the year towards our staffing costs. Our charitable giving was limited considerably due to the Covid-19 pandemic and the fact that most activates weren't able to take place.

- **Balance Sheet**

The value of fixed assets remains positive and mortgage obligations have reduced in line with current forecasts and the intentions of the Trustees. Limited funds are continuing to be held in a savings account as a contingency.

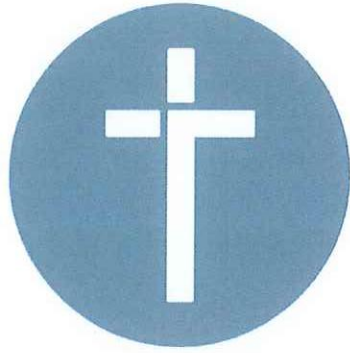
