**2024-2025 Annual meeting of Trustees Report**



## Overview

This is our Fourth Annual Trustees report since our charitable foundation in January 2020.

All trustees agree that this last financial year continued to bring some of the biggest challenges yet to our charity in a climate of austerity and a need to bring Pride 2024 (Our 20 th Birthday) in on budget.

In our report we discuss in chronological order what we have achieved in the last financial year and what we seek to achieve over the next year as a charity.

As such this report reflects what we have discussed and achieved in the 2024–25 financial year. All present agree that this is an accurate representation of what Wakefield Pride R/C 1188056 have done/ and what we plan for the future.

We also confirm that this years accounts are accurate and correct. As such this report forms a narrative of our achievements and plans for the future.



## Background

As we prepared for our 20th Event in 2024, we took time to reflect on the history of our organisation, its roots from when Wakefield pride first came together in 2005 as a community group to organise an annual Pride event in our city of Wakefield, on how our 'group' has had many volunteers, members, committees and how we came to gain Charitable status in January 2020.

We also reflect on the successes of 2024, our 3rd Pride event at our home on Borough Road Carpark and how we created our biggest events yet.

We also reflect on the success of the opening of our Shop & Hub in the Ridings Shopping Centre.

We look to the future discussing how our committee, our team of volunteers and their roles have evolved as we moved onto our next exciting chapter.

We also welcome Stuart as our new Chair at the start of the financial year; He stepped up to the role after 2 years on the committee. We thank Stuart for his stewardship over the last year and for the future! – well done Stuart!

## Key points for 2024–2025

We celebrate 2024 with 'Our Year 2024' a yearlong programme of culture and events in the Wakefield District. Wakefield Pride are confirmed as a partner in Our Year.

We reflect on how successful the year was and the contribution that Wakefield Pride made to the programme.

Our financial year started with our Easter Event in the Calder & Hops; it was an event hosted by Ariel-51 with live music from Emma Gill with a Grand Raffle of prizes organised by one of our volunteers.

We all agree that it was successful event. We reflect on the Raffle. We have run many raffles over the years; they take a lot of organising and the need just isn't there anymore from the public – we agree that we will move away from Raffles & concentrate on Tombola's at our events where people can play on the day and select a prize.



## Key points for 2024-2025

After what had been a pipe dream for many many years, we received the keys for our retail space in the Ridings Shopping Centre on the 4th of April.

We thank the Ridings Management team for supporting what would become our Pride Charity Shop & Hub. We also thank the B&Q Foundation for a grant of 10k to set up and furnish the Shop. Thanks also to YPO for gifting us office equipment, stationary, and furniture for our social area in the shop.

We also thank Jo King for her determination and dedication to making this pipe dream a reality. This has been a topic discussed each year as our Trustees compiled the TARs. The shop would serve to make our charity more sustainable and create a steady income stream, a departure from a heavy reliance on sponsorship and grants whilst also giving us a presence 'on the High Street'.



## Key points for 2024–2025

In early April we partnered with Wakefield Libraries to support their 'Come to our LGBTQ+ group at #CastlefordLibrary!' Enjoy free tea and coffee, courtesy of our warm welcoming spaces initiative!

After 4 weeks of hard graft from our Volunteers & Trustees, what was a semi derelict space on the lower mall in the Ridings had become a bright and colourful space utilising the gifts from YPO, a grant from B&Q, a till from Shaun Slater at the Black Rock, a counter from Host & Home, as well as racking and shop fittings gifted from the Ridings.

We take a moment to reflect and thank everyone that made it possible to open the Shop & Hub. This would be the first Pride Charity shop in Yorkshire! We are very proud to have made this dream come true!

The Grand Opening was on 01/05/2024 and was a spectacular launch with our Festival Hosts Sordid Secret, Glitz Von Winkle with our Trustees and special guest Steve aka Madame Connie (Wakey Drag Legend) to open the Shop. There was not a dry eye when Jo King cut the ribbon and received a beautiful bouquet on rainbow-coloured flowers – her dream had come true!

We had live music from Dolly Parton, a beautiful buffet from Cozy Corner Café and a whole host of local dignitaries including our MP Simon Lightwood in attendance.

Our sponsors and supporters were all there too. We take time to look back at the amazing launch and how the shop has developed over the last year.

You can't have a shop without Volunteers, we take time to thank our key volunteers that have guided the shop throughout the last year, special thanks to Denise who was there from day dot when we got the keys (who'd have thought she would end up building clothing rails, tables and waxing wood! Denise certainly didn't!).

Thanks also to Josh for donating his time to decorate the unit, Russell for just being there when we need him. Denise, Russell, Margaret, Christine, Blake & Mandy together with the Trustees have ensured that the shop has been open, stocked and donations sorted.

None of us, Trustees or Volunteers had any experience in running a Charity Shop, we are extremely grateful to Cath at Scope and Lisa at the Community Foundation for giving advice, support and encouragement as we started our retail journey.

We have a laugh as we look back and remember when we first encountered size cubes, Kimble guns not forgetting coats hangers of various sizes and how many we went on to need! 1500 of them!



## **Key points for 2024–2025**

The shop is more than just a shop; it's a social space with music playing – what other shop in Wakefield has DJ Equipment and a music licence? We do! – it's what we do.

Pride brings the community together and fosters a welcoming happy space free from prejudice or hate. We all agree that it's a happy shop, our customers and volunteers enjoy their time in there too.

The Ridings are also impressed with the increased footfall we have brought to the lower mall. We thank all of the Ridings management and Security staff for welcoming us and keeping our space safe.

We also take time to thank our supporters for all the kind donations that have kept the shop stocked with good quality items for us the sell. Our goal is for zero waste, everything that can't be sold is recycled, even down to clothes that can't be sold or don't sell that we put to the rag trade.

We also appreciate the impact the shop has had on our sustainability – the shop made a profit of 15K in its first year making the shop our biggest self-generated income stream.

## Key points for 2024–2025

On the 11th of May we were back at With Banners Held High on Wood Street, a main stay of our calendar in solidarity with the trade unions that stand up for the rights of the LGBTQ people.

It's also a chance to network and meet new supporters and sponsors. We thank Marc for his hard work in maintaining the Pride Merchandise for the shop he takes 'on tour' through the district.

Marc also maintains the Pride Stock in our shop – well done Marc! On the 28th of May we confirmed YPO as our headline sponsor for the 3rd year. Their support over the years has been incredible, and we're beyond grateful to have them back with us this year in what was their 50th Anniversary Year.

On the 13th of June we announced our best lineup of artists yet for our festival in August – the social media post had 214 likes, 122 shares and was extremely well received.

We reflect on the success of the advertising campaign and thank our social media team, Noel, Hannah and Nads from Host & Home for managing them for us!

Friday 21st June saw us host another Pride Fundraiser at the Calder & Hops hosted by Robyn Banx & Glitz Von Winkle with an evening of bingo, spin the wheel and music – we thank Michael at the venue for providing the space again for us.

On the 23rd of June in Pride Month we Partnered with the National Mining Museum to celebrate LGSM and the contribution they made not only to support the miners in the 84–85 strike but to the LGBTQ+ movement.

We thank Matthew for partnering with the Museum and collaborating on this piece – Anyone with any connections to the mining industry would very much associate the word pride with both the industry and those who worked in it.

Pride in their families; pride in their labour; pride in their contribution to their communities; pride in their contribution to their country as a whole; pride in their history.

But it is another “Pride” that we wanted to look at; LGBTQ+ Pride and its connections to the mining industry we are so proud of.

For many people there may have been no obvious connection until, that is, the feature film *Pride* hit our screens telling the story of LGSM (Lesbians and Gays Support the Miners) a group of people from London who donated more money to the cause of striking miners in the Dulais Valley than any other group.

It tells the story of the unusual connections which formed between the groups and how those miners who were helped by the LGSM at possibly the most difficult time in their lives, marched alongside them at Gay Pride in London in June 1985. With thanks to Wakefield Pride for contributing to this piece.

29th of June and we were back at Wakefield Armed Forces Day – a favourite event of our charities Trustees and Volunteers.

AFD gives us the platform to host a stall and talk to our public, our service people and allies. We thank Marc for procuring and showcasing his 'fancy new tent' at this event.

The new gazebo makes us stand out bright and proud and is an excellent addition to our mobile shop. Well done Marc! We also provided the Pride flag for the 3rd year for the annual parachute drop – What a cracking end to Pride Month of June!

Once again, to support grass roots sport, we sponsored Ossett Women's Rugby Team to promote equality. We thank Ellie for giving us the opportunity to sponsor her again and welcome the full team to participate in the annual parade in their kits.

In July we welcomed our latest Sponsor – Card Factory that are based in Wakefield – they are a great addition to our growing family of supporters – the trustees take time to look back at the sponsorship and how successful it was for us.

Thank you also to Stuart for reaching out to them and organising their participation – we also thank Card Factory for painting our shop window for Pride Month. It looked amazing!



## **Key points for 2024-2025**

On the 24th of July we made a very special announcement – We were delighted to announce that this year we'd be joined by true heroes of the LGBTQIA+ community!

Mike Jackson and Jonathan Blake from Lesbians and Gays Support the Miners joined our parade and the festivities on the 11th of August! Mike and Jonathan's activism in alliance with the South Wales Miners strike inspired the 2014 movie Pride. Notable stars Dominic West and Joe Gilgun played Jonathan and Mike respectively on the big screen.

They have recently donated artifacts to The National Coal Mining Museum and thoroughly enjoyed joining the march! We announced that Mike and Jonathan would be with us all day and are looked forward to meeting everyone and even happy to take pictures with them!

We thank Matthew for working closely with LGSM and The National Mining Museum to make this happen. We also thank Fin from LNER for supplying first class rail for Mike and Johnathan on their trip back to London.

## Key points for 2024–2025

In July we once again partnered with the Art House to host a day of 'Printing for Pride' scheduled for the Pride weekend, we thank the Art House for this fringe event on our weekend.

We also announced the return of DJ Connie to the fringe events raising money for Wakefield Pride – thank you Steve from our trustees.

On the 6th of August we invited our headline sponsor YPO to host a recruitment drop-in session at our Wakefield Pride Shop. It enabled people to gain valuable recruitment advice while shopping.

YPO People Services team were there to share insights into YPO roles and essential criteria, Information on inclusive policies, current vacancies and application processes, application and interview tips to boost confidence.

YPO proudly support the LGBTQIA+ community as part of their Headline Sponsorship of Wakefield Pride. Thank you to Simon and the whole team from YPO from our Trustees and volunteers.



## Key points for 2024–2025

In August we also announced support from RMT and Sandal BMW to our list of supporters and sponsors. We thank them for their support.

We can't talk about the weeks running up to our scheduled festival without mentioning the civil unrest that had rocked the UK. Shocking scenes of riots filled the media. We had supporters contacting us asking if we were still going ahead with our event.

We reflect on our response to this climate and our reaction to it. We work closely with West Yorkshire Police and their Counterintelligence heads and agree to hold the event as planned.

Threats of acid attack are brought to our attention, and we bolster our medical plan and security detail – we work closely with the police in the days up to the event. We thank the Police for sharing valuable information with us and making sure that together with our security detail that our event was safe.

We also thank Titan Security and West Yorkshire ambulance service for reacting quickly to the intelligence. We also reflect on how this affected numbers that attended our event and parade and thank all attendees that turned out in the face of the rumours to come to our event.



## Key points for 2024-2025

On the 6th August, 4 days before our festival and parade we announced this on our socials; With some growing confusion and speculation we're here to confirm that Wakefield Pride will be going ahead as planned!

Pride events are important to the community to promote inclusion and equality, and we will continue to prioritise the communities safety. Safety is our top priority and as such we have upped our security by 25% at no small cost to ourselves.

Wakefield Pride is committed to ensuring a safe event and we have, and will continue, to be in constant contact with local police and follow guidance provided to us.

Special Yee-ha to the Griffin for hosting a Pride Country & Western Fundraiser on the eve of our event, thank you also to DJ Nick Kershaw for providing the tunes!

11th August and it was Pride Day! We reflect on how amazing it was and thank everyone that made it happen with us.

The Community Stage started at 10am in Trinity Walk, we thank Trinity Walk for having us back again for the 4th time. Thanks also to Normanton Theatre Musical Society for providing the entertainment and Queenie Buffet for hosting.



## Key points for 2024–2025

The parade started at 12pm led by trustees, volunteers, On Behalf of HM King Charles, the Deputy Lieutenant Johnathon Hammond, Simon Lightwood MP, Darren Byford Mayor and Consort.

The parade was led by Mike and Jonathan founders of LGSM in an image reflecting the Gay Pride March in London 1985 and of the film Pride. They were followed by the Pit Banner of the National Mining Museum reflecting the overwhelming support from the NUM in 1985 too.

We thank Matthew for organising their participation and Stuart for liaising with BBC News who attended and filmed this historic and moving celebration of what are true legends of the LGBTQ+ Pride Movement.

It was an honour to host them and extremely moving.

The parade was filled with members of the LGBTQ+ community and their families and our allies.

We had for the first time the PCS Samba band – they were an amazing addition to the parade; we thank them for taking part. We had 2 rainbow river silk flags, plus a trans river flag in the parade, we thank David Culley of Pride Colours for once again supplying them and set dressing the event space.

The parade was filled with our sponsors, local groups and supporters

We also take time to reflect on someone missing from this years event, one of our Trustees Jo King who was sadly hospitalised following complications after her stroke 18 months previously.

We all know how much pride meant to her and we thank her for her contributions.

The main stage was started with DJ Mikki who returned to pride after nearly 20 years! Welcome back Mikki.

The speeches.....

We have goosebumps just recalling the incredible and amazing speeches. First up Mike and Johnathan from LGSM who spoke about the incredible contribution they have made to the Pride Movement and how this was reciprocated by the NUM which lobbied the Labour party to push for equal Gay rights.

Followed by Darren Byford our Mayor, Wakefield's first openly Gay Mayor who gave moving speech. Simon Lightwood, Wakefield's first openly Gay MP then gave a speech.

The speeches were very moving, something that will never be repeated and our trustees are incredibly humbled to have organised it.

Next came Johnathan Hammond Deputy Lieutenant for West Yorkshire who opened the event – he even recorded a special message for Jo in hospital. He was amazing.

We had some incredible feedback about the speeches, so we reached out to Simon and Darren to donate them to Wakefield Museum for posterity.

Thankyou to everyone that gave speeches for us this year.

The festival then started and was an overwhelming success, even when our headliner had a medical emergency and couldn't attend, we carried on with the show and no one missed the Cheeky Girls! We thank all of the artists and performers that performed for us all, especially Xuberdance that stole the show again as the first Act – special thanks to Tilly for rounding the troupe up!

Cath at Scope Wakefield gave us enormous support and facilitated a lot of the logistics of the day. Thank you Cath!

We had not one but two a BSL signers and disabled access at the main event ensuring that our event continues to be accessible to all.

It was a huge success for us, we flooded social media, we were interviewed by local press, radio stations and TV.

We're overwhelmed by the positive feedback we have had for this years main event.

We thank James Knowles at Yorkshire Craft Beers and Noel Roberts at Host & Home for providing the drinks offering.

Together they provided a slick and seamless operation acting on previous feedback from the 2023 impact surveys, the service was quick and the drinks were ice cold, good quality and value for money for our attendees.

We also thank them for their generous donations to Wakefield Pride towards our running costs and expenditure.

We can't talk about the event without mentioning Dan from DSM whose team provided the stage, after all we wouldn't have an event without it – the production quality was outstanding again – thank you Dan!

Our pride parade (also known as pride event, pride festival, pride march, or pride protest) is an event celebrating our lesbian, gay, bisexual, and transgender (LGBT+) communities, our social and self-acceptance, achievements, legal rights, and pride.

It is also the has the most visible impact on the city as we parade through the centre. It was amazing!

We can't really reflect on the event without the fantastic archive visual media that we have, we thank Pride Pics UK and 98 Media for once again documenting the day.

We thank our vendors and stall holders for bringing the merchandise, wellbeing and charitable focus to the day. Again, acting on feedback we have opened up the applications for 2025 stalls in readiness for the next event.

## Key points for 2024–2025

Post Festival we took time to compile our Impact survey. We are Proud to say that Wakefield Pride, as the hosts of the region's largest free cultural event incidentally gave an economic and cultural boost to the economy estimated £1,113,309.35. We are understandably Proud.

Through the Autumn we started hosting Turning Point in our shop & hub with free drop-in sessions running on every 2nd and 4th week in the month. We were excited to be able to offer this amazing service at our shop to offer more opportunities to people in the community to be able to seek support with their Drug and Alcohol use! We also thank turning point.

On the 22nd October we were honoured to have an audience with the Right Worshipful the Mayor of the City of Wakefield Metropolitan District in the mayor's parlour in recognition of our contributions to our city.

We took the opportunity to thank Darren personally for the moving speech he delivered back in August.

We didn't have a usual Halloween event, with great sadness one of our previous venues and the place where it on began (on the back of a beer mat) closed unexpectedly – the Rainbow. We think about the sense of grief we had as the last of the original 'Gay' bars closed.

We also reflect on how we outgrew Sun Lane and moved to a bigger space at Borough Road..... 2025..... History repeating?

On 29th October Wakefield Pride said goodbye to Jo King as she stepped back from our board of Trustees and thank her for her service to our organisation and charity. Jo stepped back to concentrate on her recovery and rehabilitation and all trustees wish her all the best for the future.

## Key points for 2024–2025

It was poignant for us that Jo King and Katy from the Rainbow collected an award on our behalf at the Wakefield Bid awards, having both stepped away from what had been such a big part of their lives, Pride and the Rainbow.

The award they collected on our behalf was for the outstanding Contribution to the City Centre. We also thank Bid for raising £200 for our Charity at the event.

On the 10th of November we attended Remembrance Day service at Wakefield Cenotaph for the 3rd year and had the honour of laying a wreath on behalf of the fallen and forgotten LGBTQ+ that gave the ultimate sacrifice, sacrifice that until very recently was given without recognition of their sexuality or gender.

We once again thank Matthew for laying our wreath.

In December rather than putting on an event we chose to thank our supporters at the National Mining Museum by supporting their Christmas Appeal. We partnered with Lisa at the Community Foundation to procure and deliver a car full of toys for the toy swap reminiscent of Christmas of 1984 in solidarity with the striking miners.

## Key points for 2024–2025

At the end of January we added yet another trophy to our Northern Enterprise Awards shelf!

In 2023 we were awarded "Best LGBT Community Pride Event" and in 2024 we're so happy to receive "Best Community Pride Charity 2024 – West Yorkshire & SME News Social Cohesion Excellence Award 2024"!

It's such an honour to receive this award and we can't thank all our sponsors and supporters enough for helping us build Wakefield Pride up!

All agree that this is a huge honour and accolade given to us in recognition of our charity and the hard work that our Trustees, Members and Volunteers put into organising our main festival and charitable work.

We couldn't have achieved the Award without all of our supporters and volunteers – we thank everyone for contributing and making 2024 another Award-Winning Year!



## Key points for 2024–2025

In the Pride History Month of February, we chose to showcase our history – the history of Wakefield Pride.

We photo dumped our entire collection of photos from each year starting with 2005. We laugh as we remember prides past – especially the photos of Marc! Marc is incidentally the longest serving member of the committee now – having witnessed the inaugural scrawling on the beer mat in the Rainbow to working in the Harewood, Downtown, Dolphin, Zeus, New Union and Odessey – fast becoming a legend Marc! We thank Marc for his service.

The photo dump also stirred an incredible response from our followers sharing stories and reminiscing and sharing stories.

In February we also sponsored the Infinity Allstars Majorettes and Wakefield City Emeralds. Sponsorship of local talent especially these provides Pride in bucket loads and we are extremely grateful for the opportunity to do it. We thank Beth for inviting us to sponsor.

We're looking forward to the new financial year as we source new and existing funding / sponsors / Grants.

Our End of year accounts are balanced and on budget for the new years expenditure.

Marc, the Master of the Merch is sourcing new merchandise including new pin badges, we all agree how great they are and thank Marc for the commitment he has given and gives to the shop.

We can't mention the future without mentioning the shop! We have a premises with a shop and space to hold workshops, meetings, counselling, and mental health work.

We all agree that it helps our sustainability, community outreach and opportunities for more volunteers. As Trustees we agree that sustainability is the key. Income from the premises helps our sustainability.



## Looking to our 21st festival

We have employed Noel Roberts of the Host and Home Group for the 2nd year to provide the Event Safety Management Plan for 2025 drawing on his wealth of experience within Wakefield's Hospitality and Festival sector.

With over 25 years of experience Noel is an Asset to Wakefield Pride and our future security and safety. We thank Noel and his team for the vast amount of time he has committed to supporting us to provide a safe main festival in August.

We have identified some of our biggest outlays for our events and have a clear budget.

We're looking to take our stall/shop to more events this year than previously after the shop's success this financial year.

And of course, Wakefield Pride 2025 main event is scheduled Sunday August 3rd. 2025 see us hold our 21st Pride Festival and of course we are all busy behind the scenes organising it to make it our biggest and best yet!

We are acting on feedback from our impact survey and social media to improve on the 'You said we did' policy we hold.

We are moving into the next 12 months with stronger relationships.

We have looked at ways to bring down costs where possible and other sources of funding.

Our members continue to work tirelessly for our Charity and our current members work well together to ensure that we are meeting our Charities missions and goals.

Our goal is to provide a free inclusive Pride Event.

## Looking to our 21st festival

2025 will be different, exciting new venue, 300% increased capacity, more opportunities to participate with more space for organisations to showcase themselves within our festival.

Wakefield Pride brings people together, fosters strong connections within and between communities. Our previous impact surveys evidence a diverse demographic, representing a blend of individuals from various communities and backgrounds.

Our initiative facilitates community engagement in cultural and artistic activities while actively advocating for marginalised communities. It gives our attendees the chance to celebrate each other's differences and what makes us individual.

Our previous projects have been in the City Centre.

This year we're creating Wakefield's newest 2-day festival, increasing our capacity from 5k to 15k attendees (a staggering 30k over 2 days!)

It will raise the profile of Wakefield, and Pride as the hosts of the region's largest free cultural event – it will incidentally drive an economic and cultural boost to the economy against a backdrop of austerity.

We take possession of our new event space in Thornes Park on

Tuesday 29th July 2025 & hand it back Tuesday 5th August.

Good Times is scheduled for Saturday 2nd August



## Looking to our 21st festival

Wakefield Pride Parade and Festival is scheduled for Sunday 3rd August

We've a creative vision to provide Wakefield's biggest ever 2-day Festival 2025. A 2-day festival is an ambitious new direction for our charity.

We've used imagination & innovation to help fund Wakefield Pride with the Good Times Festival. Good Times aims to make us sustainable, drive growth in terms of scale and what we are offering to our attendees (as a fundraiser it will be self-financed/ticketed)

We're planning to host a new weekend event in a new location, with a new pride route/parade, a new starting place and bigger community stage.

At 10am 03/08/2025 our community stage begins near the Cathedral; attendees can expect to see local 'talent' whilst mustering for the parade.

Expect a parade with a carnival atmosphere, walking parties of the public, trade unions, employees from partner sponsors and organisations, vehicles in Pride colours, marching band, silk rainbow rivers of trans & prides flags.

See the streets lined with people cheering/waving the parade as it departs down Westgate to Thornes Park.

In the Park expect a festival village with approx. 100 community/ charity & pride stalls, bright decorations and 'set dressing' in a green and open part of the park on the football fields near the miniature railway & adventure playground (which will also be open).



## Looking to our 21st festival

Food concessions, bars, funfair with a Ferris wheel and large rides, as well as smaller rides like merry go rounds that will foster a family feel.

Addition of a funfair to the weekend is a direct result of feedback from attendees of our previous projects that wanted more for families and children to do. They also wanted a place to sit; the park will offer the opportunity to sit on grass rather than tarmac in previous years.

Wakefield biggest ever stage will be opened by local dignitaries giving speeches before a roster of artists take us through a live music performance accompanied by dancers, pyros, and confetti cannons.

At the festivals finale at 20.30 expect a silent firework display to rival bonfire night and round off the weekend's celebrations.

The audience can expect an accessible free event with a disabled area (near the stage with BSL signers)

Collaborators can expect to part of Wakefield biggest ever event celebrating diversity in our city – Expect some of the biggest artists ever to perform in our city. It will be a fun family friendly atmosphere without the threat of prejudice.



## Looking to our 21st festival

Wakefield Pride offers a unique opportunity to connect with like-minded individuals, fostering a sense of community and belonging in a world where isolation can often plague the LGBT+ community.

Our festival serves as a beacon of inclusivity and acceptance, providing a safe space for people to come together and celebrate their identities.

Moreover, we recognise the importance of providing resources and support to our attendees. From Information about mental health services to access to preventive healthcare, Wakefield Pride strives to empower individuals with the knowledge and tools they need to lead healthy and fulfilling lives.

Many people may not be aware of the available services, and our festival serves as a platform to raise awareness and connect individuals with vital resources – we do this with community stalls for organisations and charities – 2025 having more than ever going from 20 to 100 stalls.

Above all, Wakefield Pride is committed to creating a safe and accessible environment for all, regardless of background, identity, orientation, everyone is welcome to join in the festivities and be themselves without fear of judgement or discrimination by promoting a culture of acceptance and celebration.

We aim to leave a lasting positive impact on our audience and participants, strengthening our communities.



## Looking to our 21st festival

There's also a positive impact on our partners, volunteers and contractors who get to be part of such a huge event, learn new skills, develop others and showcase their talent on a huge platform that is celebrated across our social media/website and local news channels.

As a Pride organisation – Accessibility and inclusivity are our core aims.

Everyone is welcome to attend without threat of prejudice or impairment due to disability.

Our community stage gives an opportunity for local grass roots talent to showcase themselves (they can apply through our website and socials)

The parade is flat or down hill to ensure that it is accessible for attendees with disabilities, it is a slow walking pace for people with mobility issues and those in wheelchairs and scooters.

We have accessible toilets on site

We have BSL signers on the main stage to support those with hearing impairment.

This year we also have planned large video screens of the stage for those with impaired sight.

We have planned a dedicated accessible area at the front of the stage for people in wheelchairs etc can view the event without have to look through a fence.



## Looking to our 21st festival

We also appreciate that not all attendees may have access to social media/online so we are planning adverts in the city in the form of posters in prominent positions in local businesses, together with notices in local news and on local radio.

The NHS is contracted to provide our medical and wellbeing details with a dedicated safe space vehicle for ask for Angela, or as a sober space or a space to get advice on drink/drugs with dedication NHS professionals.

We are also committed to provide a free event that is available to all regardless of financial situation or poverty.

Pride might be an annual event in Wakefield but 2025 is promising a whole new experience in a whole new arena for people to come together with their friends, families and meet other people in turn making more memories and sharing in the Pride we have for each other and our cities!

It's true that you never forget your first pride or any that come after – our archives then provide a springboard to remember and cherish these moments



As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





**1. ACCOUNTING POLICIES**

**Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

**Income**

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

**Expenditure**

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

**Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

**Taxation**

The charity is exempt from tax on its charitable activities.

**Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.



As the charity trustees of the Trust you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





**1. ACCOUNTING POLICIES**

**Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

**Income**

**Taxation**

The charity is exempt from tax on its charitable activities.

**Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

# 2023-2024 Trustees Annual Report

## **Overview**

This is our third annual trustees report since our charitable foundation in January 2020.

All trustees agree that this last financial year continued to bring some of the biggest challenges yet to our charity against the backdrop of the cost of living crisis.

In our report we discuss in chronological order what we have achieved and what we seek to achieve over the next year as a charity.

As such this report reflects what we have discussed and achieved in the 2023-24 financial year. All agree that this is an accurate representation of what Wakefield Pride R/C 1188056 have done and what we plan for the future.

As such this report forms a narrative of our achievements and plans for the future.

## **Background**

As we prepare for our 20th Event in 2024, we take time to reflect on the history of our organisation, its roots from when Wakefield pride first came together in 2005 as a community group to organise an annual Pride event in our city of Wakefield, on how our 'group' has had many volunteers, members, committees and how we came to gain Charitable status in January 2020.

We also reflect on the successes of 2023, our 2nd Pride event at our new home on Borough Road Carpark and how we created our biggest event yet.

We also look to the future and of deeper relationships with our sponsors and partners, and of new beginnings within the Ridings Shopping centre as we plan for our new Charity Shop and Hub.

We look to the future discussing how our committee, our team of volunteers and their roles have evolved as we move onto our next exciting chapter.

## **Cost of living and its impact on us**

As Trustees we look back on how last years main festival at Borough Road went on 13/08/2023.

All of us reflect on the costs of the event and this years accounts. We acknowledge the costs and the challenges we had – we compare this to the budget for Wakefield Pride 20th Edition on 11/08/2024.

We then discussed how we funded it. We applied for funding and grants in order to fund the event, a well-trodden process that we have done for previous events.

Various grants were secured, sponsorship was sought from businesses we have collaborated with in the past. These are reflected within this years Audited accounts.

We had continued support from our largest contributors, the YPO, Coca-Cola European Enterprises and welcomed new sponsorship from Wakefield BID, Molly & Tommy, Host & Home and WDH amongst others.

We also secured grants from National Lottery Community Fund, Made in Wakefield and the ASDA Foundation.

We also sought sponsorship from other sources/businesses reflected in our accounts.

We continued to hold our regular 'members' meetings to plan our fundraising.

As Trustees we acknowledge how much the 2023 event cost and how we could make savings for the 2024 event.

We also take time to thank our kind supporters/ sponsors/ fundraisers and donators.



## Key points for 2023-2024

We started the financial year in April by welcoming a new supporter to our growing list, ASDA Store at Durkar, Wakefield. It was pleasure to visit them and receive donations of Easter Eggs for our Easter fundraiser and raffle – we reflect on how the ASDA foundation also supported our main festival by sponsoring the BSL interpreters on our main stage.

Our network of local supporters would, as you will see in this report expand massively this year giving a fantastic foundation for our next round of events.

Our Easter fundraiser was a huge success again showcasing local talent, Madelaine Roberts as Shania Twain hosted by Miss Gina Tina. It was held in the Calder & Hops where we also held a raffle to raise money for our Charity.

We also thank Shaun at the Black Rock for once again supporting with a raffle.

In May we supplied a New Progress Flag to the Townhall in readiness for Junes Pride Month, this was also published in the Wakefield Express Newspaper and shared across the councils social media, as well as ours.

In June we made our way back to attend Wakefield Armed Forces Day at Pontefract Racecourse. It was a great honour to supply the 2 & Half Yard Pride Flag for a parachutist to jump with at the event.

We reflect how this event as well as others are giving us a presence in the community, raising awareness and raising funds adding to our ongoing sustainability.

We were extremely proud to be invited to attend Cineworld White Rose's 3 day Pride film festival with a stall. Our reach was growing.



Ask any of the trustees what we do in June, and top of the list we all agree that it wouldn't be June without our stall at Morrisons Dewsbury Road thanks to their community champ Bev.

We discuss how they have been one of our longest supporters and thank them, as well as Pam Abbott for the support they have given over the years.

We also reflect on the Shop and how Marc has grown it year on year generating a steady growing income for the charity – his valuable experience means that he knows what to stock, Marc is also proud of the things he has created for the stall and the merchandise he has procured.

Marc is proud of his shop. All agree that the shop is one of our best assets giving us a connection with the community when we take it 'on tour' round the district.

June also saw the 'Big Pride Wakefield Week Out' – This was our latest Committee member, Stuart's project. We all agree it was a fantastic idea and saw us having Pride Themed Fundraising nights in The Strafford, Talbot & Falcon, Raven, Calder & Hops, Black Horse, Union Bank, Throwback Coffee House and the Polka Hop. From Hawaiian nights to bingo and karaoke – this week featured it.

We all thank Stuart for organising it and liaising with all the businesses to make it a success.



July saw a fundraiser take place at the Community Shop in Knottingley – we thank Patsy V for organising it and ‘calling the bingo’.

Our trustees old and new discuss July. July has always been a challenge for our charity, this year was no different. Add in a cost of living crisis and the usual challenges of funding, planning and organising the main event intensify.

Our first event at our new home on Borough Road in 2022 had gone over budget. This year meant catch up. It was difficult, all present thank Matthew, our Treasurer for ensuring that the accounts balanced this year and that all suppliers and contactors were paid.

All of us at Wakefield pride appreciate the work Matthew puts into the budgets, accounts and bookkeeping. As you will see in the audit, we have never been in such a healthy position as we move into the new financial year.

We all agree that as volunteers with day jobs, and personal lives, it is a daily challenge to balance our time. We have given years of service to Wakefield Pride. In July it was time for our Chair to step down, this would be their last event. We all thank Jude for her dedicated service to our committee and the Charity. This also meant that the rest of the trustees and volunteers would have to step in and fill the gap for the near future.



We reflect on the 'teaser video' that Tom at 98 Media did for us as we geared up to the main event in August. All of us think that Tom has done a brilliant job of managing our social media, photography and video.

Our Archive is growing as we document our events and share it across our platforms. Little did we know how this would come in useful later in the year.....

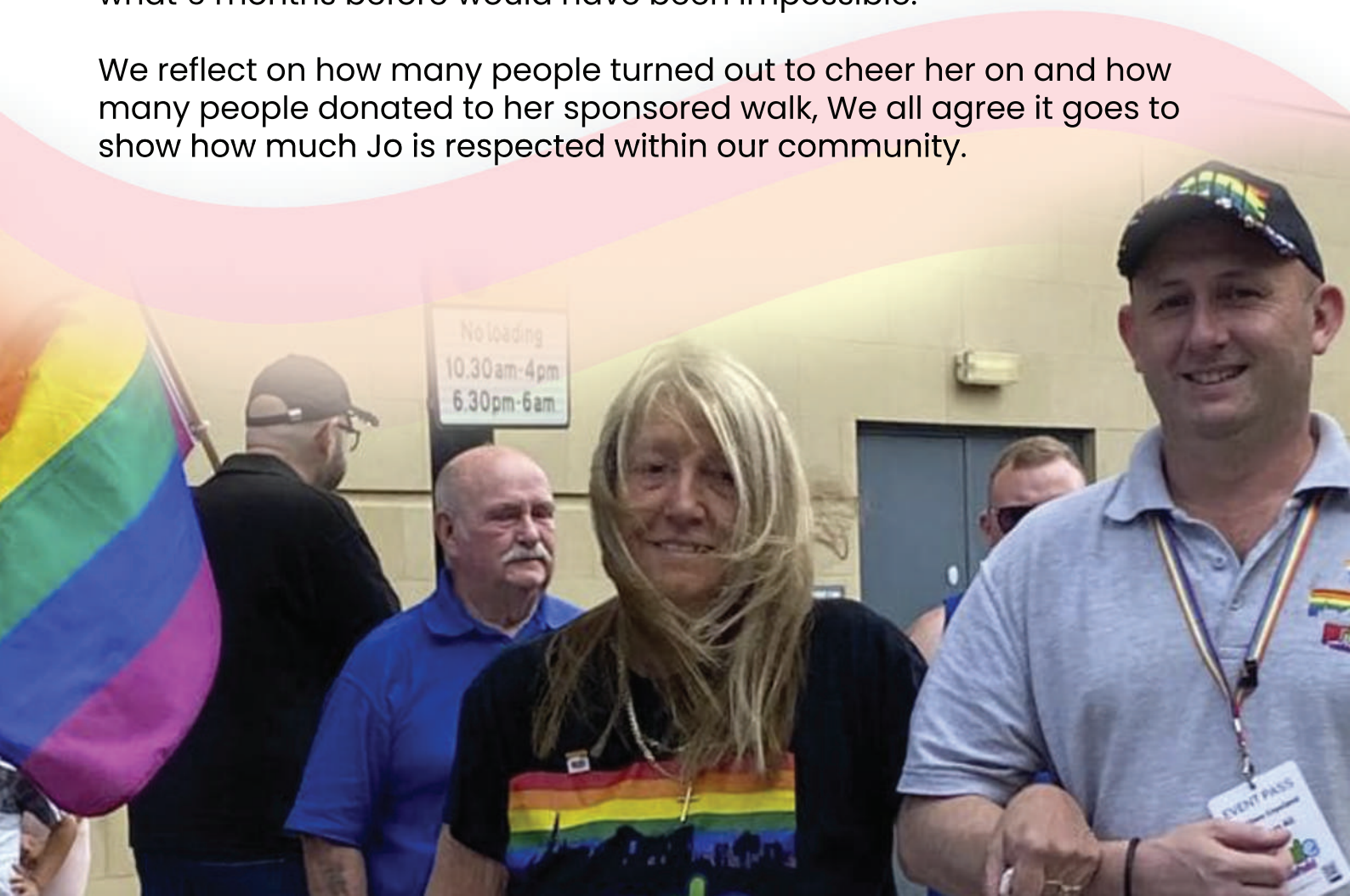
We had partner with Experience Wakefield last year, and this year they had been advertising our festival for us, we thank them for their partnership.

Our network of supporters continued to grow. What was the biggest challenge in August? Jo one of our trustees and longest serving committee member who has been with us since the start in 2005 - laughs, we thank Jo for her fundraiser.

Having suffered a massive stroke within a week of the last festival, Jo was still recovering. Ever stubborn she wouldn't be beaten and chose to do a sponsored walk of the pride parade route to raise money for us.

We're all immensely proud of her for doing it and challenging herself for what 6 months before would have been impossible.

We reflect on how many people turned out to cheer her on and how many people donated to her sponsored walk, We all agree it goes to show how much Jo is respected within our community.



The main event was only 2 sleeps away and the Pride Guides were published and out.

Saturday saw us take possession of the event space and the building of the infrastructure began. We talk about the Festival and how amazing it was.

Our Main event was held, as always on the second Sunday in August, this year falling on the 13th.

This was our second year at Borough Road Carpark. Having the previous year gone bigger, with a bigger parade, bigger venue, bigger stage, bigger artists. 2023 was a tried and tested formula now, we enacted 'you said - we did' from our impact surveys and introduced more market stalls and installed some marquees for shade and cover, improved the food and drink offering building on the previous years successes and key learns.

Logistically we chose to close the event at 8pm rather than 10pm the previous year, condensing the acts and making it easier for dispersal post event, attendees getting home and encouraging those that wanted to carry on the celebration to attend our official after parties in the Calder & Hops and the Polka Hop.

It was a huge success for us, we flooded social media, we were interviewed by local press, radio stations.



We had the pleasure once again to have in attendance a representative from the West Yorkshire Lieutenancy to open the event, supported by leaders of the Council, Mayors, deputy Mayor and consorts, as well as our local MP.

It is a great on honour to carry on the relationship with the Lieutenancy with kind permission to attend and open the event from His Majesty The King Charles III on his behalf, just as his late Mother Her Majesty Queen Elizabeth had before him in previous years.

We're honoured to have continued support and endorsement for our event from the Monarchy. We partnered with many many venues throughout the city – the whole city was awash with rainbow flags in support of our event.

We had volunteers from YPO and Coca-Cola European enterprises help on the day as part of the sponsorship packages.

Cath at Scope Wakefield gave us enormous support and facilitated a lot of the logistics of the day. Thank you Cath!

We had not one but two BSL signers and disabled access at the main event ensuring that our event continues to be accessible to all.

We reflect on how successful the event was.

We held an impact survey post main event – our trustees look over the results, feedback which will be enable our next event to build on the success of this year.

We're overwhelmed by the positive feedback we have had for this years main event.



We thank James Knowles at Yorkshire Craft Beers and Noel Roberts at Host & Home for providing the drinks offering. Together they provided a slick and seamless operation acting on previous feedback from the 2023 impact surveys, the service was quick and the drinks were ice cold, good quality and value for money for our attendees.

We also thank them for their generous donations to Wakefield Pride towards our running costs and expenditure.

We have also invited them back to provide this years hospitality at our next scheduled event in 2024, again talking account of impact survey feedback.

We can't talk about the event without mentioning Dan from DSM who's team provided the stage, after all we wouldn't have an event without it .

The production quality was outstanding again – thank you Dan!

Our Artists roster saw us bring back some old favourites and introduce new headliners that have never performed in our city before. Our impact survey results reflect the success of the running order .

We reflect on the Parade – the parade or march is integral to our annual celebrations and is makes the day for us – it's the reason for the event – our chance to walk through our city in solidarity with all of our supporters and communities to celebrate our diversity and champion equality.

The parade seeks to create community and honour the history of our Pride movement. We had hundreds take part in the parade again with representatives from local businesses, organisations and supporters, we had music provided by the Crofton Silver Band together with Stilt Walkers and Cosplay. Two 60 foot rainbow rivers, and a 20 foot trans flags were walked along the root carried by our attendees – the visual impact was incredible.



Our pride parade (also known as pride event, pride festival, pride march, or pride protest) is an event celebrating our lesbian, gay, bisexual, and transgender (LGBT+) communities, our social and self-acceptance, achievements, legal rights, and pride.

It is also the has the most visible impact on the city as we parade through the centre. It was amazing!

In 2023 the parade was bigger than it had ever been – it also brought its challenges for us – all agree that this will be one of our biggest challenges for the 2024 event, as we expect our attendance figures to increase, safety being our main focus as we organise and build our safety management plan. Plans are set for increased marshals and security to keep this aspect of the event as safe for everyone.

We can't really reflect on the event without the fantastic archive visual media that we have, we thank Pride Pics UK and 98 Media for once again documenting the day – they are back in 2024 to do it all again!

We thank our vendors and stall holders for bringing the merchandise, wellbeing and charitable focus to the day. Again acting on feedback we have opened up the applications for 2024 stalls in readiness for the next event.

Once again in September we chose to sponsor Ossett RUFC Women's Rugby promoting inclusivity and equality in grass roots sport within our city.

In November we attended Remembrance Day service at Wakefield Cenotaph for the 3rd year and had the honour of laying a wreath on behalf of the fallen and forgotten LGBTQ+ that gave the ultimate sacrifice, sacrifice that until very recently was given without recognition of their sexuality or gender.

We held our annual Christmas Pride event at The Calder and Hops with some local artists and held a raffle to raise funds, Wakefield's Bake-off celebrity Karen Wright baked and donated a Christmas cake which we raffled.



## **Award Winning**

In December we also celebrated winning the Northern Enterprise Award for the 'Best LGBT Community Pride Event 2023 – West Yorkshire' .

All agree that this is a huge honour and accolade given to us in recognition of our charity and the hard work that our Trustees, Members and Volunteers put into organising our main festival and charitable work.

We couldn't have achieved the Award without all of our supporters and volunteers – we thank everyone for contributing and making 2023 an Award Winning Year!

## **New Beginnings**

January meant new starts and new beginnings, we introduced more Trustees, a new Chair and committee members.

Our new Chair – Thomas, acknowledges the incredible achievements of our charity, how far we have come and identifies how far we can go, his new focus for us being more succinct organisation, planning, networking, growth and outreach.

All of us welcome Thomas to the charity and thank him for bringing this new focus to light.

We have started a new partnership with Our year 2024 – 366 days of culture celebrated in Wakefield. We have been recognised as a key date within the cities events calendar.

We've launched a new website – reflecting our charities partnerships, supporters, and key information. All of that fantastic 98Media came in useful!

We were proud to be invited back by Bev Kelly Community Champion and held a stall in Morrisons supermarket for LGBTQIA History month. This has become one of our regular events in our calendar.

We were invited to have a stall at this years Rhubarb festival and our committee and volunteers attended. We all agree that events like this get us out there into the community where we should be.

In March we were thrilled to have the opportunity to engage with the inspiring students of Outwood Grange Academies Trust at Leeds United! As Wakefield Pride, it was truly a pleasure to speak at their Student Conference and participate in the insightful Q&A session. The students demonstrated remarkable creativity and raised thought-provoking questions, sparking valuable discussions and presenting incredible ideas.

We're grateful for their enthusiasm and commitment to fostering positive change within the Trust and the community.

We ended the financial year with a fantastic weekend of activities for Easter, on Good Friday and Easter Saturday in the Ridings Shopping Centre. It was a brilliant opportunity to bring together volunteers and our committee to create a family friendly weekend to raise funds and let the children have fun. We Had live music, dance, facepainting, a tombola a Pride Stall, and of course Allan the Giant Rabbit!

We thank YPO for supporting us with the crafting supplies for attendees to make easter bonnets, baskets and have fun colouring in, ASDA at Durkar for providing Easter eggs for our Tombola and B&M in Pontefract for supplying Eggs to give away to the children. We also thank Craig Higgins for facilitating the event in the Ridings.

We also had fundraising events in the Calder & Hops on Good Friday and Easter Sunday. We thank Michael at the Calder for once again providing the venue, and the artists, performers Ariel-51, Stealia Heart, Emma for providing the sparkle!

We would also like to thank all of the other artists, performers and attendees for making the weekend a huge success. It also helped us to raise over just £800 for our Charity.



## **Looking to our 20th festival**

We're looking forward to the new financial year as we source new and existing funding / sponsors / Grants.

Our End of year accounts are balanced and on budget for the new years expenditure.

Marc has sourced new merchandise including new pin badges, we all agree how great they are and thank Marc for the commitment he has given and gives to the shop.

We can't mention the future without mentioning the shop! We are looking at the viability of a premises with a shop and space to hold workshops, meetings, counselling, and mental health work. Watch this Space! We all agree that it will help our sustainability, community outreach and opportunities for more volunteers.

As Trustees we agree that sustainability is the key. Income from the premises would help our sustainability.

We have employed Noel Roberts of the Host and Home Group to provide the Event Safety Management Plan this year and subsequent years drawing on his wealth of experience within Wakefield's Hospitality and Festival sector. We thank Noel and his team for the vast amount of time he has committed to supporting us to provide a safe main festival in August. We are moving into the next 12 months with stronger relationships.

**Basis of preparing the financial statements**

## 1. ACCOUNTING POLICIES

**Basis of preparing the financial statements**

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. ## **OVERVIEW**

This is our second annual trustees meeting since our charitable foundation in January 2020.

Understandably – all present agree that this last financial year has seen some of biggest challenges yet as we recovered from the Pandemic and found a new home at Borough Road Carpark.

In our meeting we discuss in chronological order what we have achieved and what we seek to achieve over the next year as a charity.

As such this report reflects what we have discussed in the meeting and all present agree that this is an accurate representation of what our charity at Wakefield Pride R/C 1188056 have done/ and what we plan for the future.

As such this report forms a narrative of what we discussed

# BACKGROUND

We reflect on the history of our organisation and its roots from when Wakefield pride first came together in 2005 as a community group to organise an annual Pride event in our city of Wakefield. We reflect on how 'group' has had many volunteers, members, committees and how we came to gain Charitable status in January 2020.

We also reflect on the success of 2021, our last Pride event when we did things 'a little differently' holding events within venues rather than outside against the backdrop of Covid restrictions. Though it was different kind of day it was hugely successful for us and helped foster relationships with multiple businesses and venues within our city.

We acknowledge how our events during the pandemic have supported local businesses and also supported Artists. They have also promoted inclusivity and diversity throughout the city. It enabled us to reach out to parts of our communities that we hadn't before. In short, though not how we usually organise it - by default it had been a massive success.

We reflect on how we have evolved. We agree we have come a long way from our humble beginnings originally and notoriously founded on the back of a beer mat in the Rainbow Pub back in 2005.

We discuss the various venues, from The Rainbow Carpark to Sun Lane to our new venue - Borough Road Carpark. Our event has got bigger and bigger and so we have adapted to larger spaces and venues.

We look at how far we have to come to where we are now having just organised Wakefield's biggest outdoor music festival within the city limits on 14th August 2022.

We look back at the relationships we have fostered within our city - the community event stage that has become an integral part of our annual event at Trinity Walk and the commencement of our annual event - we all agree that Trinity Walk is integral to our event and inception of our main event.



# 2022 – A CHANGE OF VENUE

As Trustees we look back on how we came to our new home at Borough Road.

Late 2021- Spring 2022 we were still on track to hold our Main event on Wood Street in the heart of our city on Sunday 14th August. Wood Street had been offered to us by Wakefield Council as a possible new venue after our previous home on Sun Lane had reached saturation point in 2019.

Then came the realisation of the enormity and scale and problems facing us to hold the Main Pride event on Wood Street.

As a group we had many many meetings, we liaised with Wakefield Council, Licensing, SAG, West Yorkshire Police, NHS and other interested parties.

Since being offered Wood Street in 2019 things had changed, there weren't so many empty shops/ units anymore, the old police station was earmarked for residential development, businesses now had pavement licences – concerns were raised about safety and licencing. We faced major challenges with the logistics of the proposed site.

It was clear to us that we needed to find an alternative.

Where in the centre of the city is big enough with enough capacity to hold our event? It was a tough few weeks until we had an epiphany – Borough Road Car park!

We sought permission to use the space and were granted it in principal by Wakefield Council, now came the logistics.....

Time was against us, SAG, Licensing etc all have time constraints and deadlines to meet in order to meet the deadline for the 14th August 2022



## **2022 – A CHANGE OF VENUE**

We adapted our very detailed Event Management Plan from previous events and arranged a site visit with West Yorkshire Police and Licensing.

Concerns were raised about the scale and safety of the event, the level of detail in our existing plan, and the fact that we were treated a new event. Moving site meant that we were in effect starting from scratch again. It was made clear to us that we had to employ an Event Management company to write an Event Safety Plan (EMP) to gain the endorsement and confidence to hold the main event at Borough Road by West Yorkshire Police and Wakefield Licensing. We sought a local events management company that had worked with Wakefield Council before.

Our charities committee approached Grace and Tailor and instructed them to plan the EMP for us.

All present reflect on the cost of this years event and this years accounts. We acknowledge the hidden costs, the EMP, Licensing, fencing that was required to satisfy our licensing obligations. We discuss how we funded this year.

We applied for funding and grants in order to fund the event, a well-trodden process that we have done for the last 15 years. Various grants were secured, sponsorship was sought from businesses we have collaborated with in the past and throughout the pandemic. These are reflected in this years Audited accounts. We gained new sponsorships, our largest contributors being Coca-Cola European Enterprises and the YPO, and the usual grants from National Lottery etc.

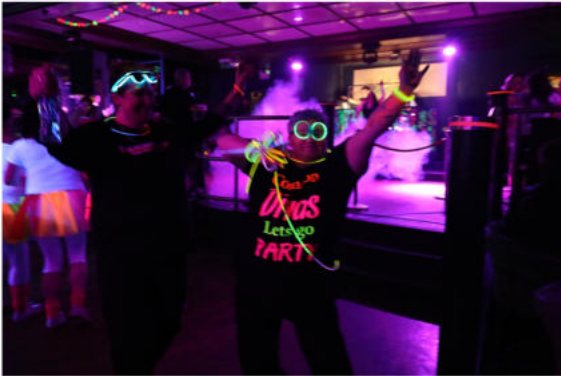
We also sought sponsorship from other sources/businesses reflected in our accounts.

We continued to hold our regular 'members' meetings to plan our fundraising.

As Trustees we acknowledge how much of an impact the new venue has had on costs.

# KEY POINTS FOR 2023

In Spring 2022 we supported a local school by providing toys for Ukrainian Children displaced by the conflict in their country. We held a Spring fundraising event at Velvet Bar 'Neon Divas'.



We held a Jubilee Race night at the Rainbow. We attended and had stalls at Banners held High on Wood Street, Wakefield Armed Forces Day in Pontefract, Morrison Supermarket in Lupset, local businesses throughout the city, Normanton Musical Theatre Society in Normanton. Our Trustees agree that these satellite events are very important for our charity, raising our profile, raising money and giving us a presence.

These events also enabled us to meet new contacts, supporters, sponsors and the general public as a whole. We discussed how our 'shop' has been a huge success this year and contributed to our sustainability.



# KEY POINTS FOR 2023

Wakefield Girls High School invited us to a colour run event organised by their sixth formers to raise money for our charity. Our trustees acknowledge how much of an honour it was that we were chosen as their nominated charity and were allowed to attend.

Our Main event was held, as always on the second Sunday in August, this year falling on the 14th.

We went big this year, bigger parade, bigger venue, bigger stage, bigger artists. We flooded social media, we were interviewed by local press, radio stations.

We partnered with many many venues throughout the city – the whole city was awash with rainbow flags in support of our event. We had volunteers from YPO and Coca-Cola European enterprises help on the day as part of the sponsorship packages.



# KEY POINTS FOR 2023

Scope Wakefield gave us enormous support and facilitated a lot of the logistics of the day.

We acted on feedback from previous events and impact surveys including have a BSL signer and disabled access at the main event.

We donated surplus soft drinks from the main event to foodbanks, charities in Wakefield providing free meals to children during the summer holidays.

We held an impact survey post main event – our trustees look over the results, feedback which will be enable our next event to build on the success of this year.

We're overwhelmed by the positive feedback we have had for this years main event.

We sponsored Ossett RUFC Women's Rugby promoting inclusivity and equality in grass roots sport.



# KEY POINTS FOR 2023

We held a Christmas Pride event at The Calder and Hops with some local artists and held a raffle to raise funds, we encouraged our attendees to bring Christmas presents to our 'alternative Santa's grotto' to donate to local children.

Wakefield's Bake-off celebrity Karen Wright baked and donated a Christmas cake which we raffled.

In December we had our Christmas appeal, again with the help of our pride partners and agencies to provide a Christmas Dinner to those most vulnerable within our communities, we delivered them out.

We opted for people to be referred or self-referred, we helped 50 families that comprised of over 200 people.



# KEY POINTS FOR 2023

The famous trimmings from the Black Rock, Wakefield were sold and the proceeds given to our Charity to help fund our 2023 events.

We held a stall in Morrisons supermarket for LGBTQIA History month.

We recorded a TikTok video in Wakey Wines with two of our committee members to launch our 2023 £1 for Pride appeal, we acknowledge its success, post reach, and subsequent extra followers to our social media. Our Website is now ranked higher on Google too as a result.

Social media is alive with Wakefield Pride.

We now have multiple income sources from Facebook Donations, Just Giving, PayPal all set up.

We are Proud of what we have achieved.



# WHAT NEXT?

We have advertised and invited new members to join to join our Charity, bring new ideas and help share the workload.

We have welcomed 3 new committee members in February 2023.

As Trustees we agree that sustainability is the key.

We have identified some of our biggest outlays for our events.

We are looking at the viability of have a premises with a shop and space to hold workshops, meetings, counselling, and mental health work. We are setting up a CIC in readiness.

Income from the premises would help our sustainability. We're also planning quarterly fundraisers, Charity sports events and more.

We're looking to take our stall/shop to more events this year than previously after the shop's success this financial year.



# WHAT NEXT?

And of course Wakefield Pride 2023 main event is scheduled for Borough Road, Sunday August 13th

We are acting on feedback from our impact survey and social media to improve on the 'You said we did' policy we hold.

We are moving into the next 12 months with strong relationships. Our current finances are our biggest challenge against the backdrop of the cost of living crisis.

We are looking at ways to bring down costs where possible and other sources of funding.

Our members continue to work tirelessly for our Charity and our current members work well together to ensure that we are meeting our Charities missions and goals.




