B) THE ADVANCEMENT OF EDUCATION, AND IN PARTICULAR SUPPORTING EDUCATIONAL INSTITUTIONS IN THE UK, USA AND ISRAEL BY THE MAKING OF GRANTS OR FOR EXAMPLE, ORGANISING LABOUR AT ZERO OR SUBSIDIZED COSTS. C) THE PREVENTION AND RELIEF OF POVERTY IN UK, USA AND ISRAEL BY PROVIDING FINANCIAL SUPPORT TO EXISTING CHARITIES WHO ARE SET UP FOR THESE PURPOSES AND ASSISTING PEOPLE DIRECTLY WHO ARE FACING POVERTY OR ARE OTHERWISE UNABLE TO MEET THEIR DAY TO DAY LIVING EXPENSES.

Activities: Advancement of the Jewish religion for the public benefit including but not limited to providing educational opportunities to assist people in carrying out their religious beliefs; the advancement of education, the prevention and relief of poverty
