Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>The charity has continued to be very successful in terms of its fundraising throughout a continued difficult period in the country, with the cost of living crises. This has enabled us to help a lot of children and their families in hospital.</p> <p>We have donated numerous 'boxes of smiles' for children on long term admissions and have also created additional packages such as Sensory Story Bags and Busy Bags, which were specifically requested by certain wards and different hospitals. As our reach has expanded throughout the hospitals we cover, we have been contacted by different wards asking for various items which they believe will help the patients and we have been able to provide. This includes the bust bags which are a distraction for children waiting for theatre and the sensory bags for children who have regular admissions to the day ward.</p> <p>All our other care packages have been regularly requested and again, have expanded to other wards as the word spreads about the charity throughout the hospitals.</p> <p>We have again received many messages from recipients and their close and wider families which detail how the care packages have supported them through the difficult times in hospital and have helped to bring a psychological boost to the children and their families. We have had letters from the hospitals also praising the work we are doing, which is above what they are able to provide to families in hospital. We have also received gifts from our Amazon wishlist, which are often a thankyou from recipient families who want to pass on a smile to someone else in hospital.</p> <p>We have had lots of support from the public in terms of fundraising. Many have set up their own fundraising challenges on behalf of the charity. We as trustees also try to take part in challenges which will help support the charity and spread awareness. This years main challenge was climbing Mount Snowdon which one of our trustees carried out along with a number of other volunteers.</p> <p>Another big event which was held by a local business was the Turfest which has supported the charity in the past and they have said that they are happy to support us in the future. This event was held in the local area and again helped to raise funds and spread awareness of the charity. The feedback following the event was very positive.</p> <p>We again had another successful Christmas Smile appeal and were able to provide large donations of toys to each hospital for onward distribution to</p>

		<p>patients within the hospitals over the Christmas period.</p> <p>We celebrated William's 10th birthday by doing a William's Birthday Gift. We asked the Gastro wards at Manchester and Alderhey and children's ward at Warrington what they thought would be beneficial and were able to provide a large amount of lego to the gastro wards and the children's ward asked for a sensory trolley and sensory items which would help when patients were unable to access the sensory room.</p>

Review of the charity's financial position at the end of the period	Para 1.21	<p>The charity is still in a good financial position at the end of the reporting period. We have been able to accept all referrals that have been sent through for boxes of smiles and have continued to expand our donations of Bags of help, Bags of bravery and activity packs to other wards and an additional hospital to help other children and their families</p> <p>We were contacted by the Founder of the Champs Appeal charity who advised us that she had decided to close the charity and would like to transfer remaining funds to William's Gift. Champs appeal had supported William and family when he was alive and as it is a similar charity (supporting families with bowel conditions). The founder said she would be happy for the remaining funds to go to such a good cause. This gave William's Gift a significant financial boost and will enable us to continue to support children and their families in hospital.</p> <p>The Trustees fundraising aim for the year was £10,000, however we managed to raise just under £41000 in monetary terms. The charity also received donated goods with an estimated value of £4800. These items are kept in stock for onward donation to the beneficiaries as and when referrals are received. The charity was also donated a laptop worth £750 which has been recorded within fixed assets.</p> <p>The Trustees believe that the difference in the fundraising aim and the actual amount is mainly due to the donation from Champs appeal and the expanded</p>

		<p>awareness of the charity, leading to more members of the public and local businesses wanting to fundraise for us.</p> <p>The charity has funds in the bank of £38712.26 at the end of the reporting period and donated items kept in stock valued at approx. £1436.</p>
