Activities: The foundation seeks to promote, encourage and extend the love, appreciation, enjoyment, understanding and practice of fine and decorative arts, and their traditional skills, through awarding grants for art projects in and supporting fine/decorative arts students in and from north Wales, Merseyside, Wirral, Cheshire, Shropshire and Herefordshire.
