The adoption of street dogs is central to our mission and we are delighted to have successfully rehomed a dog in Spain.</p> <p>Further to this, we have built a small enclosure on a private land plot, which now homes 5 dogs. And we're now working on a project to build a dog park on the same parcel of land, in order to socialise dogs and potentially offer a recreation ground for the local community and their dogs.</p> <p>We believe this will help us integrate into the local community, as well as offer a free service to local residents, whereby they can enjoy time with their pets.
