SUPPORT THE PUBLICATION OF SCHOLARLY WORKS BY ANY MEANS INCLUDING MAKING GRANTS TOWARDS RESEARCH OR TO COVER PUBLICATION COSTS OR BY MAKING A COMMITMENT TO PURCHASING AND DISTRIBUTING SUCH PUBLICATIONS.
