Families Out Loud is a Wiltshire charity working with families challenged by someone else's drug and alcohol dependency, supporting them to bravely build a better life.

###### Vision

We want to reach every family impacted by drug and alcohol use, so they can speak out, free from stigma, and receive the support, care and help they need.

#### Our objectives

- To promote mental wellbeing by dealing with feelings of stress, loss, guilt, shame and hopelessness.
- To secure income through donations, grants, sponsorship and independent fundraising.
- To actively promote awareness of the charity through newsletters and social media
- Increase outreach by approaching those who influence the support of those we consider to be our client base to advise them of the services we offer.
- To increase the number of FOL beneficiaries year-on-year.

#### Activities and performance

We provide various online and face-to-face counselling and support group services as follows:

- **One-to-one sessions** provide a safe space for clients to talk freely about what is happening in their lives. After an initial assessment that explores background, expectations, and any safeguarding issues, our experienced professionals offer counselling and therapeutic support focusing entirely on each individual's needs.
- **Family group sessions** can promote openness, discussion, and prevent family misunderstandings. Emotional manipulation is common behaviour for drug and alcohol users, and while family members are responsible for their actions, our professionals encourage open and constructive dialogue to reach a consensus on how the family collectively responds to a loved one.
- **Peer support groups** can be powerful and healing, providing the opportunity to talk to others who are also living with family addiction. Sharing stories and building relationships with peers who understand your situation helps people to feel less isolated and lonely. FOL's 2022 survey shows that 86% of respondents felt their mental health had improved after having 1-1 and/or group support.
- **Bereavement support** helps families during the worst of times. The potential loss of a loved one who is using drugs and alcohol is a constant fear for many FOL clients, but for some, it becomes a reality. The situation requires an exceptional understanding, and we want to be by their side as they come to terms with the loss of someone whose life was difficult, complicated, and often sad.
- **Teen support** for 13 to 17-year-olds is our newest specialised service offered by our expert young person's counsellors. Teenagers can struggle with their emotions when someone in the family is using drugs and alcohol. It is common for them to withdraw, to struggle at school, and to exhibit changes in behaviour and extremes of mood that are difficult to manage. Support from a specialist counsellor, who encourages the expression of emotions that are then heard and accepted, can help the young person realise they /aren't responsible for the actions and outcomes of their loved one's behaviour.

#### Impact

When one person receives our help, the whole family unit is often positively affected. Based on client information, we believe that for every individual who engages with our services, at least four others in their immediate circle benefit.

- Increased the number of beneficiaries from 125 at 30/09/23 to 205 adults and 10 Teens at 30/09/24. The Teen service began in January 2024
- In the year to 30/09/24 we delivered 626 in 1-1 client sessions.
- Our social media presence with Facebook, and Instagram followers increased from 510 at 30/09/23 to 684 at 30/09/24.

**Impact (continued)**

- We delivered group sessions online and face to face to active clients. Throughout the year to 30/09/24 there were 151 attendees.
- 90% of participants felt that using FOL services positively impacted their relationships with friends and family.

**Financial review**

The Charity has achieved another year of growth and although progress is slow, we are building on a firm foundation.

We have raised funds from market stalls, also from our client contributions towards our counselling services together with a number of generous grants which have enabled the charity to expand our support for our clients and we now have a fundraiser who has worked to raise the funds to enable us to achieve the growth which will fulfil our Purpose and Vision.

**Reserves Policy**

At 30<sup>th</sup> September 2024 we have 2-3 months reserves. We intend to build this to 4 months reserves in the coming year.

#### Achievements and performance

##### New bereavement service

In our work with families of people who have drug and alcohol addiction issues, the death of a loved one is a familiar concern. Sadly, for some this concern becomes a reality. Therefore, in May 2021 we began offering a bereavement service including one-to-one support and monthly face-to-face group meetings.

##### Sharing by Doing Volunteer programme

To recognise our growing team of volunteers, Sharing by Doing Volunteering was introduced with the aim of providing a focus for existing helpers, and recruiting even more of them. These fantastic volunteers all have one thing in common – they believe in our mission to support families of drug & alcohol users in Wiltshire. They generously donate their time by making high quality items that are sold online and at craft markets, writing articles for our website, helping out on craft stalls, peer mentoring and making sure all aspects of our charity are run well.
