B. [LEARNING DISABILITY" MEANS ANY DEVELOPMENTAL DISABILITY OF THE MIND AND ANY ASSOCIATED CONDITION HOWSOEVER CAUSED AND WHETHER MILD, MODERATE OR SEVERE.] C. THE PROMOTION FOR THE BENEFIT OF LEARNING DISABLED AND DISABLED MEMBERS OF THE PUBLIC OF URBAN OR RURAL REGENERATION IN AREAS OF SOCIAL AND ECONOMIC DEPRIVATION IN THE NORTH EAST OF ENGLAND AND IN PARTICULAR IN COUNTY DURHAM AND WEARSIDE, BY ALL OR ANY OF THE FOLLOWING MEANS: (I) THE RELIEF OF UNEMPLOYMENT; (II) THE ADVANCEMENT OF EDUCATION, TRAINING OR RETRAINING, PARTICULARLY AMONG UNEMPLOYED LEARNING DISABLED/DISABLED PEOPLE, AND PROVIDING UNEMPLOYED LEARNING DISABLED/DISABLED PEOPLE WITH WORK EXPERIENCE; (III) THE CREATION OF TRAINING AND EMPLOYMENT OPPORTUNITIES FOR LEARNING DISABLED/DISABLED PEOPLE BY THE PROVISION OF WORKSPACE, BUILDINGS, AND/OR LAND FOR USE ON FAVOURABLE TERMS:
