FOR THE YEAR ENDED 31 DECEMBER 2024

The trustees present their report with the financial statements of the charity for the year ended 31 December 2024. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The charity was established for the care and protection of animals in need. To do this, the charity operates two shops in order to generate funds, one in Ulverston and the other in Barrow-in-Furness. It also receives monies from memberships, adoptions, donations, legacies and income from investments. The shops themselves rely heavily on the time and efforts of volunteers.

Animal Welfare (Furness) charity number 519065 transferred its assets and liabilities on 1 January 2023 completing its transition to a Charitable Incorporated Organisation of the same name, charity number 1189973. Due to delays in the transfer process, property is still held in the unincorporated Charities name at the 31 December 2024. The property has been incorporated into these financial statements.

Public benefit

The trustees confirm they have complied with their duty under section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission and consider that the pursuit of the trust's objectives through the activities described above is consistent therewith

ACHIEVEMENT AND PERFORMANCE

Charitable activities

This year many changes have happened within the business from staff training, re-branding, new shop purchase, new vastly improved website and consultants assisting the charity.

We have also had some new staff and volunteers and created a new Associate Trustee role to assist the Charity Trustees going forward. We are looking to fill this roll during 2025.

More changes will be added to the charities portfolio for 2025 going forward as the Charity is expanding with our new shop and collaborating with other organisations.

Both our retail shops in Barrow and Ulverston have had a good steady year with revenue, just a few bumps with staff illness.

The cattery has had a productive year as usual and a little less on the feral side of things this year.

Unfortunately like with all businesses the core costs have spiraled this year with supplies and vet fees and with this our adoption costs for animals had to go up to help with this increase. The charity has helped a lot more animals and persons within our community via financial hardship, mental health and wellbeing, pet foods and animal behaviours.

One area we have struggled with this year is transportation of animals and our TNR scheme and stock for shops, so this is earmarked for 2025.

Our new shop in Ulverston at 2 Dalton Gate will open in April 2025. This has actually been a costly project and more than initially expected but it will look great.

We are now again fully associated with the ADCH and the Charity Fundraising standards and this means our standards are kept high.

We did say at last years AGM that we were looking for land for dog kennels and feral cats. Unfortunately this has not come to fruition so this may be sort for in 2026/2027.

I would like to thank Tesco, Co-op, Booths, Pets at Home Foundation, Factory shop Ulverston and WCF pet supplies who have vastly helped the charity throughout the year with pet foods and litter and with their donation points in stores.

Reserves policy

It is the committee's policy that the reserves held by the charity should be such that the charity can carry on its activities for six months without income. The reserves should, therefore, represent one half of the years expenditure. At 31st December 2024 the reserves met the policy requirement.

None of the funds are restricted.

FINANCIAL REVIEW

For the 2024 year, the charity generated a deficit in funds of £41,623 (2023 : Surplus of £743,233). 2023 included an exceptional item of £651,466 being the transfer of net assets from Animal Welfare (Furness) charity number 519065 on 1 January 2023.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its CIO constitution dated 17 June 2020.

Recruitment and appointment of new trustees

Applications received from potential new trustees are discussed at a Trustees Meeting. Once appointed, we provide copies of our Constitution and a welcome pack from the Charities Commission.

There must be at least four charity trustees. If the number falls below this minimum, the remaining trustee or trustees may act only to call a meeting of the charity trustees, or appoint a new charity trustee. As of 28 March 2025 a new trustee has been appointed, taking the total number to four.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Donated goods for resale are not recognised on receipt. The value to the charity of the donated goods sold is recognised as income when sold. The proceeds of sales are categorised as 'Other trading activities'

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Freehold property	- 2% on cost
Improvements to property	- 10% on cost
Computer equipment	- 33% on cost

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charity operates a defined contribution pension scheme. Contributions payable to the charity's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.

The charity was established for the care and protection of animals in need. To do this, the charity operates two shops in order to generate funds, one in Ulverston and the other in Barrow-in-Furness. It also receives monies from memberships, adoptions, donations, legacies and income from investments. The shops themselves rely heavily on the time and efforts of volunteers.

Animal Welfare (Furness) charity number 519065 transferred its assets and liabilities on 1 January 2023 completing its transition to a Charitable Incorporated Organisation of the same name, charity number 1189973. Some transactions have been carried out under the unincorporated charity name during the year under review due to delays in the transfer process. Also, some assets including bank accounts and property are still held in the unincorporated charities name at the 31 December 2023. Those transactions and assets have been incorporated into these financial statements.

Public benefit

The trustees confirm they have complied with their duty under section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission and consider that the pursuit of the trust's objectives through the activities described above is consistent therewith

ACHIEVEMENT AND PERFORMANCE

Charitable activities

This year we have had a major change in our management as Michele Hudson, Charity Manager had taken early retirement in April and we appointed and welcomed Emma Fawcus as the new Charity Manager in May. We still had however ongoing issues with the CIO status banking accounts but thankfully that is now finally dealt with.

The charity in 2023 has also had a reshuffle of trustees and ended the year with 4 on the committee.

Our Shops in Barrow and Ulverston and our Cattery in Barrow have been very busy this year.

Our retail shops combined Barrow and Ulverston's income has decreased slightly by £9,000. We believe this to be due to staff and volunteer shortages and a decrease of footfall earlier in the year.

Barrow now has 3 part time employees and 4 volunteers and Ulverston also has 3 part time employees and 3 volunteers whilst our Cattery has 5 employees and 12 volunteers.

We do however still require more volunteers to help within the shops and our fundraising team, so we are launching a volunteer project in 2024.

Our Cattery on Rawlinson Street has had a mini facelift with a new front door and window signage which looks wonderful and the care of animals this year has been:

Dogs 3 - 3 adopted

Cats 163

137 were adopted

17 PTS/Died

5 reunited with their owners

3 transferred to another rescue

2 in foster homes

12 in the cattery over the New Year

Ferals 93 - of which 5 were PTS

Others 1 Rabbit - 1 adopted

We took the necessary steps to cease renting kennels from the Barrow Borough Council due to the facilities being under the standards we expect and operate on. Unfortunately due to not having other dog facilities in place, we cannot accept dogs for rehoming for approximately the next 2 years. We will still offer advice and referral to Wainwright's trust, we will be however in the pipeline having Dog Kennels from 2025.

The charity still operates at a very high standard, when members of the community adopt from us, our animals have all been health checked, vaccinated, cats FIV tested, wormed and flea'd, microchipped and neutered (after 6 months if adopted a kitten) this service is provided by Furness Vets of Dalton.

This year we started the procedure to join the ADCH (Association of Dog and Cat Homes) and were very proud to have been accepted by the association for our membership to begin in 2024. This was achieved by the existing high standard that the cattery team already had in place.

By joining the ADCH it lets adopters, other rescues, professional partners and funders nationally know we are operating at these high standards and will open many doors for the charity, including training, funding and networking.

We at AWF have had a Welfare pot to support animals whose owners need funds. This was a £50 voucher supplied to their chosen VETS. Unfortunately 2023 has seen all vet practices put up their consultation fees by up to 30% so our pot was well utilised. Due to this we are looking at each welfare need individually from 2024 to provide the best help possible to the animals in our community and their owners.

It's been very hard on us this year as a charity with the vet fees and extra guidelines but our amazing team in the Cattery had sacrificed their goodwill time with the 7 feral colonies within the Furness area, in Particular Helen, Kayleigh and Tanya for their cat trapping skills.

We cared for just under 100 cats as part of our feral Trap Neuter Release project.

Our vets fees this year, which includes cats in our cattery, fosters and the feral scheme, totalled £31,962.

With this in mind, the minimum adoption donation for kittens will increase for 2024 from £100 to £150. This is to make us in line with other rescues in the county and to attempt to replenish the veterinary and care cost per kitten which exceeds £250.

In 2023 we applied for funding to help with our feral project to purchase equipment and to help with our veterinary fees via the Pets at Home Foundation. We were awarded £11,000 - £7,000 towards our feral project and £4,000 towards the veterinary fees.

We also started talks in late 2023 to charity partner with our local Barrow store and we will be partnered from April 2024.

Every year we have had a lovely donation of £5,000 or £10,000 by the Samuel & Freda Parkinson Trust which supports the welfare pot, cattery items and kennel fees when we used Walney kennels. We were advised that the trust is winding up in late 2023, and were very grateful to receive a final donation of £50,000 to be used on our existing projects. We thank them very much for the continued support over the years and wish the trustees of the trust all the very best.

The charity had been looking for land to build Dog Kennel facilities in the Barrow area but the costs are too high, so this is currently on the backburner for now whilst we explore other options to enable us to care for dogs.

Our aim for 2024 is to own all our shop and cattery facilities, so we are hoping to explore the assets we already have to expand the charity's offer.

FINANCIAL REVIEW

Reserves policy

It is the committee's policy that the reserves held by the charity should be such that the charity can carry on its activities for six months without income. The reserves should, therefore, represent one half of the years expenditure. At 31st December 2023 the reserves met the policy requirement.

None of the funds are restricted.

For the 2023 year, the charity generated a surplus in funds of £743,233 (2022 : £Nil). This included an exceptional item of £651,466 being the transfer of net assets from Animal Welfare (Furness) charity number 519065 on 1 January 2023.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Freehold property	- 2% on cost
Improvements to property	- 10% on cost
Computer equipment	- 33% on cost

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Pension costs and other post-retirement benefits

The charity operates a defined contribution pension scheme. Contributions payable to the charity's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.
