## **Objectives and Activities**

The charity's objectives are to support refugee volunteers through community-based projects, helping to promote inclusion, skill development, and wellbeing.

During the financial year, CONNECTIONHUB continued to deliver small-scale community support activities.

The work focused on assisting refugee volunteers in Greece through project engagement and community support initiatives.

## **Achievements and Performance**

Despite operating on a small income, CONNECTIONHUB successfully supported local volunteer activities and community initiatives. Volunteers were crucial to the delivery of projects, and funds were used to reimburse necessary project-related expenses.

## **Financial Review**

All funds were fully expended on charitable activities during the year. No reserves were held at the end of the CONNECTIONHUB - Trustees' Annual Report and Accounts financial year.

The charity did not engage in any investment activities.

## **Structure, Governance and Management**

CONNECTIONHUB is a Charitable Incorporated Organisation (CIO) governed by its constitution.

During the financial year 1 July 2022 to 30 June 2023, CONNECTIONHUB was managed by a board of trustees. In late April and early May 2023, all trustees (James Perham-Marchant, Heloise Ardley, Firas El Dib, and Dr Konstantina Foteinou) formally resigned from their positions. Following these resignations, no new trustees were immediately appointed before the end of the reporting period.

Although Dr Konstantina Foteinou remained listed on the Charity Commission register temporarily, she had formally resigned and was not involved in any further governance or operational matters. Administrative responsibility for the charity was assumed entirely by Monica Wagner. Monica Wagner accepts full responsibility for the administration of the charity during and after this transition and requests that any Charity Commission correspondence be directed solely to her.

No new trustees were appointed during the period.
