All trustees are issued with copies of charity commission's guidance.

4. Charitable Objects

- i. To advance the Islamic faith for the benefit of the public through providing a place of worship, religious services, broadcasting Islamic messages of an evangelistic and teaching nature and producing and/or distributing literature on Islam to enlighten others about the Islamic religion
- ii. To advance the education of the public by:
 - a. Promoting study in the subject of Islam and the Quran for the benefit of the local community, regardless of age, gender or race.
 - b. By hosting religious education study sessions for local school children and/or adults to promote understanding of the Islamic faith
- iii. To further or benefit the residents of Huddersfield, West Yorkshire and the neighbourhood, without distinction of sex, sexual orientation, race or of political religious or other opinions by associating together the said residents to advance religious or other opinions by associating together the said residents to advance education and to provide facilities in the interest of social welfare for recreation leisure time occupation with the objective of improving the conditions of life for the residents.

5. Charity's activities and performance.

6. Financial review of the period

The Charity relies on fees and voluntary income.
Donations and fees received during the period were £142,008.

7. Reserves policy

The charity's reserve policy is to hold sufficient funds in reserve to enable the charity to operate for a period of six months if no other funds were available.

8. Gift Aid Donations

The charity is recognised by HM Revenue & Customs (HMRC) to claim Gift Aid on eligible donations received from UK taxpayers

9. Public Benefit statement.

The trustees confirm they have complied with their duty in Section 17(3) of the 2011 charities Act to have due regard to the guidance on public benefit by the Charity Commission in exercising their powers and duties.

10. Future Plans

After deliberation, the trustees have decided to proceed with transferring to the Incorporation of Markazi Jamia Masjid Ghausia – Granting Indemnity to the unincorporated trustees.

This decision was driven by several key factors aimed at enhancing the long-term sustainability and operational efficiency of Masjid Ghausia.

Firstly, incorporation will provide a more robust legal framework, facilitating Improved governance and clearer regulatory compliance. This legal structure will also enhance our ability to enter into contracts, own property, and engage In various financial transactions with greater security And credibility.

Secondly, incorporation will significantly mitigate Individual trustees' liability. By creating a distinct legal entity, Markazi Jamia Masjid Ghausia itself will assume liability, thereby protecting trustees from personal financial risk associated with the mosque's obligations and activities. This structural change is crucial in attracting and retaining qualified Individuals willing to serve as trustees without the fear of personal liability.

After reviewing our governing documents and consulting with advisors, we confirm that the trustees' liabilities have indeed been amended as part of the incorporation process. The liability protection afforded by Incorporation will now shield trustees from personal financial exposure, except in cases of fraud, gross negligence, or other acts of wilful misconduct.

In summary, the incorporation decision reflects our commitment to strengthening our framework, enhancing operational capabilities, and ensuring the trustees can serve with confidence in their roles. The amendment of trustees' liabilities through incorporation represents a vital step in aligning our legal protections with our missions and goals.
