The objects of the Charity are, for the public benefit

- i. to relieve terminally ill patients at hospices and health settings with a view to improving their quality of life by providing funding or equipment to facilitate the provision of recognised evidence-based acupuncture and massage therapies.
- ii. to promote the conservation protection and improvement of the physical and natural environment, in particular but without limitation by planting trees; and
- iii. advancing education of the general public in topics relating to health and wellbeing and environmental conservation.

Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.

1. The charity continued to receive regular monthly donations from dedicated supporters, demonstrating sustained public engagement with the charity's aims. Throughout the financial year, the charity maintained consistent support from regular donors including medical professionals and local businesses, reflecting ongoing commitment to the charity's objectives (i-iii).
2. In August 2024, the charity received multiple donations totaling £1,020 in celebration of the Chair's birthday, demonstrating community support for the charity's mission. These funds will be used to further the charity's aims in supporting terminally ill patients, environmental conservation, and public education in health and wellbeing.
3. In March 2025, the charity received a substantial donation of £2,100 from supporters, which will enable the charity to expand its activities in support of terminally ill patients in hospices and health settings, in line with aim (i) of the charity.
4. The charity made a charitable grant of £1,000 to SS John & Elizabeth in July 2024 to support end-of-life care services, fulfilling aim (i) of the charity by directly benefiting terminally ill patients.


Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.

1. The charity successfully maintained a stable base of regular donors throughout the financial year, with consistent monthly donations totaling £2,880, demonstrating sustained public engagement with the charity's aims of supporting terminally ill patients, environmental conservation, and health education (aims i-iii).
2. A charitable grant of £1,000 was awarded to SS John & Elizabeth Hospice in July 2024, directly supporting the provision of care for terminally ill patients and fulfilling aim (i) of the charity. This grant contributed to improving the quality of life for hospice patients through enhanced care services.
3. The charity received exceptional support from the wider community, with one-off donations totaling £3,909.66 during the year. This included a significant donation of £2,100 in March 2025, reflecting growing awareness and support for the charity's mission among the public.
4. The charity's financial position strengthened considerably during the year, with net income of £9,389.66 enabling the charity to build reserves for future charitable activities. The closing balance of £84,094.87 provides a strong foundation for expanding the charity's work in supporting terminally ill patients, environmental conservation, and public education in the coming year.
5. The charity continued to promote awareness of its objectives through sustained engagement with regular supporters, fulfilling aim (iii) of advancing education in topics relating to health, wellbeing and environmental conservation.

The charity has experienced a strong financial year, with total income of £10,389.66 exceeding total expenditure of £1,000.00, resulting in a net surplus of £9,389.66. This has increased the charity's reserves to £84,094.87, providing a solid foundation for future charitable activities.

The income comprised regular monthly direct debits from Besk Women's Care Ltd (£3,600), consistent monthly donations from three regular supporters (£2,880), and various one-off donations (£3,909.66) including a substantial gift of £2,100 received in March 2025.

The charity made one charitable grant during the year of £1,000 to SS John & Elizabeth Hospice, directly fulfilling the charity's primary aim of relieving terminally ill patients. The Trustees plan to increase charitable giving in the coming financial year, utilizing the accumulated reserves to make a more substantial impact in line with the charity's objectives.


Basis of independent examiner's statement:


