OBJECTIVES AND ACTIVITIES **Objectives, Aims and Public Benefits** **RELIGIOUS ACTIVITIES**

Prayer facilities

Masjid Abu Bakr offers a wide range of regular activities and services to cater for the diverse needs of our community. Being in a prime location for people who are working or shopping in town centre, we aim to keep our doors open for Fajr and then from 9:30 to the last prayer of the day, Esha. Details of services that take place throughout the day are detailed below.

Additionally, we always understand the need to have a member of staff or volunteer on site who can be approached to assist you in your needs. The Masjid can accommodate up to 500 worshippers within its building and when needed utilises the open courtyard space to accommodate additional 200 people.

Five Daily Prayers

Masjid offers 5 daily congregational prayers lead by Maulana Huzaifa and Maulana Mohammed Moreea. The timing of each salah can be found on the yearly calendar, monthly Newsletter, Masjid's Website, Phone app such as My mosque and Masjid Timetable and too can be found displayed in the main hall clock. We provide audio stream of the prayers so that all could still benefit from listening into the service.

Jumuah Prayers

Jumuah being the busiest time of the week, Masjid provides 2 services to accommodate the needs of locals and those who are working or travelling in Walthamstow Central. Masjid courtyard is used to avoid worshippers from Praying on outside footpath. On Average, over 1,000 people attend the Friday afternoon prayer and benefit from English lecture (Bayaan) followed by Khutbah in Arabic and then Salah.

Month Of Ramadan

Ramadan being the most blessed month draws more worshippers than any other month. To benefit the large numbers of people attending during these blessed days, daily Dais lessons were delivered by Imams and special guests to educate people on aspects of Deen and to increase one's Imaan. We were fortunate to have Mufti Abdur Rahman ibn Yusuf Mangera delivering talks throughout Ramadan.

Regular reminders were made to tackle noise issues and all worshippers were advised to avoid parking on Mansfield Road. We aim to work closely with those worshippers and neighbours to resolve the above issue.

Public benefit

The trustees confirmed they have had regard to the Charity Commission's guide on public benefits.

ACHIEVEMENTS AND PERFORMANCE

Charitable activities

Madrasah

This year is a new phase for us due to the curriculum having run its full course. We are at the beginning stages of establishing a teenage syllabus. InshaAllah, we wish to see some fruition not least in terms of young individuals deep diving into advanced Islamic studies and mature teenagers contributing to community roles.

Statistics

We had 300 students by end of July 2024. 63 new students enrolled. 90 students left during or at the end of year.

Student attendance was 84% and punctuality was 96% at the end of 2024 academic year. Exam results overall average was 64%.

Curricula & Staff Updates

A weekend Islamic Diploma course was launched as an opportunity for Madrasah leavers to further their studies in Arabic, Tafseer, Hadeeth, Fiqh and Aqeedah.

A special 'Path to Paradise' Sunday youth scheme for girls was launched for term time.

3-Day classes were extended for all new students joining the youngest classes. This was to ensure that students who are already enrolled get priority to remain in 5-day classes. This also catered for parents' requests to give reduced days to young children whilst they settle in.

Arabic language trial course was replaced with Madinah Arabic reader for a more structured approach. This subject continued for one particular age group of boys and girls.

FINANCIAL REVIEW

Financial position

Total Incoming funds generated in the year were £471,971 (2024: £407,948) whilst total expenditure amounted to £274,981 (2024:£279,592) leaving a surplus of £196,990 (2024: £128,356) in the year.

At the year ended 31st January 2025, reserves carried forward were £2,687,207 (2024: £2,490,217) of which £2,677,666 (2024: £2,468,083) are unrestricted and £9,541 (2024: £22,134) was restricted.

Reserves policy

The charity aims to maintain reserves sufficient to cover six months of expenses which equates to approximately £134,000 (excluding depreciation). Cash at bank and in hand at 31 January 2025 amounted to £144,805, the trustees consider this figure to be below the standard they require and are actively planning to raise the funds.

Governing document

The charity governing document is a CIO foundation model constitution registered with Charity Commission on 17th August 2020.

The charity is controlled by its governing document and constitutes a Charitable Incorporated Organisation (CIO) as defined by Charities Act 2011.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Statutory Information

Masjid Abu Bakr Walthamstow is a charitable incorporated organisation (CIO) registered with Charity Commission in England and Wales. The registered office address can be found at the information page.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Donations are recognised when the charity receives them.

Madrasah fees are recognised on a receivable basis.

Rental income is recognised on receivable basis.

Expenditure and irrecoverable vat

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Irrecoverable VAT is charged against the expenditure heading for which it was incurred.

Tangible fixed assets

Tangible fixed assets are stated at historical cost/ or on a revaluation basis (deemed cost for land and buildings) less accumulated impairment losses. historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is not charged on the deemed value of land.

Depreciation is charged so as to allocate the costs of assets less their residual value over their estimated useful lives, using either a straight line or reducing balance method, as indicated below.

Depreciation is provided on the following basis:

1. ACCOUNTING POLICIES - continued

Tangible fixed assets

Plant and Machinery - 20% Straight Line

The asset's residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Investment property

Investment properties are properties that are held for financial gain, either through rental income or capital appreciation. Investment properties are revalued and are stated at fair value.

Any gains/losses on revaluation are transferred to the Revaluation Reserve.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Going concern

The trustees consider the charity to be able to continue its operations.

The charity has a net current liability as on the balance sheet date. The trustees are confident of continuous support from the community. It is for this reason the accounts have been prepared on going concern basis.

Only with the assistance of Allah, a fantastic opportunity has come about. For this year we have made an agreement to secure the house next door No.26. Having consulted some members of the community we received blessing from them to look to pursue this endeavour. Considering the already existing remaining loans that are outstanding from the previous house project, the management and worshippers still felt that this opportunity not to be missed.

This would be a great milestone in the history of the Masjid, as having purchased a house on Somers Road during Covid with no congregation then to purchase another house next door just a few years after. As this house is right next door, the community has had their eyes set on it from day one of the existence of the Masjid. Having agreed the buying price with the seller and now raising the funds to secure the purchase, we will be looking to have the keys to the property in the coming months.

Our vision is to provide a sister with a dedicate centre, so that the ladies in the community can benefit from the services for the Masjid. This was the initial vision when purchasing the house on Somers Road. However, due to the location in relation to the Masjid and scale of work that would be required, this would have taken some years to accomplish.

I pray that in the next report we will have a functioning Sister's centre, with a booming community evolving the ladies of the community and had made many new connections.

Objectives, Aims and Public Benefits

RELIGIOUS ACTIVITIES

Prayer facilities

Masjid Abu Bakr offers a wide range of regular activities and services to cater for the diverse needs of our community. Being in a prime location for people who are working or shopping in town centre, we aim to keep our doors open for Fajr and then from 9:30 to the last prayer of the day, Esha. Details of services that take place throughout the day are detailed below.

Additionally, we always understand the need to have a member of staff or volunteer on site who can be approached to assist you in your needs. The Masjid can accommodate up to 500 worshippers within its building and when needed utilises the open courtyard space to accommodate additional 200 people.

Five Daily Prayers

Masjid offers 5 daily congregational prayers lead by Maulana Huzaifa and Maulana Mohammed Moreea. The timing of each salah can be found on the yearly calendar, monthly Newsletter, Masjid's Website, Phone app such as and My mosque and Masjid Timetable and too can be found displayed in the main hall clock. We provide audio stream of the prayers so that all could still benefit from listening into the service.

Jumuah Prayers

Jumuah being the busiest time of the week, Masjid provides 2 services to accommodate the needs of locals and those who are working or travelling in Walthamstow Central. Masjid courtyard is used to avoid worshippers from Praying on outside footpath. On Average, over 1,000 people attend the Friday afternoon prayer and benefit from English lecture (Bayaan) followed by Khutbah in Arabic and then Salah.

Month Of Ramadan

Ramadan being the most blessed month draws more worshippers than any other month. To benefit the large numbers of people attending during these blessed days, daily Dais lessons were delivered by Imams and special guests to educate people on aspects of Deen and to increase one's Imaan. We were fortunate to have Mufti Abdur Rahman ibn Yusuf Mangera delivering talks throughout Ramadan.

Regular reminders were made to tackle noise issues and all worshippers were advised to avoid parking on Mansfield Road. We aim to work closely with those worshippers and neighbours to resolve the above issue.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

Madrasah

This year is a new phase for us due to the curriculum having run its full course. We are at the beginning stages of establishing a teenage syllabus. InshaAllah, we wish to see some fruition not least in terms of young individuals deep diving into advanced Islamic studies and mature teenagers contributing to community roles.

Statistics

We had 300 students by end of July 2023. 63 new students enrolled. 54 students left during or at the end of year. Student attendance was 84% and punctuality was 97% at the end of 2023 academic year. Exam results overall average was 69%. 126 pupils (64% of all pupils who sat exam) achieved 65% or more.

Curricula & Staff Updates

A weekend Islamic Diploma course was launched as an opportunity for Madrasah leavers to further their studies in Arabic, Tafseer, Hadeeth, Fiqh and Aqeedah.

A special 'Path to Paradise' Sunday youth scheme for girls was launched for term time.

3-Day classes were extended for all new students joining the youngest classes. This was to ensure that students who are already enrolled get priority to remain in 5-day classes. This also catered for parents' requests to give reduced days to young children whilst they settle in.

Arabic language trial course was replaced with Madinah Arabic reader for a more structured approach. This subject continued for one particular age group of boys and girls.

Events & Activities

Before breaking up for Summer Holidays, pupils conducted various performances in the presence of parents in the end of year Awards Ceremony' such as speeches, recitals, nasheeds, plays, etc.

The Year ended with a Sports' Day in Lloyds Park over 2 separate days for boys and girls. Parents were also invited to attend. Both days were well attended. Teenage Madrasah boys were invited to monthly youth events to enjoy fun activities, listen to speeches on the Hereafter series and take part in meals. 60-80 boys attended most of whom were Madrasah children.

During Summer holidays, we provided:

- Teenage boys were offered the opportunity to enrol in a 'Beginning of Guidance' course covering various topics.:
- Optional Madrasah classes continued to run during summer holidays with a focus of Quran and Salaah. 2 groups/classes of children participated.
- Masjid Abu Bakr collaborated with Madrasatul Haq to take part in an exclusive access to Flip Out Trampoline Park during Summer Holidays for boys and girls separately.
- Masjid Abu Bakr collaborated with Teens Inspired to arrange self-development workshops for teenage boys during summer holidays.
- A morning of Motivation event was held for sisters in October as part of the Path to Paradise scheme. The event included bake sale, henna, talks, presentations, reflection and free lunch.
- A special assembly was held by Madrasah staff on the topic of Palestine. This was followed up with a fundraiser in collaboration with UWT.
- Madrasah liaised with Aida refugee camp in Palestine to give an opportunity for our children to communicate with refugee children in Palestine.
- The first term ended with an activity day involving snacks and games.

- A winter conference was organised for sisters in December holidays as part of the Path to Paradise scheme.
- Approximately 30 boys took part in Fajr Knights winter challenge during December holidays.

FINANCIAL REVIEW

Financial position

Total Incoming funds generated in the year were £407,948 (2023: £303,711) whilst total expenditure amounted to £279,592 (2023:£233,274) leaving a surplus of £128,356 (2023: £70,437) in the year.

At the year ended 31st January 2024, reserves carried forward were £2,490,217 (2023: £2,361,861) of which £2,468,083 (2023: £2,356,825) are unrestricted and £22,134 (2023: £5,036) was restricted.

Financials

Annual Fees Charged between £120 and £588 per pupil for various class types.

- Total Income: £95,465
- Total Expenses: £102,590
- Voluntary contributions: £747 was paid by parents in addition to fees
- Sadaqah funding: £1,389 of Sadaqah income was allocated towards fees for struggling families

Reserves policy

The charity aims to maintain reserves sufficient to cover six months of expenses which equates to approximately £134,000 (excluding depreciation). Cash at bank and in hand at 31 January 2024 amounted to £179,103, the trustees consider this figure to be below the standard they require and are actively planning to raise the funds.

Governing document

The charity governing document is a CIO foundation model constitution registered with Charity Commission on 17th August 2020.

The charity is controlled by its governing document, a deed of trust, and constitutes a Charitable Incorporated Organisation (CIO) as defined by Charities Act 2011.

Recruitment and appointment of new trustees

New trustees can be appointed from the existing paid members of the Trust. Member willing to become trustee shall have to submit the "Trustees Appointment Form" duly filled to the Trust Office which is then considered for voting in the coming meeting of Trustees.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 JANUARY 2024

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Statutory Information

Masjid Abu Bakr Walthamstow is a charitable incorporated organisation (CIO) registered with Charity Commission in England and Wales. The registered office address can be found at the information page.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Donations are recognised when the charity receives them.

Madrasah fees are recognised on a receivable basis.

Rental income is recognised on receivable basis.

Expenditure and irrecoverable vat

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Irrecoverable VAT is charged against the expenditure heading for which it was incurred.

Tangible fixed assets

Tangible fixed assets are stated at historical cost/ or on a revaluation basis (deemed cost for land and buildings) less accumulated impairment losses. historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is not charged on the deemed value of land.

Depreciation is charged so as to allocate the costs of assets less their residual value over their estimated useful lives, using either a straight line or reducing balance method, as indicated below.

Depreciation is provided on the following basis:

Tangible fixed assets

Plant and Machinery - 20% Straight Line

The asset's residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Investment property

Investment properties are properties that are held for financial gain, either through rental income or capital appreciation. Investments properties are revalued and are stated at fair value.

Any gains/losses on revaluation are transferred to the Revaluation Reserve.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Going concern

The trustees consider the charity to be able to continue its operations.

The charity has a net current liability as on the balance sheet date. The trustees are confident of continuous support from the community. It is for this reason the accounts have been prepared on going concern basis.

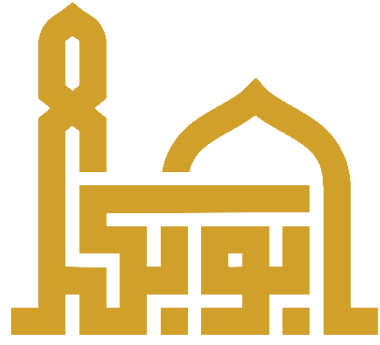

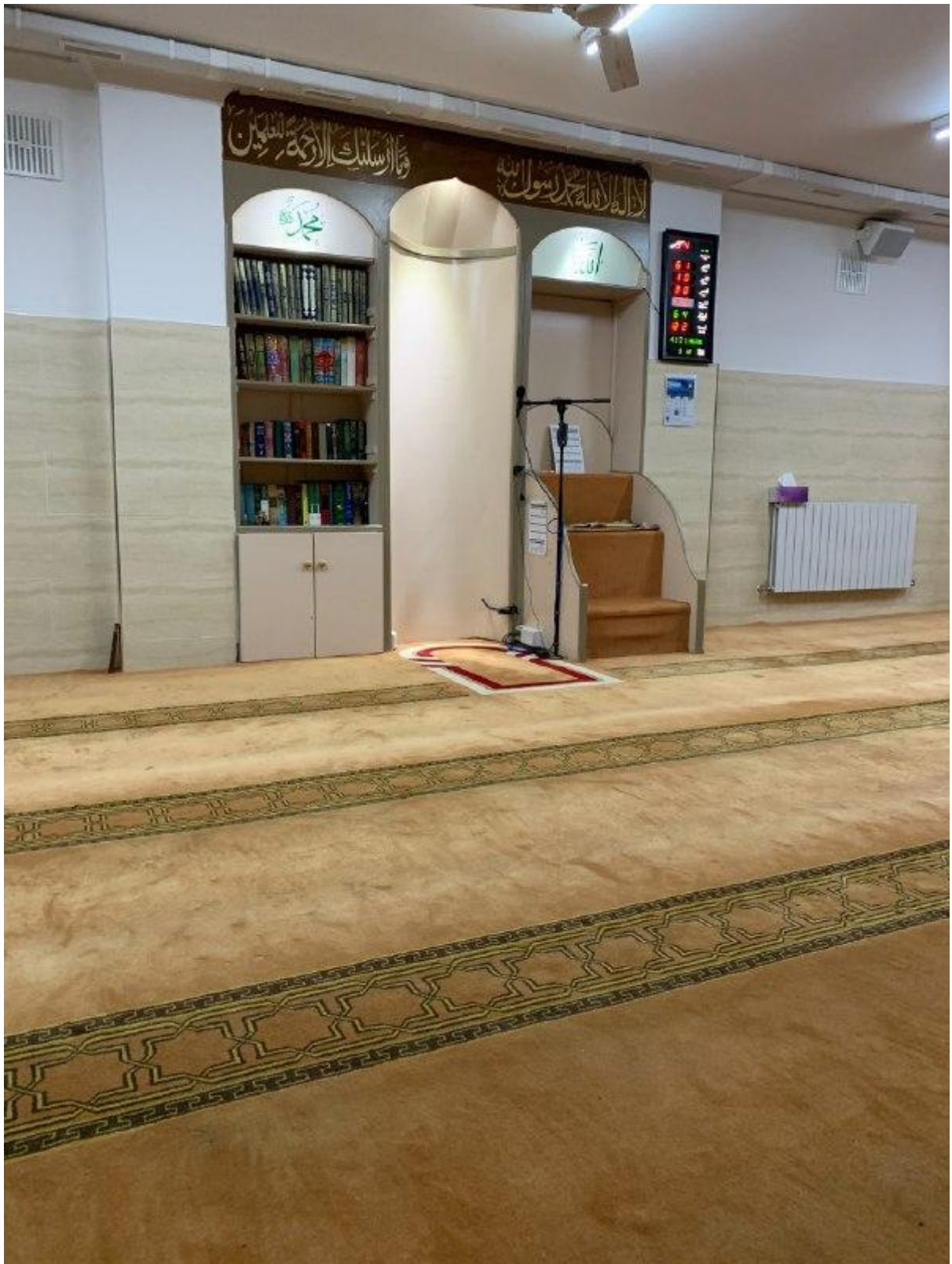
