2022-23 CHAIRMAN'S REPORT TO THE TRUSTEES OF THE NORTH LEEDS LEOPARDS RUGBY LEAGUE CLUB

Whilst there have been and continue to be some unavoidable delays due to planning, weather and illness issues, having our own base will be a significant landmark which is on the horizon.

It will enable us to relaunch the club, enable significant recruitment - not least in attracting more girls - and give us the base we have been crying out for in order for us to fulfil more of our potential.

Completing such a project was always going to be difficult in the current social and economic environment and until the keys are handed over then there is still much to reconcile.

The posts are up, pitch marked out and in use, and a 25-year lease and licence registered. An official opening for our funders and backers is planned, with a community open day to show off the facilities at a later date.

It has not been ideal but there is progress through patience. The trustees of the club are exceptionally grateful for everyone's patience and understanding. Financially, the cost of the building work has been covered by the sponsors and money released in line with completion targets for the build.

We have kept the building fund apart from the day to day running costs and both have been carefully managed.

Every year throws up different triumphs and occasional tribulations, and we have been frustrated that we have only been able to get two age groups regularly playing fixtures whilst four have been in training.

Having our youngsters play in festivals and on the pitch at Headingley at half time have been a real boost for all concerned as has our formal link with neighbouring Carr Manor school.

2024 could be a momentous year in the life of the Leopards, not least when we are fully ensconced in our own space. The possibilities are limitless and opportunities immense.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE NORTH LEEDS LEOPARDS RUGBY LEAGUE CLUB

Independent examiner's statement


In connection with my examination, no matter has come to my attention;
