TRUSTEES' REPORT
FOR THE YEAR ENDED 31ST DECEMBER 2024

The Trustees, who are directors for the purposes of company law, present the annual report together with the financial statements of the charitable company for the year to 31st December 2024.

Charity Set Up

Weymouth Foodbank was registered as a separate charity on 21st August 2020. The Foodbank was originally established in 2012 and operated from that time under the responsibility of Weymouth Baptist Church. Once the separate charity was registered, responsibility passed to the Trustees. Weymouth Baptist Church continued to account for the finance while the new charity set up bank accounts. On 27th October 2020, the Foodbank funds held by Weymouth Baptist Church were transferred into the charity.

Objects and Public Benefit

The charity was established with the following objects clause:

“The prevention or relief of poverty or financial hardship. In particular, but not exclusively in Weymouth and surrounding area, based on Christian principles by:

- a) Providing emergency food to individuals and families in need and/or for distribution by charities or other organisations working to prevent or relieve poverty or financial hardship.

- b) Such other means, including (but not limited to) the provision of support or signposting to relevant information and other advisory services.”

We are a Christian organisation motivated by the love and teaching of Jesus. We operate according to Biblical principles of compassion, honesty, integrity, openness, kindness and care for all people, regardless of background or belief. We believe that everyone has a basic right to have food on their plate, dignity and a hope for the future.

Weymouth is a needy town with areas of deprivation. There are many that go hungry through loss of income or an unexpected bill when on low income. Weymouth Foodbank provides a minimum of three days' emergency food in the form of a food parcel. We also provide support and signposting to other agencies to help with any underlying issues.

We have seen the level of use of the Foodbank increase significantly over the last few years. The cost-of-living crisis has been widely reported on and has significantly impacted Weymouth Foodbank. As well as helping those in temporary need of help because of an unexpected event, we are finding people are needing help on a longer-term basis. Many of our clients are on benefits, which have not kept pace with rises in the cost of living. We are seeing many new clients who have never visited a Foodbank before, including a number who are in work. As the numbers below show, in 2024 we have seen a slight decrease in our referral numbers, but they remain at a very high level and we are still feeding more than 250 people every week.

In 2024 we had 6,855 referrals (2023: 7,148) comprising 2,004 families, 1,517 couples and 3,334 singles. This is a decrease of 4% over last year following a 57% increase in 2023 and a 68% increase in 2022. In total we helped 10,548 (2023: 10,973) adults and 3,210 (2023: 3,183) children. This equates to the provision of about 124,000 meals.

When planning the activities for the period, the Trustees believe that they have complied with the duty set out in section 4 of the Charities Act 2011 to have due regard for Public Benefit.

Activities

The overall aims and focus of Weymouth Foodbank remain unchanged in the year.

We distribute food out of three premises (we call them satellites):

- i) - Weymouth Baptist Church – open Tuesday and Friday mornings.
- ii) - Westham Methodist Church - open Monday morning and
- iii) - St Francis Littlemoor - open Wednesday morning.

We believe that being open on 4 mornings at locations local to clients, has made us more accessible.

We have also benefitted from the provision by a local company of a rent-free warehouse (we call it the hub). In February 2024 we moved out of our old warehouse as this was due for demolition and moved into a much-improved warehouse. This was again supplied rent free by the same company. All food donated by individuals and corporates is sent to the hub for checking and storing. Food is supplied to the three satellites from here. The warehouse has allowed us to store and rotate the increased level of food donated in a safe and orderly way. It has also allowed us to take delivery of bulk orders from suppliers to top up the donated food.

We rely totally on a team of around 90 volunteers as we have no paid staff. These come primarily from the churches in Weymouth.

We work closely with other agencies including Citizens Advice, The Lantern, First Point and Christians Against Poverty. These, and many other agencies refer their clients to us to receive food parcels. Where appropriate we refer our clients on to them to receive the specialist help that they need to improve their situation.

Financial Review

The results for the year are shown in the attached financial statements. Income for the year totalled £130,123 (2023: £119,669). The increase in income is largely explained by Council grants, mainly Household Support Grant. We were also successful in generating additional grants from other grant giving bodies. A one-off gift of £10,000 was received in 2023 in advance of a planned warehouse, which was spent in the year. Donations by individuals through our website remained encouraging. We are grateful for a group of people that donate regularly to support the work. We feel that the community and churches of Weymouth have really got behind us.

Expenditure in the year totalled £122,278 (2023 £142,771). The decrease in spend was largely due to a £28,008 reduction in spend on food that we need to buy to supplement food donations. This was partly because of a small reduction in the number of referrals plus a focus by the trustees to ensure that we just provide food that is really needed. Our underlying running costs remain very low as planned. We want as much of our donated money as possible to be used to purchase food to feed hungry people. We spent £10,304 to make our new warehouse fit for purpose, but this was funded by specific one-off gifts to cover this.

The excess of income over expenditure in 2024 amounted to £7,845 which was added to accumulated reserves. Our cash reserves of £70,111 are sufficient to meet our expected needs in the medium term.

Structure, Governance and Management

Governing Document

The charity was established using the Foundation Model constitution, as provided by the Charity Commission, for Charitable Incorporated Organisation whose only voting members are its charity trustees. These were adopted by the trustees on 21st August 2020.

Recruitment and Appointment of Trustees

Trustees have responsibility to manage the financial, legal and administration of the charities' assets and funds. Trustees are selected and appointed by existing trustees. On 10th January 2024 Ruth Peers resigned as a trustee. Subsequently Helen Cross was appointed in her place on 16th April 2024.

Internal Control and Risk Management

The systems of internal control are designed to provide reasonable but not absolute assurance against material misstatement or loss. The Trustees approve the annual budget and monitor performance against it. Risks are identified and managed. Suitable accounting policies are selected and applied. No significant judgements or estimates have been identified.

The Trustees are responsible for maintaining proper accounting records which disclose with accuracy at any time the financial position of the charity. This includes ensuring they are prepared in compliance with applicable accounting standards and on a going concern basis.

A full risk management exercise was carried out on set up of the charity and at the time the warehouse was acquired. This covered major strategic, operational and financial risk to which Weymouth Foodbank is exposed. Systems and actions were established to mitigate the risks. This has been reviewed in the year and will continue to be reviewed at least annually.

During 2024 we had a thorough review of our Safeguarding procedures, resulting in the appointment of a new safeguarding Officer, updating our policies and procedures and an increased focus on training.

The Trustees believe that internal controls conform to guidelines issued by the Charity Commission.

Trustees' Responsibilities


The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable Law and the Generally Accepted Accounting Principles (GAAP) including Financial Reporting Standard 102: The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

The Charities Act 2011 require the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the CIO and of the surplus or deficit of the CIO for that period. In preparing those financial statements the trustees are required to:

- Select suitable accounting policies and apply them consistently.
- Observe the methods and principles in the Charities SORP.
- Make judgements and estimates that are reasonable and prudent
- State whether applicable UK Accounting Standards have been followed subject to any material departures disclosed and explained in the financial statements.
- Prepare financial statements on the going concern basis unless it is inappropriate to presume that the CIO will continue in existence.

The trustees are responsible for keeping sufficient accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the Governing Document. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.



1. ACCOUNTING POLICIES

Basis of Preparation & Assessment of Going Concern

Basis of Preparation

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (SORP 2015) (Second Edition, effective 1st January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and the Charities Act 2011.

The Charity meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost unless otherwise stated in the relevant accounting policy notes.

Assessment of Going Concern

Preparation of the accounts is on a going concern basis. The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Incoming Resources

Recognition of Incoming Resources

These are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain they will receive the resources; and
- the monetary value can be measured with sufficient reliability

Incoming Resources with Related Expenditure

Where incoming resources have related expenditure (as with fundraising or contract income) the incoming resource and related expenditure are reported gross in the SOFA.

Grants and Donations

Grants and Donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Tax Reclaims on Donations and Gifts

Incoming resources from tax reclaims are included in the SOFA at the same time as the gift to which they relate.

Contractual Income and Performance Related Grants

This is only included in the SOFA once the related goods or services have been delivered.

Gifts in Kind

Gifts in kind are accounted for at a reasonable estimate of their value to the charity or the amount actually realised. Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity. Gifts in kind for use by the charity are included in the SOFA as incoming resources when receivable. Perishable and non perishable food items donated to the Charity for onward distribution to beneficiaries are not valued in the Statement of Financial Activity.

Donated Services and Facilities

These are only included in incoming resources (with an equivalent amount in resources expended) where the benefit to the charity is reasonably quantifiable, measurable and material. The value placed on these resources is the estimated value to the charity of the service or facility received.

Volunteer Help

The value of any voluntary help received is not included in the accounts.

Investment Income

This is included in the accounts when receivable.

Investment Gains and Losses

This included any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

1. ACCOUNTING POLICIES (continued)

Expenditure and Liabilities

Liability Recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Governance Costs

Include costs of the preparation and examination of statutory accounts, the costs of the trustees meetings and cost of any legal advice to trustees on governance or constitutional matters.

Grants with Performance Conditions

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SOFA once the recipient of the grant has provided the specified service or output.

Grants Payable without Performance Conditions

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to a grant which remain in control of the charity.

Investments

Investments quoted on a recognised stock exchange are valued at market value at the year end. Other investment assets are included at trustees' best estimate of market value.

Unrestricted funds

These funds can be used for the general objectives of the charity as set out in the trustees report. The movements of the unrestricted funds are given in the Statement of Financial Activities.

Restricted funds

These funds are where the donor has specified a purpose for the donation made. These restrictions often arise as a result of appeals for special offerings for specific purposes.

Designated funds

These funds are funds set aside by the trustees out of unrestricted general funds for particular purposes or projects.

Fixed Assets

Fixed Assets are capitalised if they can be used for more than one year and cost at least £1,500. They are valued at cost or, if gifted, at the value to the charity on receipt.

Depreciation Expense

Depreciation is calculated at a rate to write off the cost of tangible fixed assets over their estimated useful lives. The rates applied are as follows:

12. STAFF COSTS AND NUMBERS

The Charity employed no members of staff during this or the previous financial year.

13. TRUSTEES AND OTHER RELATED PARTIES

The only payments made to the Trustees consisted of reimbursements of expenses incurred in furthering the Charity's objects and no direct benefits were received by the Trustees during this or the previous financial year.

No other payments were made to trustees or any persons connected with them during this financial period. No material transaction took place between the organisation and a trustee or any person connected with them.

14. RISK ASSESSMENT

The Trustees actively review the major risks which the charity faces on a regular basis and believe that maintaining the free reserves stated, combined with the annual review of the controls over key financial systems carried out on an annual basis will provide sufficient resources in the event of adverse conditions. The Trustees have also examined other operational and business risks which they face and confirm that they have established systems to mitigate the significant risks.

15. RESERVES POLICY

The Trustees have considered the level of reserves they wish to retain, appropriate to the CIO's needs. This is based on the CIO's size and the level of financial commitments held. The Trustees aim to ensure the CIO will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in income or unexpected expenditure. The Trustees will endeavour not to set aside funds unnecessarily.

16. PUBLIC BENEFIT

The CIO acknowledges its requirement to demonstrate clearly that it must have charitable purposes or 'aims' that are for the public benefit. TRUSTEES' REPORT
FOR THE YEAR ENDED 31ST DECEMBER 2023

The Trustees present the annual report together with the financial statements of the Charitable Incorporated Organisation for the year ended to 31st December 2023.

Charity Set Up

Weymouth Foodbank was registered as a separate charity on 21st August 2020. The Foodbank was originally established in 2012 and operated from that time under the responsibility of Weymouth Baptist Church. Once the separate charity was registered, responsibility passed to the Trustee body. On 27th October 2020, the Foodbank funds held by Weymouth Baptist Church were transferred into the Charity.

Objects and Public Benefit

The charity was established with the following objects clause:

“The prevention or relief of poverty or financial hardship. In particular, but not exclusively in Weymouth and surrounding area, based on Christian principles by:

- a) Providing emergency food to individuals and families in need and/or for distribution by charities or other organisations working to prevent or relieve poverty or financial hardship.
- b) Such other means, including (but not limited to) the provision of support or signposting to relevant information and other advisory services.”

We are a Christian organisation motivated by the love and teaching of Jesus. We started to meet the specific call to “Feed my sheep”. We operate according to Biblical principles of compassion, honesty, integrity, openness, kindness and care for all people, regardless of background or belief. We believe that everyone has a basic right to have food on their plate, dignity and a hope for the future.

Weymouth is a needy town with areas of deprivation. There are many that go hungry through loss of income or an unexpected bills when on low income. Weymouth Foodbank provides a minimum of three days' emergency food in the form of a food parcel. We also provide support and signposting to other agencies to help with any underlying issues.

We have seen the level of use of the Foodbank increase significantly over last year. The cost-of-living crisis has been widely reported on and has significantly impacted Weymouth Foodbank. As well as helping those in temporary need of help because of an unexpected event, we are finding people are needing help on a longer term basis. Many of our clients are on benefits, which have not kept pace with rises in the cost of living. We are seeing many new clients who have never visited a Foodbank before, including a number who are in work.

In 2023 we had 7,148 referrals (2022: 4,547) comprising 2,106 families, 1,425 couples and 3,617 singles. This is an increase of 57% over last year following a 68,% increase in the previous year. In total we helped 10,973 (2022: 6,790) adults and 3,183 (2022: 2,276) children. This equates to the provision of more than 127,000 meals.

When planning the activities for the period, the Trustees believe that they have complied with the duty set out in section 4 of the Charities Act 2011 to have due regard for Public Benefit.

Activities

The overall aims and focus of Weymouth Foodbank remain unchanged in the year.

We distribute food out of three premises (we call them satellites):

- i) - Weymouth Baptist Church – open Tuesday and Friday mornings.
- ii) - Westham Methodist Church - open Monday morning and
- iii) - St Francis Littlemoor - open Wednesday morning.

We believe that being open on 4 mornings at locations local to clients, has made us more accessible.

We have also benefitted from the provision by a local company of a rent-free warehouse (we call it the hub). All food donated by individuals and corporates is sent to the hub for checking and storing. Food is supplied to the three satellites from here. The warehouse has allowed us to store and rotate the increased level of food donated in a safe and orderly way. It has also allowed us to take delivery of bulk orders from suppliers to top up the donated food.

We rely totally on a team of around 100 volunteers as we have no paid staff. These come primarily from the churches in Weymouth.

We work closely with other agencies including Citizens Advice, The Lantern, First Point and Christians Against Poverty. These, and many other agencies refer their clients to us to receive food parcels. Where appropriate we refer our clients on to them to receive the specialist help that they need to improve their situation.

Subsequent to the year end, the local company that had provided us with the rent free warehouse provided us with an improved warehouse, again rent free.

Financial Review

The results for the year are shown in the attached financial statements. Income for the year totalled £119,583 (2022: £103,805). The increase in income comprises a number of ups and downs. Additional income came in 2023 from Council grants, mainly Household Support Grant. A one-off gift of £10,000 was received in 2023 in advance of a planned warehouse move that happened after the year end. Increased gift aid was claimed in 2023. Amounts received from local companies fell compared with 2022, mainly because at the start of the cost of living crisis in 2022 there were a number of companies that responded to the need. Donations by individuals through our website remained encouraging, in particular in the period just prior to Christmas. We are grateful for a group of people that donate regularly to support the work. We feel that the community and churches of Weymouth have really got behind us.

Expenditure in the year totalled £142,685 (2022 £68,840). Almost all of the increase in spend was used to buy food to supplement the food donations, which we use to feed our clients. Food donations to us have not increased sufficiently to meet the increased demand for our services, so we have used the cash grants and donations to buy the food required. Our underlying running costs remain very low as planned. We want as much of our donated money as possible to be used to purchase food to feed hungry people.

The excess of expenditure over income in 2023 amounted to £23,102 which was funded out of accumulated reserves. Our cash reserves of £62,266 are sufficient to meet our expected needs in the medium term.

Structure, Governance and Management

Governing Document

The charity was established using the Foundation Model constitution, as provided by the Charity Commission, for Charitable Incorporated Organisation whose only voting members are its charity trustees. These were adopted by the trustees on 21 August 2020.

Recruitment and Appointment of Trustees

Trustees have responsibility to manage the financial, legal and administration of the charities' assets and funds. Trustees are selected and appointed by existing trustees. On 31st October 2023 Ann Hampton resigned as a trustee. Subsequent to the year end on 10th January 2024, Julia Clarke resigned as a trustee.

Internal Control and Risk Management

The systems of internal control are designed to provide reasonable but not absolute assurance against material misstatement or loss. The Trustees approve the annual budget and monitor performance against it. Risks are identified and managed. Suitable accounting policies are selected and applied. No significant judgements or estimates have been identified.

The Trustees are responsible for maintaining proper accounting records which disclose with accuracy at any time the financial position of the charity. This includes ensuring they are prepared in compliance with applicable accounting standards and on a going concern basis.

A full risk management exercise was carried out on set up of the charity and at the time the warehouse was acquired. This covered major strategic, operational and financial risk to which Weymouth Foodbank is exposed. Systems and actions were established to mitigate the risks. This will be reviewed at least annually.

The Trustees believe that internal controls conform to guidelines issued by the Charity Commission.

Trustees' Responsibilities

The trustees are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable Law and the Generally Accepted Accounting Principles (GAAP) including Financial Reporting Standard 102: The Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

The Charities Act 2011 require the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the CIO and of the surplus or deficit of the CIO for that period. In preparing those financial statements the trustees are required to:

- Select suitable accounting policies and apply them consistently.

1. ACCOUNTING POLICIES

Basis of Preparation & Assessment of Going Concern

Basis of Preparation

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities (SORP 2015) (Second Edition, effective 1st January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and the Charities Act 2011.

The Charity meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost unless otherwise stated in the relevant accounting policy notes.

Assessment of Going Concern

Preparation of the accounts is on a going concern basis. The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Incoming Resources

Recognition of Incoming Resources

These are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain they will receive the resources; and
- the monetary value can be measured with sufficient reliability

Incoming Resources with Related Expenditure

Where incoming resources have related expenditure (as with fundraising or contract income) the incoming resource and related expenditure are reported gross in the SOFA.

Grants and Donations

Grants and Donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Tax Reclaims on Donations and Gifts

Incoming resources from tax reclaims are included in the SOFA at the same time as the gift to which they relate.

Contractual Income and Performance Related Grants

This is only included in the SOFA once the related goods or services have been delivered.

Gifts in Kind

Gifts in kind are accounted for at a reasonable estimate of their value to the charity or the amount actually realised. Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity. Gifts in kind for use by the charity are included in the SOFA as incoming resources when receivable. Perishable and non perishable food items donated to the Charity for onward distribution to beneficiaries are not valued in the Statement of Financial Activity.

Donated Services and Facilities

These are only included in incoming resources (with an equivalent amount in resources expended) where the benefit to the charity is reasonably quantifiable, measurable and material. The value placed on these resources is the estimated value to the charity of the service or facility received.

Volunteer Help

The value of any voluntary help received is not included in the accounts.

Investment Income

This is included in the accounts when receivable.

Investment Gains and Losses

This included any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

Expenditure and Liabilities

Liability Recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Governance Costs

Include costs of the preparation and examination of statutory accounts, the costs of the trustees meetings and cost of any legal advice to trustees on governance or constitutional matters.

Grants with Performance Conditions

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SOFA once the recipient of the grant has provided the specified service or output.

Grants Payable without Performance Conditions

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to a grant which remain in control of the charity.

Investments

Investments quoted on a recognised stock exchange are valued at market value at the year end. Other investment assets are included at trustees' best estimate of market value.

Unrestricted funds

These funds can be used for the general objectives of the charity as set out in the trustees report. The movements of the unrestricted funds are given in the Statement of Financial Activities.

Restricted funds

These funds are where the donor has specified a purpose for the donation made. These restrictions often arise as a result of appeals for special offerings for specific purposes.

Designated funds

These funds are funds set aside by the trustees out of unrestricted general funds for particular purposes or projects.

Fixed Assets

Fixed Assets are capitalised if they can be used for more than one year and cost at least £1,500. They are valued at cost or, if gifted, at the value to the charity on receipt.

Depreciation Expense

Depreciation is calculated at a rate to write off the cost of tangible fixed assets over their estimated useful lives. The rates applied are as follows:

TRUSTEES' REPORT
FOR THE YEAR ENDED 31ST DECEMBER 2022

The Trustees, who are directors for the purposes of company law, present the annual report together with the financial statements of the charitable company for the year to 31 December 2022. The comparative information deals with the 16 month period from registration (21 August 2020) to 31 December 2021.

Charity Set Up

Weymouth Foodbank was registered as a separate charity on 21 August 2020. The Foodbank was originally established in 2012 and operated from that time under the responsibility of Weymouth Baptist Church. Once the separate charity was registered, responsibility passed to the Trustees. Weymouth Baptist Church continued to account for the finance while the new charity set up bank accounts. On 27 October 2020, the Foodbank funds held by Weymouth Baptist Church were transferred into the Charity.

Objects and Public Benefit

The charity was established with the following objects clause:

"The prevention or relief of poverty or financial hardship. In particular, but not exclusively in Weymouth and surrounding area, based on Christian principles by:

- a) Providing emergency food to individuals and families in need and/or for distribution by charities or other organisations working to prevent or relieve poverty or financial hardship.
- b) Such other means, including (but not limited to) the provision of support or signposting to relevant information and other advisory services."

We are a Christian organisation motivated by the love and teaching of Jesus. We started to meet the specific call to "Feed my sheep". We operate according to Biblical principles of compassion, honesty, integrity, openness, kindness and care for all people, regardless of background or belief. We believe that everyone has a basic right to have food on their plate, dignity and a hope for the future.

Weymouth is a needy town with areas of deprivation. There are many that go hungry through loss of income or an unexpected bill when on low income. Weymouth Foodbank provides a minimum of three days' emergency food in the form of a food parcel. We also provide support and signposting to other agencies to help with any underlying issues.

We have seen the level of use of the Foodbank increase significantly over last year. The cost-of-living crisis has been widely reported on and has significantly impacted Weymouth Foodbank. As well as helping those in temporary need of help because of an unexpected event, we are finding people are needing help on a longer term basis. Many of our clients are on benefits, which have not kept pace with rises in the cost of living. We are seeing many new clients who have never visited a Foodbank before, including a number who are in work.

In 2022 we had 4,547 referrals (2021: 2,712) comprising 1318 families, 829 couples and 2,400 singles. This is an increase of 68% over last year. In total we helped 6,790 (2021: 3,855) adults and 2,276 (2021: 1,524) children. This equates to the provision of more than 80,000 meals.

When planning the activities for the period, the Trustees believe that they have complied with the duty set out in section 4 of the Charities Act 2011 to have due regard for Public Benefit.

Activities

The overall aims and focus of Weymouth Foodbank remain unchanged in the year.

We distribute food out of three premises (we call them satellites):

- i) - Weymouth Baptist Church – open Tuesday and Friday mornings.
- ii) - Westham Methodist Church - open Monday morning and
- iii) - St Francis Littlemoor - open Wednesday morning.

We believe that being open on 4 mornings at locations local to clients, has made us more accessible.

We have also benefitted from the provision by a local company of a rent-free warehouse (we call it the hub). All food donated by individuals and corporates is sent to the hub for checking and storing. Food is supplied to the three satellites from here. The warehouse has allowed us to store and rotate the increased level of food donated in a safe and orderly way. It allowed us to work in a socially distanced way during the Covid pandemic. It has also allowed us to take delivery of bulk orders from suppliers to top up the donated food.

We rely totally on a team of around 90 volunteers as we have no paid staff. These come primarily from the churches in Weymouth.

We work closely with other agencies including Citizens Advice, The Lantern, First Point and Christians Against Poverty. These, and many other agencies refer their clients to us to receive food parcels. Where appropriate we refer our clients on to them to receive the specialist help that they need to improve their situation.

Financial Review

The results for the year are shown in the attached financial statements. Income for the year totalled £103,805. The income from the 16 month period from incorporation to 31 December 2021 was £93,531, but this included £46,041 in respect of the accumulated reserves which were transferred in. The underlying rate of increase is therefore very significant. We are grateful for a group of people that donate regularly to support the work. Significant additional income came in 2022 from Council grants, mainly Household Support Grant. Amounts received from local companies and organisations and from individuals through our website were so encouraging, in particular in the period just prior to Christmas. We feel that the community and churches of Weymouth have really got behind us.

Expenditure in the year totalled £68,840 (16 month period to 31 December 2021 £43,128). As we planned, the vast majority of the spend was directly for food that we donate to our clients. Food donations to us have not increased sufficiently to meet the increased demand for our services, but we have funds to buy the food required.

Our cash reserves of £85,368 are sufficient to meet our expected needs in the medium term.

Structure, Governance and Management

Governing Document

The charity was established using the Foundation Model constitution, as provided by the Charity Commission, for Charitable Incorporated Organisation whose only voting members are its charity trustees. These were adopted by the trustees on 21 August 2020.

Recruitment and Appointment of Trustees

Trustees have responsibility to manage the financial, legal and administration of the charities' assets and funds. Trustees are selected and appointed by existing trustees. On 26 January 2022, Andy White was appointed a trustee. On 1 July 2022, Janet Amey resigned as trustee. On 17 November 2022, Jacqui Trent was appointed as trustee.

Internal control and Risk Management

The systems of internal control are designed to provide reasonable but not absolute assurance against material misstatement or loss. The Trustees approve the annual budget and monitor performance against it. Risks are identified and managed. Suitable accounting policies are selected and applied. No significant judgements or estimates have been identified.

The Trustees are responsible for maintaining proper accounting records which disclose with accuracy at any time the financial position of the charity. This includes ensuring they are prepared in compliance with applicable accounting standards and on a going concern basis.

A full risk management exercise was carried out on set up of the charity and at the time the warehouse was required. This covered major strategic, operational and financial risk to which Weymouth Foodbank is exposed. This also included an assessment of the risks identified through Covid. Systems and actions were established to mitigate the risks. This will be reviewed at least annually.

The Trustees believe that internal controls conform to guidelines issued by the Charity Commission.

1. ACCOUNTING POLICIES

Basis of Preparation & Assessment of Going Concern

Basis of Preparation

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015) - (Charities SORP - FRS102) and the Charities Act 2011.

The Charity meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost unless otherwise stated in the relevant accounting policy notes.

Assessment of Going Concern

Preparation of the accounts is on a going concern basis. The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Incoming Resources

Recognition of Incoming Resources

These are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain they will receive the resources; and
- the monetary value can be measured with sufficient reliability

Incoming Resources with Related Expenditure

Where incoming resources have related expenditure (as with fundraising or contract income) the incoming resource and related expenditure are reported gross in the SOFA.

Grants and Donations

Grants and Donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Tax Reclaims on Donations and Gifts

Incoming resources from tax reclaims are included in the SOFA at the same time as the gift to which they relate.

Contractual Income and Performance Related Grants

This is only included in the SOFA once the related goods or services have been delivered.

Gifts in Kind

Gifts in kind are accounted for at a reasonable estimate of their value to the charity or the amount actually realised. Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity. Gifts in kind for use by the charity are included in the SOFA as incoming resources when receivable. Perishable and non perishable food items donated to the Charity for onward distribution to beneficiaries are not valued in the Statement of Financial Activity.

Donated Services and Facilities

These are only included in incoming resources (with an equivalent amount in resources expended) where the benefit to the charity is reasonably quantifiable, measurable and material. The value placed on these resources is the estimated value to the charity of the service or facility received.

Volunteer Help

The value of any voluntary help received is not included in the accounts.

Investment Income

This is included in the accounts when receivable.

Investment Gains and Losses

This included any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

1. ACCOUNTING POLICIES (continued)

Expenditure and Liabilities

Liability Recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Governance Costs

Include costs of the preparation and examination of statutory accounts, the costs of the trustees meetings and cost of any legal advice to trustees on governance or constitutional matters.

Grants with Performance Conditions

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SOFA once the recipient of the grant has provided the specified service or output.

Grants Payable without Performance Conditions

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to a grant which remain in control of the charity.

Investments

Investments quoted on a recognised stock exchange are valued at market value at the year end. Other investment assets are included at trustees' best estimate of market value.

Unrestricted funds

These funds can be used for the general objectives of the charity as set out in the trustees report. The movements of the unrestricted funds are given in the Statement of Financial Activities.

Restricted funds

These funds are where the donor has specified a purpose for the donation made. These restrictions often arise as a result of appeals for special offerings for specific purposes.

Designated funds

These funds are funds set aside by the trustees out of unrestricted general funds for particular purposes or projects.

Fixed Assets

Fixed Assets are capitalised if they can be used for more than one year and cost at least £1,500. They are valued at cost or, if gifted, at the value to the charity on receipt.

Depreciation Expense

Depreciation is calculated at a rate to write off the cost of tangible fixed assets over their estimated useful lives. The rates applied are as follows:

TRUSTEES' REPORT
FOR THE FIRST PERIOD ENDED 31ST DECEMBER 2021

The Trustees, who are directors for the purposes of company law, present the annual report together with the financial statements of the Charitable Incorporated Organisation for the period from registration on the 21st August 2020 to the 31st December 2021.

Charity Set Up

Weymouth Foodbank was registered as a separate charity on 21 August 2020. The Foodbank was originally established in 2012 and operated from that time under the responsibility of Weymouth Baptist Church. Once the separate charity was registered, responsibility passed to the Trustees. Weymouth Baptist Church continued to account for the finance while the new charity set up bank accounts. On 27 October 2020, the Foodbank funds held by Weymouth Baptist Church were transferred into the charity. As a result, these financial statements cover the transfer of funds into the charity on 27 October 2020 and the transactions since then.

Objects and Public Benefit

The charity was established with the following objects clause:

"The prevention or relief of poverty or financial hardship. In particular, but not exclusively in Weymouth and surrounding area, based on Christian principles by:

a) Providing emergency food to individuals and families in need and/or for distribution by charities or other organisations working to prevent or relieve poverty or financial hardship.

b) Such other means, including (but not limited to) the provision of support or signposting to relevant information and other advisory services."

We are a Christian organisation motivated by the love and teaching of Jesus. We started to meet the specific call to "Feed my sheep". We operate according to Biblical principles of compassion, honesty, integrity, openness, kindness and care for all people, regardless of background or belief. We believe that everyone has a basic right to have food on their plate, dignity and a hope for the future.

Weymouth is a needy town with areas of deprivation. There are many that go hungry through loss of income or an unexpected bill when on low income. Weymouth Foodbank provides a minimum of three days' emergency food in the form of a food parcel. We also provide support and signposting to other agencies to help with any underlying issues. We have seen the level of use of the Foodbank increase significantly over last year, partly as a result of the impact of Covid, but also through the impact of the change in the way we operate as explained below.

In 2021 we had 2,712 referrals comprising 790 families, 489 couples and 1,433 singles. In total we helped 3,855 adults and 1,524 children. This equates to the provision of almost 50,000 meals.

When planning the activities for the period, the Trustees believe that they have complied with the duty set out in section 4 of the Charities Act 2011 to have due regard for Public Benefit.

Activities

Although the overall aims and focus of Weymouth Foodbank has remained unchanged in the last year, the way we operate has changed significantly. The set up of the new charity and transfer of responsibilities and funds has been explained above.

Previously we operated out of just one premises, Weymouth Baptist Church, with this being open on Tuesday and Friday mornings. We now have two further outlets (we call satellites) for distribution of food to clients. Westham Methodist Church is open on Monday morning and St Francis Littlemoor on Wednesday morning. We believe that the increased opening times and locations local to clients, has made us more accessible.

We have also benefitted from the provision by a local company of a rent-free warehouse (we call it the hub). All food donated by individuals and corporates is sent to the hub for checking and storing. Food is supplied to the three satellites from here. The warehouse has made a huge difference to our ability to operate. It has allowed us to store and rotate the increased level of food donated in a safe and orderly way. It has allowed us to work in a socially distanced way during this Covid pandemic.

We rely totally on a team of around 50 volunteers as we have no paid staff. These come primarily from the churches in Weymouth. Many of our regular volunteers are in the 60+ age range and so had to step back from involvement because of Covid. We were so encouraged to see other volunteers step up so that the work could continue uninterrupted. All of our processes have been reviewed and changed to ensure that we fully complied with Government guidance on operating in as safe a way as possible during this pandemic.

We work closely with other agencies including Citizens Advice, The Lantern, First Point and Christians Against Poverty. These, and many other agencies refer their clients to us to receive food parcels. Where appropriate we refer our clients on to them to receive the specialist help that they need to improve their situation.

Financial Review

The results for the year are shown in the attached financial statements. Income for the period totalled £47,489. The CIO also received £46,041 related to the transfer in from Weymouth Baptist Church, representing the historic accumulated surplus. The majority of the regular income in the period came from individual donations.

Expenditure in the year totalled £43,127. The set-up of the warehouse and new IT equipment to allow the hub and satellite systems to operate amounted to £5,632. A donation of £4,500 was made, effectively from the balance transferred in, to Weymouth Baptist Church in recognition of all of the cost they have incurred over the years in providing the Foodbank with free accommodation. The balance of expenditure relates to regular costs of buying food and running the charity.

Structure, Governance and Management

Governing Document

The charity was established using the Foundation Model constitution, as provided by the Charity Commission, for Charitable Incorporated Organisation whose only voting members are its charity trustees. These were adopted by the trustees on 21 August 2020.

Recruitment and Appointment of Trustees

The original 3 trustees, JP Dervley (Chairman), Helen Miller (Treasurer) and Amanda Dervley (Secretary) were appointed at the inception of the company for 4 years, 3 years and 2 years respectively. The differing terms are to provide continuity. Trustees have responsibility to manage the financial, legal and administration of the charities' assets and funds. Trustees are selected and appointed by existing trustees. During the transition period 3 additional Trustees were appointed on 4 November 2020 for one year, Ann Hampton, Genny Burchill and Brenda Woodsford. A further 3 trustees were appointed on 13 December 2020 representing the satellites, Ruth Peers and Janet Amey, and Refresh, Cherry Clarke all for a term of 3 years. In November 2021, Ann Hampton agreed to serve a further year.

Internal control and risk management

The systems of internal control are designed to provide reasonable but not absolute assurance against material misstatement or loss. The Trustees approve the annual budget and monitor performance against it. Risks are identified and managed. Suitable accounting policies are selected and applied. No significant judgements or estimates have been identified.

The Trustees are responsible for maintaining proper accounting records which disclose with accuracy at any time the financial position of the charity. This includes ensuring they are prepared in compliance with applicable accounting standards and on a going concern basis.

A full risk management exercise was carried out on set up of the charity and at the time the warehouse was required. This covered major strategic, operational and financial risk to which Weymouth Foodbank is exposed. This also included an assessment of the risks identified through Covid. Systems and actions were established to mitigate the risks. This will be reviewed at least annually.

The Trustees believe that internal controls conform to guidelines issued by the Charity Commission.


Trustees' Responsibilities

1. ACCOUNTING POLICIES

Basis of Preparation & Assessment of Going Concern

Basis of Preparation

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2015) - (Charities SORP - FRS102) and the Charities Act 2011.

The Charity meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost unless otherwise stated in the relevant accounting policy notes.

Assessment of Going Concern

Preparation of the accounts is on a going concern basis. The trustees consider that there are no material uncertainties about the Charity's ability to continue as a going concern.

Incoming Resources

Recognition of Incoming Resources

These are included in the Statement of Financial Activities (SOFA) when:

- the charity becomes entitled to the resources;
- the trustees are virtually certain they will receive the resources; and
- the monetary value can be measured with sufficient reliability

Incoming Resources with Related Expenditure

Where incoming resources have related expenditure (as with fundraising or contract income) the incoming resource and related expenditure are reported gross in the SOFA.

Grants and Donations

Grants and Donations are only included in the SOFA when the charity has unconditional entitlement to the resources.

Tax Reclaims on Donations and Gifts

Incoming resources from tax reclaims are included in the SOFA at the same time as the gift to which they relate.

Contractual Income and Performance Related Grants

This is only included in the SOFA once the related goods or services have been delivered.

Gifts in Kind

Gifts in kind are accounted for at a reasonable estimate of their value to the charity or the amount actually realised. Gifts in kind for sale or distribution are included in the accounts as gifts only when sold or distributed by the charity. Gifts in kind for use by the charity are included in the SOFA as incoming resources when receivable. Perishable and non perishable food items donated to the Charity for onward distribution to beneficiaries are not valued in the Statement of Financial Activity.

Donated Services and Facilities

These are only included in incoming resources (with an equivalent amount in resources expended) where the benefit to the charity is reasonably quantifiable, measurable and material. The value placed on these resources is the estimated value to the charity of the service or facility received.

Volunteer Help

The value of any voluntary help received is not included in the accounts.

Investment Income

This is included in the accounts when receivable.

Investment Gains and Losses

This included any gain or loss on the sale of investments and any gain or loss resulting from revaluing investments to market value at the end of the year.

1. ACCOUNTING POLICIES (continued)

Expenditure and Liabilities

Liability Recognition

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

Governance Costs

Include costs of the preparation and examination of statutory accounts, the costs of the trustees meetings and cost of any legal advice to trustees on governance or constitutional matters.

Grants with Performance Conditions

Where the charity gives a grant with conditions for its payment being a specific level of service or output to be provided, such grants are only recognised in the SOFA once the recipient of the grant has provided the specified service or output.

Grants Payable without Performance Conditions

These are only recognised in the accounts when a commitment has been made and there are no conditions to be met relating to a grant which remain in control of the charity.

Investments

Investments quoted on a recognised stock exchange are valued at market value at the year end. Other investment assets are included at trustees' best estimate of market value.

Unrestricted funds

These funds can be used for the general objectives of the charity as set out in the trustees report. The movements of the unrestricted funds are given in the Statement of Financial Activities.

Restricted funds

These funds are where the donor has specified a purpose for the donation made. These restrictions often arise as a result of appeals for special offerings for specific purposes.

Designated funds

These funds are funds set aside by the trustees out of unrestricted general funds for particular purposes or projects.

Fixed Assets

Fixed Assets are capitalised if they can be used for more than one year and cost at least £1,500. They are valued at cost or, if gifted, at the value to the charity on receipt.

Depreciation Expense

Depreciation is calculated at a rate to write off the cost of tangible fixed assets over their estimated useful lives. The rates applied are as follows:

It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

Independent examiner's statement

In connection with my examination, no matter has come to my attention:

1. which gives me reasonable cause to believe that in any material respect, the requirements:
 - to keep accounting records in accordance with section 130 of the Charities Act; and
