INCREASING, OR COORDINATING, OPPORTUNITIES FOR MEMBERS OF THE COMMUNITY TO ENGAGE WITH SERVICE PROVIDERS, TO ENABLE THOSE PROVIDERS TO ADAPT SERVICES TO BETTER MEET THE NEEDS OF THAT COMMUNITY. THE FOUNDATION IS NOT ORGANISED NOR SHALL IT BE OPERATED FOR THE PRIMARY PURPOSE OF GENERATING GAIN OR PROFIT. THE FOUNDATION SHALL NOT DISTRIBUTE ANY GAINS, PROFITS OR DIVIDENDS TO THE DIRECTORS, OFFICERS, MEMBERS OR ANY INDIVIDUAL.
