During the year, the charity raised approximately £4,000 through mosque and community cash collections. These funds were applied to local homeless relief in the UK, including the provision of food (£700) and clothing (£3,300) to individuals experiencing homelessness.

The trustees confirm they have had due regard to Charity Commission public benefit guidance.
