Report to the Charity Commission: April 2023 – March 2024

This report reflects our charity's unwavering commitment to advancing health and relieving needs worldwide by supporting healthcare and frontline workers. Through innovative digital technology, robust logistics, and collaborative action, we have worked tirelessly to address urgent medical and domestic needs.

Advancement of Health and Support for Frontline Healthcare Workers

Platform Impact

- The Frontline Live platform has been an essential tool, enabling over 20 frontline charities in Ukraine to report their real-time medical and domestic needs. This tech-driven system directly connects those in need with individuals, businesses, and non-profits ready to help.
- The platform ensures efficient matching of supplies to urgent requirements, promoting the safety and well-being of healthcare workers and communities.

Deliveries of Essential Supplies

- Our charity has consistently supported 20 small frontline organisations, ensuring healthcare workers and volunteers have the tools and resources they need to perform their critical roles.
- From April 2023 to March 2024, Frontline Live delivered 15 HGVs of essential supplies to Ukraine, including:
 - o Medical Supplies: 21 defibrillators, 56 medical devices, 8,000 thermometers, and 200 boxes of general medical supplies.
 - o Hygiene and Clothing: 1,200 boxes of hygiene products and 1,200 boxes of clothing.
 - o Energy and Shelter: 20 generators, 500 boxes of bedding, and 1,000 power banks.
 - o Basic Essentials: Food, shoes, and toys to support families and children.
- These deliveries addressed critical needs in healthcare, hygiene, energy, and daily living for communities affected by the ongoing conflict.

Transparency, Engagement and Collaboration

Collaboration, Corporate Support, and Sponsorship

- This year, Frontline Live secured a landmark 3-year sponsorship with HFW's Insurance and Reinsurance Department. This partnership provides annual cash donations, strategic expertise, and volunteer support to strengthen our operations. HFW's commitment enables us to address immediate logistical needs, enhance our technology platform, and expand our community outreach.
- Our partnerships with organisations such as Microsoft, Sky, and Mars have also been instrumental in sustaining our work through valuable contributions of goods and funding.
- Fundraising events, including an auction at the Little Ship Club, raised over £2,000 to cover transportation costs, demonstrating the power of community collaboration.

Volunteer Contributions

- Volunteers have been central to our success, coordinating logistics, collecting and sorting donations, and managing shipments of 25–30 pallets each month.
- Their dedication ensured timely and efficient delivery, overcoming challenges such as navigating customs and securing storage facilities.

Digital and Data-Driven Advocacy

- The Frontline Live platform continues to collect and analyse data, ensuring aid delivery is efficient and resources reach those in greatest need. This data-driven approach supports informed decision-making for healthcare and frontline workers.

Financial Integrity

- Every penny donated through our fundraising platform has been used exclusively for the purchase and delivery of essential supplies, reinforcing trust and loyalty among our donors, partners, and stakeholders.

Community Engagement

- Our volunteers' passion drives our mission. Stories from the frontlines—children receiving school supplies, families warmed by donated quilts, and healthcare workers equipped with life-saving tools—show the tangible impact of collective action.

Looking Forward

Frontline Live remains a beacon of hope in challenging times. Guided by our charitable objects, we continue to advance health, support healthcare workers, and relieve need through innovation, compassion, and collaboration.

We remain committed to expanding partnerships, fostering broader community engagement, and maintaining a transparent, efficient platform to address urgent humanitarian needs.
