FUNDING

GLL applied for and received a small amount of funding from Leeds City Council in the amount of £462.50 to hold a workshop on Cardiovascular Disease.

CARDIOVASCULAR DISEASE WORKSHOP

A workshop was held on 13th of September 2023. It was made up of interactive sessions on African and Caribbean diet and healthy eating, lecture given by a trained nutritionist, Lecture on healthy eating for diabetics, a talk/ interactive session on cardiovascular disease and how it relates to diabetes. The

session included blood pressure checks and signposting to the relevant medical centre.

PARTNERING WITH OTHER GROUPS

Guiding Light Leads was approached by a faith based group running health programmes in the Birmingham area. They had heard of Guiding Light Leads and the work we were doing in the local community and wanted to partner with us. The group had received funding from the NHS to run some health programmes in predominantly African and Caribbean communities. We did not receive funding from them. Our programmes were completely funded by the group. Together we held programmes and health expos educating the community on, nutrition, diabetes, cardiovascular disease, Blood pressure and stroke mental health issues and how it involves the police. We also held workshops on Peri-natal mental health issues. These programmes covered the period of November 2024 to February 2025.

PROJECTED PROGRAMMES 2026

Guiding Light Leads plans to partner with the, 'Black Health Initiative' group, a group which has been running successfully for the past thirty five years in the Leeds area. We are planning to run some programmes in conjunction with the Leeds City Council.

REPORT

This is a very short report to state that due to dwindling ability to obtain funds, Guiding Light Leads was unable to carry out any activity for this financial period.

A fund of £462.00 was obtained in July 2024, but was paid in two parts, the first part in July, £231.00 and the balance in October 2024. The project was therefore carried out in August 2024 and payments were made in October 2024. The account for the spending of £462.00 will therefore be submitted for the relevant year, 2024/2025.

Guiding Light Leads did not have any activity serving the community in the financial period of September 2023 to August 2024. However, a dinner was held in honour of the charity winning the Jo Cox award for December 2023.

This event was totally funded by the trustees. Donations were given towards a scholarship fund to honour two of the foundation members who had died of cancer in March and April of 2023.

The scholarship programme is ongoing, but the appropriate amount has not yet been realized, it is a work still in progress. The Guiding Light Leads team of trustees is committed to getting this done as soon as is possible despite the very harsh financial situation now. £ 770.00 has been raised of a total of £10,000.00 needed. This will be done.

Principal activity: Attempt to improve racial relationships with the police and the young people in the African Caribbean community by using the history of the African Caribbean people in a positive way to show the fortitude of the African Caribbean people thereby creating pride and improved self-worth in the young people, encouraging them to higher education and vocational achievements.

WORKSHOP

A two-day workshop was held on 27th & 28th of March 2023. It was made up of interactive sessions on African-Caribbean history, group sessions on 'finding self', a session by an educationist, on various avenues of furthering education. A representative from the NHS had a group session on finding jobs in the NHS. A representative from Leeds University Life-Long learning Centre, went through the process of re-entering higher education. The final session of the day was on 'Emotional Intelligence' by the co-founder of Jago Company.

POLICE RACE ACTION PLAN

GLL was contacted by the West Yorkshire Police to help in formulating material for the new initiative they were embarking on in creating better relationships with members of the black community. GLL was asked to participate in this project. Several meetings were held with the planning committee. GLL was then asked to do the pilot presentation. The presentation was given at the Bishopgarth Training Centre, Carrgate Complex in Wakefield. The presentation was attended by several senior police officers and recorded for training. This was followed by a question-and-answer session which was also recorded for training purposes. These recorded sessions were slated to be beamed to all police officers in West Yorkshire. Further 'Police Race Action Plan' meetings were expected to take place between the Police Race Action Plan committee and Guiding Light Leads.

Guiding Light Leads was not paid for this project, but we decided that we would make use of the

opportunity of being able to make a positive impact on the police force. We felt compelled to be part of the spearheading of the project because it was in line with our ethos, the pledge we had made. We established GUIDING LIGHT LEADS with three establishments in mind: The Police, Teachers in schools, and executives in the workforce. Our belief is that if we can establish harmonious relations with these bodies by educating them on who we are, there will be less tension and misunderstanding in our communities, and our young people will find it easier to fit into general society, reducing ASB.

The presentation covered:

- **How the British got involved in the slave trade-**
- **Africans existing within slavery and the abolition of slavery.**
- **The Apprenticeship Period**
- **Post Apprenticeship Period**
- **Laws to curtail development of the freed slaves.**
- **Resultant mass migration**
- **Participation in both World Wars**
- **Fallacious portrayal of the black man**
- **Windrush Outcome**

The presentation was interactive, making use of props, music, and videos.

Achievements: One of the participants of the workshop was so impressed by the history of heroism in African -Caribbean history, the report on the numbers of young black people in jail, that she has gone into the community to create groups of her peers, engaging with them, pointing out pitfalls, and encouraging them to aspire for better. She has been appointed by a Leeds based group to be a national outreach person.

The lecture and interactive pilot sessions held by Guiding Light Leads with senior West Yorkshire Police officers is being used as part of the, 'Police Race Action Plan' that has been implemented and is ongoing for all police officers in West Yorkshire. The expectation of this endeavour is to create better relations between the police and the community thereby reducing tension.


