However, due to the impact of COVID-19 and the current global financial situation, Unveiling Voice is still meeting its objectives, although not as expected.</p> <p>Unveiling Voice has played a significant role since the beginning of this global economic crisis by providing counselling assistance, encouragement, providing meals for the homeless and directing people to where they could receive further help.</p> <p>Due to the high cost of materials and services, we primarily relied on social media—specifically, Zoom, FaceTime, and MS Teams—to deliver training and leadership skills to those in need.
