**Objects:** (1) FOR THE PUBLIC BENEFIT, TO PROTECT AND PROMOTE THE HEALTH OF AND RELIEF OF THE NEEDS OF PERSONS AFFECTED BY CEREBRAL PALSY OR ANY OTHER NEUROLOGICAL CONDITION BY: A) PROVIDING TREATMENT TO SUCH PERSONS; B) PROVIDING, FACILITATING OR SUPPORTING THE TRAINING OF THOSE INVOLVED IN THE TREATMENT AND CARE OF SUCH PERSONS; C) UNDERTAKING, SUPPORTING, AND PARTICIPATING IN RESEARCH INTO THE TREATMENT OF CEREBRAL PALSY AND OTHER NEUROLOGICAL CONDITIONS, AND DISSEMINATING THE RESULTS OF SUCH RESEARCH; D) SUPPORTING OTHER ORGANISATIONS THAT ASSIST SUCH PERSONS; OR E) PROVIDING SUPPORT SERVICES FOR SUCH PERSONS AND THEIR FAMILIES(2) FOR THE PUBLIC BENEFIT, TO RELIEVE POVERTY AND FINANCIAL HARDSHIP OF PERSONS AFFECTED BY CEREBRAL PALSY OR ANY OTHER NEUROLOGICAL CONDITION
