The Object of the Charity

Reserves Policy

The Trustees would like to work towards maintaining unrestricted funds at a level which equates to approximately three months of unrestricted expenditure.

Volunteers

The charity is utilising the services of volunteers who offer their time and skills in the different activities engaged in through the year.

Summary of Income

During the year under review, we received donations from members totalled: £7,888.00 (31 March 2024 was £12,592.00) and reclaimed Gift Aid totalled: £3,157.00 (in 2024, £2,704.00)
