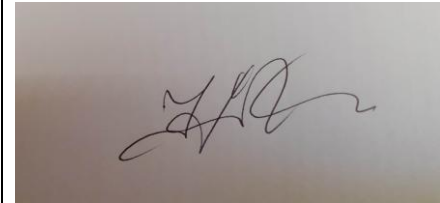

Section C. Notes to the Accounts**1. Basis of accounting**

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value.

The accounts have been prepared in accordance with:

- * the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014
- and with the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

2. Financial Policies**2.1. Reserves**

Although the Trustees still consider that it is not possible, at a time of great volatility for food banks, to determine the Reserves Policy for the Charity, they decided that, provided strict monitoring of its finances continued, the Charity had sufficient funds to decide that no grant funding would be applied for in the year.

2.2. Income.

The charity has adopted standard accounting practices for income except that donations in kind have not been valued. The Trustees consider that the substantial effort required to place a value on donated goods would not be worthwhile.

- supplied 127 additional parcels at Christmas (2024 – 109) to needy clients and pensioners.
