Objects: ADVANCING THE EDUCATION AND DEVELOPMENT OF THE STUDENTS OF WOOLMER HILL SCHOOL ("THE SCHOOL") BY PROVIDING AND ASSISTING IN THE PROVISION OF FACILITIES FOR THE EDUCATION AND DEVELOPMENT OF STUDENTS AT THE SCHOOL THAT WOULD NOT NORMALLY BE PROVIDED; AND PROMOTING FOR THE BENEFIT OF THE INHABITANTS OF HASLEMERE AND ITS SURROUNDING AREAS THE PROVISION OF FACILITIES FOR RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, FINANCIAL HARDSHIP, OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF SUCH INHABITANTS.

Activities: Supporting Woolmer Hill School, Haslemere, Surrey by making grants for the acquisition of equipment and the improvement of facilities which facilitate teaching/learning by staff and students and which ensure that staff and students are better equipped to use modern teaching/learning techniques. The enhanced facilities will also benefit the local community when they visit and make use of them.
