Para 1.20	High Heritage's achievement this year has been in our Projects which includes: Monthly Sessions Every month we have a joint session dealing with different topics such as 'writing goals', 'Conversation around the world about Covid 19', staying motivated, Mindfulness, Staying Well and healthy, talking to a young politician, Writer's club. We invite guest speakers who teach and train the children and young people. Well Being Projects this involves Mentoring: Young people are linked with mentors who act as experienced and trusted advisors. Coaching: we have weekly coaching sessions for young people who need it. These sessions support young people with specific personal, life or professional goals. Music Project. During the pandemic we started a classical music project. All the young people involved have instruments at home with them. Music became a form of therapy for them and their families. Sports Project We carried out a sports project during the 2021 summer holiday. It was a good way to get young people moving, exercising and interacting with others again after the periods of isolation. Additionally, some of our young people has been involved in the brain storming for the new Children Cambridge Hospital (which is the first physical and mental health hospital in our region). It is a wonderful experience for the young people to be involved in the decision making for a big government project.

		Some of our young people also joined a brain storm session organised by the Peterborough City Council about racism discussion in schools. One of our young people acted in a short COVID film campaign organised by the Peterborough City Council. The filmed titled 'Be Part of the Solution' campaign was shortlisted for an LGC Award under the 'Campaign of the Year' category.
