TO PROMOTE, FOR THE BENEFIT OF THE PUBLIC, THE CONSERVATION, PROTECTION, IMPROVEMENT AND ECOLOGICALLY SUSTAINABLE MANAGEMENT OF THE MARINE ENVIRONMENT INCLUDING ASSOCIATED LAND, SHORELINE AND STRUCTURES; AND4. TO ADVANCE THE EDUCATION OF THE PUBLIC IN THE CONSERVATION, PROTECTION, IMPROVE-MENT AND ECOLOGICALLY SUSTAINABLE MANAGEMENT OF THE MARINE ENVIRONMENT INCLUD-ING ASSOCIATED LAND, SHORELINE AND STRUCTURES
