Objects: TO PROMOTE FOR THE BENEFIT OF THE INHABITANTS OF SANDS END AND THE SURROUNDING AREAS THE PROVISION OF FACILITIES FOR THE ARTS, EDUCATION, RECREATION OR OTHER LEISURE TIME OCCUPATION OF INDIVIDUALS WHO HAVE NEED OF SUCH FACILITIES BY REASON OF THEIR YOUTH, AGE, INFIRMITY OR DISABLEMENT, FINANCIAL HARDSHIP OR SOCIAL AND ECONOMIC CIRCUMSTANCES OR FOR THE PUBLIC AT LARGE IN THE INTERESTS OF SOCIAL WELFARE AND WITH THE OBJECT OF IMPROVING THE CONDITION OF LIFE OF THE SAID INHABITANTS IN FURTHERANCE OF THESE OBJECTS, BUT NOT OTHERWISE, THE TRUSTEES SHALL HAVE POWER TO ESTABLISH OR SECURE THE ESTABLISHMENT OF AN ARTS AND COMMUNITY CENTRE AND TO MAINTAIN AND MANAGE IT.

Activities: The charity maintains and manages an arts and community centre for use by all the people living in or near Sands End, Fulham, London. It provides a meeting place, community cafe, facilities for arts, health and well being activities, leisure pursuits and a home for community events. It is run by local trustees who will ensure that everyone is welcome and that the centre is accessible to all
