Local environmental company Ecology Resources has continued to support The Oakham Canal Green Corridor Project, carrying out a number of surveys with the Leicestershire and Rutland Wildlife Trust to develop our understanding of the plant and animal species within the project area. One of their employees, Bethany Hunt, has joined the Project as a Trustee and will work with us on environmental matters as well as engaging with the younger generation.

The Project has become a key partner in the Climate Action Rutland group and supports its initiatives around biodiversity.

The Trustees have continued to engage widely in the local community. Employees of local company Edmentum supported our work parties, assisting in the laying of the new footpath surface and constructing several new benches along the canal corridor.

The Project Manager ran a further series of guided walks over the summer months, and provided talks to a number of local groups, generating over £350 in donations.

The Project has grown its team of volunteer Rangers who are active along the canal corridor trimming vegetation, engaging with the public, and reporting issues.

The Project's website and Facebook page have been instrumental in engaging with the local community and have generated a considerable amount of interest in our work. Our Facebook followers now exceed 1,000.

Our Volunteer Manager has managed a large number of work parties throughout the year, implementing our planned projects and keeping abreast of preventative maintenance works to keep the footpaths well maintained and accessible.

The Project has been featured on the BBC's Escape to the Country and local MP Alicia Kearns visited the Project to lend her support to our work.

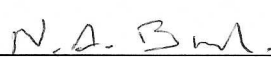
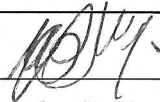
The Project is in the process of making several funding applications for the levelling and surfacing of a further 400m of footpath to continue to make the canal corridor more accessible all year round.

We continue to work with landowners and Rutland County Council to realign a public footpath closer to the canal corridor and to protect and promote the canal as a vital public green space. We have gained significant support within the local community who take interest in, and help maintain, the canal environment.
