IN THIS OBJECT, "SUSTAINABLE DEVELOPMENT" MEANS DEVELOPMENT WHICH MEETS THE NEEDS OF THE PRESENT WITHOUT COMPROMISING THE ABILITY OF FUTURE GENERATIONS TO MEET THEIR OWN NEEDS. 3.1.2 THE ADVANCEMENT OF HEALTH, INCLUDING THE PREVENTION OR RELIEF OF SICKNESS, AMONGST UNDERPRIVILEGED COMMUNITIES IN ANY PART OF THE WORLD, INCLUDING BUT WITHOUT LIMITATION: (A) DESIGN AND DELIVERY OF HEALTH PROGRAMMING; AND (B) ASSISTING WITH THE DEVELOPMENT OF A SUSTAINABLE MEDICAL INFRASTRUCTURE.
