As a charity we harness the power of the rugby community to raise funds and awareness to enhance the lives of those living with cancer.

The charity is run by a team of volunteers who have a passion for rugby and have all been personally affected by cancer in their own lives or friends, family & teammates. Each individual offers their time to help grow, manage and coordinate the charity so we can run events and give back to the community.

Alongside our dedicated committee, we have an extended family of professional ambassadors that play or coach rugby in the UK, each of whom support our vision and values.
