It is envisaged that the Charity will shortly be involved in, or benefit from, fundraising activities relating to Central Foundation Boys' School which will enable it to make grants to the School to cover expenditure on the maintenance, enhancement or improvement of facilities, resources and educational opportunities at the School. The initial fundraising is likely to be in support of the refurbishment and equipping of the Tabernacle building at the School so that it can be used for teaching creative arts subjects and which will include a performance space for music and drama.

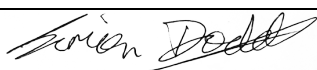
