ADVANCEMENT OF EDUCATION BY THE PROVISION OF GRANTS TO SUCH INDIVIDUALS OR CHARITABLE INSTITUTIONS AS THE TRUSTEES IN THEIR DISCRETION SHALL DECIDE.
