accommodation, things which they would not be able to afford and therefore would likely result in them struggling to maintain their tenancies, potentially resulting in them becoming homeless again

This supports the widening of inclusivity for young children to be able to join in and benefit from amateur sport, football, and participate fully in organised football

In Munich we support Pikassio Libero (<https://translate.google.co.uk/translate?hl=en&sl=de&u=https://www.pikassio.de/libero-fussballprojekt/&prev=search>) with sports kits, a football charity which focuses on helping asylum seekers integrate into life in Munich. These young children and young adults up to the age of 18 years, have nothing. MMMF support allows Pikassio Libero to help fund and support young asylum seekers and contribute to their assimilation year life in a foreign country

We also provide financial support for Buntkicktgut (<http://www.buenaspracticascunitarias.org/buenas-practicas/39-buntkicktgut-munich.html>) an all inclusive children's football charity which focuses on disadvantaged and disaffected young children whose philosophy is one of all inclusivity

In our first year as a registered Charitable Incorporated Organisation, and bearing in mind this has largely taken place during the global Covid pandemic, we have been able to financially support our four stated partner organisations, as per our objects, to the sum of £25,020.88, which can be broken down as follows

The CIO board of trustees decided that we would not actively fundraise during the pandemic, however by running a charity fundraising dinner in October 2021 and raising money through auctions and a raffle on the evening, plus additional voluntary donations by MUFC fans over the period, we raised the total sum of £22,798.32 during our first year as a registered charity

In October 2021 we held a charity fundraising dinner which raised the sum of £20,625.00, wholly from ticket sales, however the expenses and costs of running the event totalled £17628.94 - leaving a balance of £2996.06. It should be noted that a venue deposit of £4400.18 had been paid prior to the inception of the CIO, when operating as a Not for Profit Limited Company by Guarantee. Therefore, for this event, we can show a profit, however with the deposit being paid out of the calendar year, this would have resulted in a net loss. As such,

.this “profit” has been added to the sum raised in year to boost income in period

We also entered into a separate sponsorship deal valued at £3000.00 to continue to facilitate a non charitable commitment. Mention of this here, in this report, is simply to account for the income shown in our bank accounts and financial spreadsheets. There is expenditure already taken out from this sponsorship amount (Lufthansa flights), with more to follow in February 2022, however there will be a residual balance circa £2000.00 from the sponsorship, which as agreed with our sponsor, will be used in distribution to our four partner organisations as an .additional bonus to the payments we will be making next Spring

NOTES TO STATEMENTS OF FINANCIAL ACTIVITIES (SOFA)
YEAR ENDED 30 NOVEMBER 2021**

1. THE BASIS OF ACCOUNTING POLICIES AND DEFINITIONS

1.1 THE ACCOUNTS have been prepared under the historical cost convention in

accordance with applicable accounting standards and the Charities Act 2006

and Statement of Recommended Practice (SORP) 2005.

1.2 GENERAL FUNDS represent unrestricted funds that are not subject to any restriction regarding their use and are available for application towards their use

purposes of a general nature.

1.3 RESTRICTED FUNDS represent funds restricted by the donor for a particular purpose.

1.3(a) DESIGNATED FUNDS represent funds that have been allocated out of Unrestricted

funds by the Trustees of MMMF, for specific events or liabilities MMMF is committed to.

Any remaining balance is returned to unrestricted funds when events have been held.

1.4 INCOMING RESOURCES are included in the SOFA when:-

- MMMF becomes entitled to the resources
- The trustees are virtually certain they will receive the resources; and
- The monetary value can be measured with sufficient reliability.

1.5 GRANTS & DONATIONS are included in the SOFA when MMMF has unconditional entitlement to the resources.

1.6 INVESTMENT INCOME is included in the SOFA when receivable.

1.7 RESOURCES EXPENDED are recognised when costs have been incurred, or for designated or special gifts, in the same accounting period as the related gift is received.

1.8 TANGIBLE FIXED ASSETS are capitalised at cost when incurred, or for assets bought in previous years, at valuation in 2021. The valuation of assets from previous years was identified as income, in Voluntary Incoming Resources.

1.9 DEPRECIATION OF FIXED ASSETS is included in resources expended, to write off the assets of over their useful life.

1.10 LIABILITY RECOGNITION - Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources.

1.11 GOVERNANCE COSTS - The preparation & examination of MMMF's annual statutory accounts, AGM & trustee meeting expenses; also legal advice given to trustees.
