Amcanion yr Elusen

Mae Elusen Ogwen yn cefnogi cynlluniau fydd yn gwella ansawdd bywyd trigolion, grwpiau a chymunedau yn Nyffryn Ogwen. Mae'n gwneud hynny drwy ddosbarthu rhan o'r elw o gynlluniau ynni Ynni Ogwen. Charity Objectives

Elusen Ogwen supports initiatives that will improve the quality of life of the residents, groups and communities of Dyffryn Ogwen. It does so by distributing some of the profits from Ynni Ogwen's energy schemes. Community groups can apply for support for projects that will benefit the residents of Dyffryn Ogwen. Elusen Ogwen can contribute to capital and revenue projects that meet one or more of the following objectives:

- Reduce fuel and social poverty
- Develop renewable energy projects
- Promote sustainable transport and active travel
- Save energy
- Connect individuals of all ages to the environment
- Minimize waste
- Encourage individuals to volunteer in environmental projects in their communities
- Improve the quality of the local environment
- Increase production / purchase of local food products

Datganiad Risg

Mae'r Ymddiriedolwyr yn archwilio'r risgiau a wynebwr gan Elusen Ogwen ac effaith bosibl y risgiau hyn ar weithrediad yr Elusen. Cynhelir yr asesiad risg gan y Trysorydd a chaiff ei gyflwyno i'r Ymddiriedolwyr bob blwyddyn fel y gellir rhoi polisïau a gweithdrefnau yn eu lle i sicrhau bod risgiau'n cael eu cadw i lefel dderbyniol.

Risk Statement

The Trustees examine the risks faced by Elusen Ogwen and the potential impact of these risks on the operation of the Charity. The risk assessment is undertaken by the Treasurer and presented to the Trustees every year so that policies and procedures can be put in place to ensure risks are kept to an acceptable level.

Adroddiad ar gyfer y 12 mis yn diwedd 31 Mawrth 2025

Cafodd Elusen Ogwen flwyddyn lwyddiannus, gan ddosbarthu grantiau gwerth cyfanswm o £25,769, o gymharu â £17,446 yn y flwyddyn ariannol flaenorol, cynnydd o 47%.

Ers cael ei lansio ddiwedd 2020 mae'r elusen wedi dyrannu dros £67,000 mewn grantiau i grwpiau lleol.

Nid oeddem wedi disgwyl cael cyllid gan Ynni Ogwen eleni oherwydd maint eu rhodd yn 2023–24, ond yn wyneb y galw am grantiau, rhoddwyd £15,000 yn ychwanegol i ni yn ystod y flwyddyn, ac rydym yn ddiolchgar iawn am y rhodd hon.

Report on the 12 months ending 31st March 2025

Elusen Ogwen had a successful year, distributing grants totalling £25,769, compared to £17,446 in the previous financial year, a rise of 47%.

Since its launch at the end of 2020 the charity has provided over £67,000 in grants to 23 local groups.

We had not expected to receive funding from Ynni Ogwen this year due to the size of their donation in 2023-24, but in the light of demand for grants, they provided us with an additional £15,000 during the year, for which we are very grateful.

Fe wnaethom ariannu 11 o sefydliadau gwahanol yn ystod y flwyddyn. Mae'r grwpiau canlynol wedi elwa o'n grantiau:

Dyfarnwyd grant o £2,000 i **Neuadd Goffa Mynydd Llandygai** i fynd tuag at gost batri fel rhan o'r gwaith o osod paneli solar newydd.

Cafodd **Asynnod Eryri** £3,000 tuag at gost canolfan ymwelwyr newydd.

Cafodd **Dreigiau'r Dyffryn**, grŵp gymnasteg lleol, £3,000 i helpu i dalu am oleuadau LED newydd. Gyda chymorth Elusen Ogwen, mae'r grŵp wedi newid ei holl oleuadau dros y tair blynedd diwethaf, gan arwain at ostyngiad o 70% yn yr ynni a ddefnyddir.

Cafodd **Canolfan Gymunedol Tregarth** grant o £3,000 i'w galluogi i wneud gwelliannau i'r ffensys a'r llwybrau o amgylch y ganolfan.

Enillodd **Growing for Change** grant o £3,000 tuag at gost tŷ gwydr newydd.

Fe wnaethom hefyd roi cyllid i lawer o grwpiau er mwyn iddynt gynnig gweithgareddau haf fforddiadwy i blant. Cafodd **Parc Moch, Beics Ogwen a Phartneriaeth Ogwen** gyfanswm o £6,830 yn ystod y flwyddyn.

Cafodd **Clwb Bowlio a Chriced Bethesda** £2,721 i helpu i dalu am danc dŵr newydd a goleuadau solar.

Cafodd **Cyfeillion Ysgol Llanllechid** grant bychan i'w galluogi i brynu offer ailgylchadwy i'w defnyddio mewn digwyddiadau a drefnir gan yr ysgol.

Yn olaf, talodd Elusen Ogwen am fwrdd gwybodaeth newydd ym Methesda fel rhan o'r **Llwybr Llechi**.

Cadwyd costau gweithredu yn isel iawn ar £423 ac fe'u hariannwyd i raddau helaeth gan log o £335. Cyfanswm incwm yr elusen oedd £15,335, a gwariwyd £26,193.

Ar ddiwedd y flwyddyn ariannol roedd gan yr elusen £20,036 o Gronfeydd wrth gefn, i lawr o

We funded 11 different organisations during the year. The following groups benefited from our grants:

Mynydd Llandygai Memorial Hall were awarded a grant of £2,000 to go towards the cost of a battery as part of a new solar panel installation.

Snowdonia Donkeys received £3,000 towards the cost of a new visitors centre.

Dreigiau'r Dyffryn, a local gymnastic group, received £3,000 to help pay for new LED lighting. With the help of Elusen Ogwen, the group have completely changed their lighting over the last three years, resulting in a reduction of 70% in the energy used.

Tregarth Community Centre received a grant of £3,000 to enable them to make improvements to the fencing and paths around the centre.

Growing For Change were successful in getting a grant for £3,000 towards the cost of a new greenhouse.

We also provided funding to a number of groups in order for them to provide affordable summer activities for children. **Parc Moch, Beics Ogwen and Partneriaeth Ogwen** received a total of £6,830 during the year.

Bethesda Bowling and Cricket Club received £2,721 to help pay for a new water tank and solar lighting.

Cyfeillion Ysgol Llanllechid received a small grant to enable them to buy recyclable utensils, for use at events organised by the school.

Finally, we paid for a new information board in Bethesda as part of the **Llwybr Llechi Slate Trail**

Operating expenses were kept very low at £423 and were financed to a large extent by interest received of £335. In total the charity had income of £15,335 and expenditure of £26,193

The charity ended the financial year with reserves of £20,036, down from £30,894 at the end of the

Polisi Cronfeydd wrth Gefn Mae gan yr elusen bolisi o gynnal o leiaf £750 yn gronfeydd wrth gefn er mwyn gwastatau amrywiadau mewn incwm a gwariant yn ystod y flwyddyn ariannol. Bydd arian wrth gefn ychwanegol yn cael ei gadw pan fyddwn wedi cytuno i ariannu prosiectau dros fwy na blwyddyn. Byddwn yn parhau i adolygu ein polisi dyfarnu grantiau er mwyn sicrhau nad yw cronfeydd wrth gefn yn cronni dros amser.	Reserves Policy The charity has a policy of maintaining at least £750 by way of reserves in order to even out fluctuations in income and expenditure during the financial year. Additional reserves will be held where we have agreed to fund projects over more than one year. We will continue to keep our grant making policy under review to ensure that reserves do not build up over time.
