(2) ABOVE BY:(1) MAKING GRANTS OF MONEY, OR(2) PROVIDING OR PAYING FOR GOODS, SERVICES OR FACILITIES FOR THEM, OR(3) MAKING GRANTS OF MONEY TO OTHER PERSONS OR BODIES WHO PROVIDE GOODS, SERVICES OR FACILITIES TO THOSE IN NEED.
