2. Structure, Governance and Management

GOD ASSOCIATION is constituted as a Charitable Incorporated Organisation (Association model), registered with the Charity Commission for England and Wales under number 1192707 on 8 December 2020. Trustees are appointed in accordance with the charity’s constitution. The charity has no custodian trustees and no paid senior staff.

3. Objectives and Activities

Summary of the charity’s objects, as set out in the governing document:

- (a) To advance the Christian religion in London for the benefit of the public, through the provision of a place of worship, holding prayer meetings, providing religious education, public celebration of religious festivals, interfaith activities, and distributing literature to enlighten others about the Christian faith.
- (b) The prevention or relief of poverty in the UK and worldwide, by providing grants, items and services to individuals in need, charities, and other organisations working to prevent or relieve poverty.¹
