The charity's principal sources of funds (including any fundraising)	Para 1.47	The charity's principal sources of funds include individual donations received through platforms such as PayPal and GoFundMe, which have provided consistent and valuable support. Additionally, we have benefited from corporate donations, including a significant contribution from Lush, which has strengthened our financial position. Our fundraising efforts have also been bolstered by creative initiatives, such as organising charity auctions and leveraging social media platforms for marketing campaigns to engage supporters and raise awareness of our cause. These diverse sources of funding have enabled us to continue our mission of providing football boots to disadvantaged children globally while maintaining a sustainable financial base.
Investment policy and objectives including any social investment policy adopted	Para 1.46	The charity's investment policy is focused on ensuring that funds are managed prudently to support our mission of providing football boots to disadvantaged children worldwide. Our primary objective is to preserve capital while achieving a modest return to enhance our financial sustainability and ensure the availability of funds for future projects. We do not currently engage in high-risk investments, preferring to prioritise liquidity and security to meet the charity's short- and long-term needs. Additionally, where possible, we aim to align any investment decisions with socially responsible principles, ensuring that our financial activities reflect the values and mission of the charity. This approach ensures that all resources are effectively utilised for the maximum benefit of our beneficiaries.
A description of the principal risks facing the charity	Para 1.46	The principal risks facing the charity include: 1. Funding Volatility: A significant risk is the reliance on donations and fundraising initiatives. Any decline in public or corporate donations, such as through platforms like PayPal, GoFundMe, or partnerships with businesses like Lush, could impact our ability to deliver on our mission. 2. Economic Challenges: Global economic uncertainty, including rising costs, could affect donor generosity and increase the expense of procuring and distributing football boots to

		disadvantaged children. 3. Operational Risks: As the charity grows, there is a risk of overstressing resources, particularly in managing logistics and scaling up projects without adequate staffing or infrastructure. 4. Compliance and Governance: Ensuring ongoing compliance with legal and regulatory requirements is vital. Any failure to meet these obligations could damage the charity's reputation or result in penalties. 5. Reputational Risks: Negative publicity or social media mismanagement could harm the charity's public image and donor trust, reducing future funding opportunities. To mitigate these risks, the trustees have implemented robust financial controls, diversified funding streams, enhanced governance practices, and established risk management policies to monitor and address potential challenges proactively. This ensures the charity remains resilient and capable of fulfilling its mission.
