**Activities:** Sunrise provides playgroups, youth groups and drop-ins for members of the local ethnic minority communities. We also provide a confidential counselling and support service for those at risk of or experiencing domestic abuse. Through our sessions we provide advice and support on a wide range of issues affecting our users, including health, education, racial discrimination and human rights.
