TRUSTEES REPORT

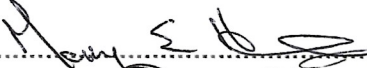
The trading throughout the financial year was not exceptional. In fact the general public still seem not to want to go out following the Covid situation. This has limited our fundraising both at street and field events.

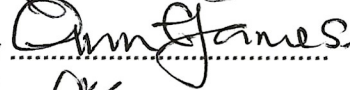
