Para 1.17 and 1.19	Most Cantus Firmus activities are in-person events and services. During the Covid pandemic lockdowns, the Trust created video resources for churches and other organisations to use in their worship, and it maintains the capability to create more in the future. Most Cantus Firmus events and services are in partnership with local churches. Some of those events and services are to present Christian music and understanding to people who would not usually hear them. Some others are to help introduce congregations (and other people) to musical (and other artistic) styles and materials that they are not familiar with and want to consider using. Some Cantus Firmus events are in partnership with InHarmony, a small organisation in St Edmundsbury and Ipswich Diocese (Church of

		England) to develop music across churches in Suffolk. Also, some Cantus Firmus events are in partnership with the Royal School of Church Music, a charity to develop music within Christian worship across the UK and elsewhere.

Policy on grant making	Para 1.38	Cantus Firmus Trust has a practice of making donations to individuals who have been heavily involved in preparing and presenting events and activities. The Artistic Director (who is not a trustee) makes proposals to the trustees on the amount of such donations and the trustees take these proposals into account when making a decision. A trustee is able to propose to the other trustees a donation to a person, who may be a regular supporter of Cantus Firmus Trust or someone not previously known to the trustees, who is undertaking study or other activity which is consistent with the objects of Cantus Firmus Trust and who is in need of financial support, and the trustees believe that such study or activity will generally advance those objects. Any such donation is at the trustees' absolute discretion and they will take into account the circumstances of the case and the amount of funding which Cantus Firmus Trust has available. A trustee may also propose a donation to an organisation whose aims are consistent with those of Cantus Firmus Trust; a similar set of decision criteria will apply as noted above in relation to an individual.

Other		During the reporting period, the trustees met in October 2022, January 2023, May 2023 and June 2023. The October 2022 meeting and the June 2023 meetings were Annual General Meetings of the CIO.

Achievements and Performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	During 2022-23, Cantus Firmus provided the choir and musical leadership for churches in West Mersea and Stanway (Colchester), who wanted to explore how different styles of music could enhance their regular worship. The Trust ran two Pilgrimages of Song this year (near Stowmarket and near Bury St Edmunds), in the format created by the Trust and used successfully in previous years. "Singing pilgrims" spend a day walking together between churches on a planned route, stopping at each church for a short, themed, musical service – to experience first-hand some parts of pilgrimage and also how effective services can be built from well chosen, simple music and liturgy. Cantus Firmus provided a large choir and orchestra, with specially arranged hymns and songs, for the 2023 celebration and call to action organised for all Ipswich churches by Ipswich In Prayer – which gave many present a first experience of how choral and orchestral arrangements can enhance worship. Cantus Firmus also contributed choir members for Coronation Praise, a national-scale outreach event in the Royal Albert Hall on the evening of Coronation Day, modelled on the BBC's Last Night of the Proms, organised by All Souls Church, London. The music was a key component of presenting the Christian message to a full auditorium. The trust's events and activities are advertised widely to c450 mailing list subscribers, to churches and to the general public. They are also regularly mentioned on BBC Radio Suffolk. All are welcome to attend and take part.

Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	Accounts are maintained on a 'Receipts and Payments' basis. Donations from supporters of £766 were received for general purposes, along with participant donations to defray the cost of events of £3,983. The charity is registered with HMRC for Gift Aid and claims were made on qualifying donations. The total income was £9,968. Expenditure of £12,527 was incurred, which included £2,173 of administrative support and an equipment grant from the reserves fund of £1187. The year-end balance was £11,263, of which £926 is in restricted funds. There was a deficit for the year of £2558.

Constrained capacity to produce events (or other projects) because of not enough volunteers for necessary roles. 2. Any return of restrictions due to further waves of Covid. 3. The availability of the Artistic Director. His level of availability could change at relatively short notice because of the nature of his employments outside Cantus Firmus, which puts some uncertainty into long term planning. He could very possibly become available at short notice for a larger project.

A DBS check is carried out, if appropriate. After appointment, he or she is provided with information about the trust's policies and methods of working.
The charity's organisational structure and any wider network with which the charity works	Para 1.51	The trustees meet approximately three-monthly to make strategic and financial decisions. There are two Steering Groups, one for Essex and one for Suffolk, with at least one trustee in each, whose members propose and manage events in their respective counties. In the early stages of planning each event, the steering groups prepare, for the trustees' consideration and approval, a budget and a summary of its structure and content and which shows how it aligns with the trust's objectives.
Relationship with any related parties	Para 1.51	The Trust has close links with: InHarmony, a project of St Edmundsbury Cathedral, which employs the Trust's Artistic Director part-time. The Suffolk Branch of the Royal School of Church Music (whose committee includes several Cantus Firmus Trustees and Artistic Director). The RSCM has changed its structure for 2023-24, so this relationship will not apply next year. London School of Theology, which employs Richard Hubbard (the Trust's Artistic Director) part-time. Several churches in Suffolk and Essex.
