FOR THE PURPOSES OF THIS CLAUSE 'CLASSIC AND HISTORIC VEHICLES' MEANS CARS, TYPICALLY 20 YEARS OR OLDER, OF SUFFICIENT HISTORICAL INTEREST TO BE COLLECTIBLE AND WORTH PRESERVING.

**Activities:** Promote education for the public benefit in the subject of classic and historic vehicles principally by promoting the knowledge and understanding of the maintenance, repair, restoration and operation of such vehicles and providing or assisting in the provision of apprenticeships or other training relating to the maintenance, repair and restoration of classic and historic vehicles for young persons
