WESTERHAM ALMSHOUSE CHARITY

REPORT OF THE TRUSTEES

The Trustees present their report and the Financial Statements of the Charity for the period from 1st January 2024 to 31st December 2024. These accounts have been subject to independent examination as reported on page 3.

The Charity was originally established as Moreton Almshouse Charity by a Trust Deed dated 19 November 1874. It was merged with Westerham Parochial Charities under a new Trust Deed dated 4 December 2006 and its name was changed to Westerham Almshouse Charity, which was registered with the Charity Commission (No. 212065). On 4th January 2021 a CIO was established and registered with the Charity Commission (No 1192970). On 27th May 2021 the Charity Commission granted permission for the merger of the original charity and the CIO. On 14 July 2021, the two charities merged, and the assets were transferred from the unincorporated charity (no: 212065) to the CIO (no:1192970). The unincorporated Charity (No 212065) was deregistered as of that date.

The purpose of the Charity remains to provide housing for the general benefit of those with limited means in housing need. During 2024 the Charity has continued to provide good quality housing for 17 residents in Westerham without significant vacant periods. Further the Charity continues to be able to afford to maintain its properties and maintain its reserves for future maintenance from the funds.

RESERVES POLICY

Most of the reserves of the Charity are designated either as property reserves (to reflect funds permanently invested in property) or as future repair reserves (to accumulate funds for the medium and long-term maintenance of property). It is the policy of the Charity to ensure that free reserves (Accumulated General Reserve) should not exceed one and half year's unrestricted expenditure.

The operation of the charity is carried out by the Trustees with the assistance of the Clerk to the Trustees. The Charity's governance scheme provides for three classes of Trustees who are appointed as follows:

Two ex officio trustees, one is the Vicar of the Ecclesiastical Parish of St. Mary, Westerham and one is a representative of Squerryes Court and both serve as trustees as long as they hold their respective office;

Nominated trustees (maximum of 4) are nominated by the Board and serve 5 year terms, 2 of the nominated trustees must live in or work in the Ecclesiastical Parish of Crockham Hill;

Co-opted trustees (maximum of 3) are made by the trustees at a special meeting called in accordance with the scheme for a term of 5 years.

TRUSTEES' RESPONSIBILITIES

It is the Trustees' responsibility to prepare Financial Statements which give a true and fair view of the state of affairs of the Charity at the end of each financial year and of the surplus or deficit for the year then ended. In preparing financial statements, the Trustees are required to:

- select suitable accounting policies and apply them consistently;
- make judgements and estimates that are reasonable and prudent;
- follow applicable Accounting Standards, subject to any material departures disclosed and explained in the Financial Statements;
- prepare the Financial Statements on the going concern basis unless it is inappropriate to presume that the Charity will continue to operate.

The Trustees are responsible for maintaining adequate accounting records, for safeguarding the assets of the Charity and for taking reasonable steps for the prevention and detection of fraud and other regularities. NOTES TO THE FINANCIAL STATEMENTS for the period 1 January 2024 to 31 December 2024

1. PRINCIPAL ACCOUNTING POLICIES

- a) *Basis of accounting:*
The Financial Statements are prepared under the historical cost basis of accounting, and in accordance with the Financial Reporting Standard 102. The accounts are prepared on a going concern basis, as there are no material uncertainties related to events or conditions that cast significant doubt on the charity's ability to continue as a going concern.
- b) *Turnover*
Turnover represents maintenance contributions receivable from residents during the year, including charges for light and heat.
- c) *Housing Properties*
Housing Properties are accounted for at valuation as at 14 July 2021 when the unincorporated charity was merged into the CIO. The properties are not depreciated as the Charity expenses all maintenance costs when incurred. See Note 6 for more detail.
- d) *Investments*
Fixed asset investments and current asset investments are stated at market value. Investment income is accounted for on an accruals basis. Current asset investments are regarded as held primarily to accumulate funds for future repair costs.
- e) *Repair expenditure*
All repair expenditure, whether routine, cyclical or extraordinary, is charged to revenue in the year in which it is incurred.
- f) *Future Repairs Reserve*
A reserve is held representing amounts set aside for cyclical and extraordinary repairs which become necessary from time to time during the life of the buildings. The amounts set aside are (except in years of heavy expenditure) at least equal to the amounts recommended by the Almshouse Association for the Cyclical and Extraordinary repair categories.
- g) *Property Investment Fund*
This represents the book value of properties owned by the Charity, and acknowledges the fact that reserves equivalent to this value are not available in liquid form.
- h) *Value Added Tax*
The Charity is not registered for Value Added Tax. In these Financial Statements expenditure is shown inclusive of VAT where relevant.

2 TRUSTEES' EMOLUMENTS AND EMPLOYEE INFORMATION

None of the Trustees receives any emoluments. A total of £6,642 was paid by way of fees to the Clerk to the Trustees during the period. There are no other employees.

3 TAXATION

As a registered charity, Westerham Almshouse Charity is exempt from liability to taxation on its income and capital gains.

Moretons Court was constructed in the late nineteenth century. There is no record of the original cost and no value is attributed thereto. The cost relates to improvements carried out in earlier years (£30,322) and more recently the conversion of the existing accommodation to provide 12 self-contained apartments (£329,964) which was partially funded by a grant from the then Housing Corporation, and a mortgage loan of £64,861 advanced in March 1989 from the same source (secured by a charge on Moretons Court). The loan was repaid in April 2019.

Colltherst Almshouses (in Vicarage Hill, Westerham) was renovated and refurbished in 1999 to produce three self-contained apartments. The total cost was £220,739, partially defrayed by a grant of £98,947 from the then Housing Corporation.

Willards is a two-unit property in New Street, Westerham, and is stated at a valuation made in 2000, less subsequent depreciation.

All Properties were transferred to the CIO on 14 July 2021 at the then stated book value which is shown above.

The properties are not depreciated as all maintenance and improvements expenses are charged to income by the Charity when incurred.
