Summary of the main achievements of the charity during the year

Animal ArkAid has now donated over £60,000 to local small animal charities and this included £11,390 donated in 2022, which was our most successful year in our twelve year history.

World Animal Day presentations were made in 2022 to Leeds schools and it is hoped that this scheme will be rolled out to more schools in the future. A big part of these presentations is aimed at school children respecting animals.

Miscellaneous expenditure in the year was only £260, thereby allowing Animal ArkAid to pay the vast amount of it's event profits to local small animal charities.

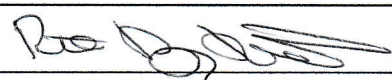
